SF welcomed everyone and reminded members to sign the meeting register to confirm attendance.

3. Notice

The Notice of the Meeting, as published on 10th June 2019, was taken as read.

4. Minutes of AGM 28th July 2018 / Matters Arising

Members were invited to comment on the Minutes of the AGM dated 28th July 2018. No comments made.

Therefore, it was unanimously **RESOLVED** that the Minutes of the Charity's AGM, dated 28th July 2018, be hereby received and adopted **(AGM19/04: Proposer Mary Smith; Seconder Yvonne Colclough)**. The minutes were signed by the Chair and entered in the Charity's Minute Book.

5. Chair's Report - Year Ending 31st March 2019

It was unanimously **RESOLVED** that the Chair's Report, year ending 31st March 2019 be hereby received and noted **(AGM19/05: Proposer Mary Smith; Seconder Yvonne Colclough)**.

6. Treasurer's Report – Year Ending 31st March 2019

Alongside the report, MF informed Members that the Membership Fee will rise from £26pa to £30pa from the 2020/21 Membership Year, reflecting inflationary increases.

7. Election of Trustees

Trainer Representative

SF informed the meeting that only one nomination had been received for the Trainer Representative.

It was **RESOLVED** that **Ema Davis** (nomination seconded by Donna Waring) be appointed to the Trustee Board and was invited to complete the organisation's "Trustee Declaration". **(AGM19/09: Proposed Deborah Cornwall; Seconder Yvonne Colclough)**.

8. Election of Officers

SF reminded the Meeting that Clause 24 of the Charity's Constitution gives the Trustee Board the delegated power to appoint Honorary Officers from their number, which negates the need for further vote.

9. Any Other Business

Shipley Family Fun Day and Pet Dog Show 2019

Marye Arnett Clark addressed the meeting on behalf of the group who organised the recent event in Shipley Country Park, Derbyshire:

"Like a lot of you here, I'm often awake during the night and it was during one of these sleepless nights that I wondered why we were always paying to be at other people's events when they could be paying us to come to ours and that was how this whole thing started. I shared the idea with Carolyn and we then took it to Mike to see if it would have the backing of the Charity. As my vision had been for this to be run by a team we asked Rob, Rhiannon and Kathie to join us straight away, then at a later date Bel and Burnie.

Our event was booked at Shipley Country Park for Sunday 30th June. Thankfully it was lovely weather after weeks of rain. We started setting up at 7.30am but time flew passed and it was soon time for the local mayor to open the event. Including our dog A.I.D. stands we had a total of 42 stands on the day ranging from children's rides, various caterers, other charities and professional stallholders. As well as the Pet Dog Show we had the Derwent Valley Gun Dog Display Team and a local dance troop doing displays plus some of our dogs demoing. It was lovely to see so many clients and trainers turn up to support us on the day! It meant so much to the planning team that you all gave us your support. Thank You.

The original idea was for us to run the first event, which involved starting from scratch with everything - Booking Forms, Terms & Conditions, Health & Safety, flyers, posters, registering the event with the local council, checking all the ratings and registering all the caterers, and finding out how to do all these things. All it now leaves us to do is the hand over this cheque for the profits from our event."

The group then presented a cheque for £1817. 91 to SF and MM.

Chair's Report 2019

This year our charity has continued to grow and still progresses well thanks to all involved.

The Office. Supporting Roles!

We have seen an increase in workload over this period which has meant an increase in staff numbers; we have recruited another part time employee to cover additional administration needs for the benefit of members.

Mike has settled in well and has been promoted from Operations Manager to CEO; it was felt that his overall management and dedication warranted this recognition. As part of our strategy Mike is also covering Grant Funding and will continue to do so whilst we review our approach to Income Generation - it may mean that we recruit a professional Fundraiser in the next 12 months.

As a consequence of an ongoing review of our governance structures, processes and procedures, and to enable us to face anticipated future challenges within the Third Sector, the Board adopted 3-year terms of office for Trustees, in order to give stability and consistency to the overarching leadership of our charity. Individuals will be able to stand for a second term if they wish to, with the approval of the Board. Based on a Board Skills analysis, we also intend to "cast" our net wider when recruiting new trustees to benefit from external expertise and knowledge and bringing a fresh approach to all that we do.

Our Strategy - The Plot!

During the year, we revisited our organisational strategy, developing 3 overarching themes:

- Fit for the Future
- Making Connections
- Aiming for Excellence

These themes were then broken down into specific actions to drive the Charity forward. Mike will cover this in more detail in our next newsletter which should be interesting reading!

We have also recently introduced a Dog A.I.D. "Charter" to voice a commitment to how we interact with each other, either in person or on line. We hope that all members, volunteers and supporters will subscribe to this in the manner in which it is intended ... we are growing but we want to maintain our 'family feel'

Recognition - Our Oscar ... and a bit of an unexpected twist!

A few months ago we received an email to say that we were to be given the "Shinning World Compassion Award" along with a gift of \$15,000 from Supreme Master Ching Hai!!

In June, Mike and I attended a presentation at Stoke Mandeville Stadium – the event will be broadcast on her own TV channel and we were showered with gifts. At the same time our client Ruth Spur and her dog Willow were also recipients of an award, or rather Willow was, for her outstanding services to her owner.


Dog A.I.D TREASURER REPORT for the nine months ended 31.3.19 Maggie Furmanek, Treasurer

During the nine months ended 31.3.19 the charity generated a net surplus of £4,259.

The charity became a CIO and the assets were transferred to the new charity at the start of the financial year. We took the opportunity to change the end of the financial year therefore this is a nine month period. Income (excluding the transfer of assets) for the nine months was £128,279 and expenditure was £124,020.

As at 31.3.19 our funds available were £74,032. These can be broken down as

This year we invested further £8,000 into Charifund units to enable us to gain a higher investment return than the bank accounts. It is intended to continue to increase this investment.


An immense thank you to all our donors, we would not be able to carry out our valuable work without you. Grants totalled £45,640 and we also received legacies amounting to £28,855



Sources of income for the nine months were




Comparing this to last year (twelve months)




