### **Role Purpose**

The Senior Training Advisor will play a key role in supporting the Head Trainer by carrying out appropriate key duties to ensure efficient delivery of all aspects of service delivery and charitable services.

### **Key Responsibilities/Duties**

- To work closely with the Head Trainer to;
  - Ensure overall effective delivery and development of Dog A.I.D. services, including online/virtual training programs.
  - Manage cases of concern and providing updates and outcomes.
  - Be responsible and accountable for overseeing the training carried out by the trainers.
  - o Plan and deliver Client/Trainer workshops and Showcase days.
  - o Develop training materials and resources for trainers and clients.
  - o Ensure the health and welfare of the dogs on the Dog A.I.D. scheme.
- To work with the Volunteer Manager to;
  - Educate volunteer trainers in areas such as equity, disability awareness and mental health awareness.
  - Coordinate Dog A.I.D.'s team of volunteer trainers, including supporting the trainers with trainer drop-in meetings.
  - Evaluate and assess new trainer applications.
- To work with the admin team to;
  - Develop and implement effective, consistent and equitable processes that support service delivery.

- Manage and respond to comments regarding training highlighted in monthly reports, identifying any that require further investigation.
- To manage the client Initial Assessment process and six-month probationary period.
- To act as the Internal Verifier for assessment of all levels.
- Keep appropriate records for ADI accreditation process in line with data protection and confidentiality requirements.
- To complete any training required to fulfil the role.

- Recent experience as a volunteer Dog A.I.D. trainer.
- Professional experience in positive dog training techniques.
- Finds value in working with both people and dogs and is driven by the overall goal to help transform the life of disabled people.
- Compassion and understanding of challenges for physically disabled people and the potential life-changing impact their dogs can provide as trained Assistance Dogs.
- Effective interpersonal skills with a diverse range of people: clear communication, teamwork, collaboration, management, negotiation, influencing, presentation, and problem-solving skills with the ability to empathise and understand individual needs.
- Good organisational and time management skills, with the ability to multitask, self-manage, plan and prioritise workload for self and colleagues when working on joint projects.
- Knowledge of legal requirements including safeguarding, health and safety, lone working, confidentiality, and UK GDPR.
- Proficient IT skills (MS Office) and the ability to produce clear reports.
- A good understanding of and commitment to the social model of disability; equity, diversity, and inclusion.
- Ability to travel if required across the UK.
- Commitment to Dog A.I.D.'s values and mission.
- Ability to think creatively, cope with limited resources, use your initiative, and seize opportunities - a 'can do attitude' willing to go over above your job role in order to contribute to the ongoing success of this small charity.
- Passionate about Dog A.I.D.'s charitable aims, service and delivering impactful work.
