The State of Rhode-Island and Providence Plantations.

By the Court of Probate, who are authorized by law, for the Probate of Wills, and to grant Letters of Administration on the estates of persons deceased, having goods, chattels, rights or credits, in the town of Providence in the county of Providence in the state aforesaid.

To all to whom these Presents shall come:—GREETING.

KNOW YE, That upon the day of the date hereof, the instrument herunto annexed, purporting to be the Last Will and Testament of Emma Bradley late of Providence

deceased, was presented to the said Court and proved; and thereupon the said Court did approve and allow of the said instrument, as the Last Will and Testament of the said deceased. Whereupon the said Court, by virtue of their authority, aforesaid, did commit administration of the said Last Will and Testament, in all matters concerning the same, and of the estate of which the said Emma died seized and possessed, in the said town, unto Bathman Sewley and Mary Sewley

the Executors therein named, well and faithfully to execute the same, and to administer on the estate of the said deceased, according therunto, who accepted of the said trust, and gave bond as the law directs, to return, upon each a year and perfect inventory of the said estate unto the said Court, within three months; and also to render an account of their proceedings thereon upon oath, within seven days required by said bond from the date hereof.

Share and Share alike to them their Heirs and assigns forever
and lastly I do hereby explain Reviviate and appoint them
My true Said Sisters Catherine and Mary Lowley My sole
Executors and Devisors together to this My Last Will
and Testament in testimony Whereby I have hereunto set
My Name and signed Myself this 27 day of August 1724
