It's mid-winter and daylight is slowly getting longer every day. This year we even have an extra day in February. Do you believe those born on February 29th age a bit slower? After all, they only have a real birthday every four years – just food for thought.

Those who attended the January civic league meeting heard an informative presentation by representatives from the Bay Lake Retirement Community. The turnout was not large, but those in attendance asked many questions, and there appeared to be quite a lot of interest in the subject. Keep in mind, we have eight civic league membership meetings each year. They are always on the third Tuesday of the months of January to May, and September to November. The venue is the fellowship hall at Bayside Presbyterian Church. Meetings convene at 7:00 PM and typically adjourn in about an hour or so. Please mark your calendars and spend some time with us. You won't be disappointed.

This month, we have a very timely presentation from representatives at Project Safe House. This is an important organization that assists and advocates for victims of human trafficking. It is a huge problem in this country today because it has increased with the virtually unchecked onslaught of migrants crossing our southern border in the last couple of years. The date for this meeting is February 20, 2024. I hope to see all of you there. This is one you don't want to miss.

Our 2024 civic league membership drive is underway. As of today, we have 224 member households on the active roster. My *personal goal* for 2024 is 450 households. That is 50 percent of our 900-home neighborhood. Help Jean Bowman and her membership committee reach that goal today by completing and mailing the membership form in this newsletter. Our low annual household dues are \$20.00. It is a small price to support this active civic league that works on your behalf throughout the year.

Recently while attending the Virginia Beach Council of Civic Organizations (VBCCO) meeting I had the opportunity to speak with Virginia Beach city manager, Patrick Duhaney. I thanked him for the role he may have played in preventing the installation of a traffic light at the intersection of Paul Revere and Independence. Our civic league has opposed that project since it was in the planning stage about four years ago. We see a traffic light at that intersection as being a detriment to our neighborhood primarily by increasing cut-thru traffic on our narrow residential streets – most with no sidewalks. Last year I sent a letter to Mr. Duhaney reiterating our opposition to that project. The civic league will continue to monitor the issue.

You may have noticed the medical practice at Copperfield and Independence has closed or moved. That was the business that prompted our community to petition the city for No-Parking signs on the streets around that intersection to curb the employees parking their vehicles in front of our residents all day. The building is now for lease. We will watch with interest to see what business moves there.

There are still weeks of winter ahead of us. Please be sure to watch out for your elderly or disabled neighbors. A helping hand or even just a simple phone call is appreciated – and it's the right thing to do.

It's Pruning Time

Pruning is a horticultural practice that alters the form and growth of a plant. Based on aesthetics and science, pruning can also be considered preventive maintenance. Many problems may be prevented by pruning correctly during formative years for a tree or shrub. It's good to prune to promote plant health, remove dead branches or branches that are rubbing together. Pruning can also encourage flower and fruit development and encourage hedge growth.

Timing is Everything!

The late dormant season is best for most pruning. Pruning in late winter, just before spring growth starts, leaves fresh wounds exposed for only a short length of time before new growth begins the wound sealing process. Another advantage of dormant pruning is that it's easier to make pruning decisions without leaves obscuring plant branch structure. Pruning at the proper time can avoid certain disease and physiological problems:

Prune before or after blooming?

Trees and shrubs that bloom early in the growing season on last year's growth should be pruned immediately after they finish blooming:

- apricot
- azalea
- chokeberry
- SEP chokecherry
- clove currant
- flowering plum | or ch
- forsythia
- Juneberry
- lilac
- magnolia
- early blooming spirea

Shrubs grown primarily for their foliage rather than showy flowers should be pruned in spring, before growth begins: alpine currant, barberry, buffalo berry, burning bush, dogwood, honeysuckle, ninebark, pea shrub, purpleleaf, sand cherry, smokebush, sumac

Shrubs that bloom on new growth may be pruned in spring before growth begins. Plants with marginally hardy stems such as clematis and shrub roses should be pruned back to live wood. Hardier shrubs such as late blooming spiraeas and smooth (snowball) hydrangeas should be pruned to the first pair of buds above the ground. In recent years, neighborhoods have experienced rapid change.

The old, well-established neighborhood has been replaced by a community where people seek more and more privacy. This lifestyle tends to promote unfamiliarity with neighbors and a corresponding lack of concern. Unfortunately, this enhances the opportunities for the criminal element and increases the community's vulnerability to crime.

Nextdoor.com is a website that encourages neighbors to communicate with other nearby neighbors. On that website you will notice that there are many neighborhoods that surround ours that have numerous reports of criminal activity. Lake Smith Terrace, Haygood Point, Governor Square are rarely mentioned. We are doing what it takes to discourage roving, early morning gangs checking for unlocked vehicles. Once they find a community that neglects to keep their vehicles locked, they will return again and again. When they do come into our community and find all the vehicles locked the criminal element will go elsewhere.

We need everyone to buy into Neighborhood Watch to keep out the criminal element. We are fortunate to live in a community where everyone has pride in their homes. This shows those with dishonest intentions that our community is very stable, with longtime residents who support one another.

Get to know your neighbors advise them when you are going to be away for an extended period. Give them your contact information in case they need to contact you while you are away. You will have a better trip if you know that someone is watching your home. In most cases you will be asked to reciprocate when they go on vacation.

The police can't be everywhere all the time, and in truth many law enforcement agencies are undermanned and have limited staffing. But it's a foregone conclusion that in most neighborhoods someone is going to be home, even during the workday or while you're off on a vacation. Neighborhood Watch is a program designed to neighborhood security, enhance heighten community's power of observation, and to encourage mutual support and concern among neighbors. Not only will looking out for your neighbors create a sense of community, but it will also help prevent crime and protect property in your neighborhood. Neighbors watching out for neighbors is a better crime deterrent than any burglar alarm.

Over the past few months, the number of settled sales has somewhat "slowed", mostly due to low inventory. Days on the market are a little longer for some homes, others are under contract in a matter of days! Prices have increased and so have interest rates, creating an affordability issue for some buyers and they are forced to rent. With such a short supply of homes it has continued to be a "seller's market"

The City of Virginia Beach is experiencing a housing shortage. There are only 607 active listings (attached and detached homes) and out of those 197 are under contract which leaves only 413 properties available to purchase. If you consider the City of Virginia Beach has a population of approximately 465,000 people, that is a very low supply of available homes.

It is not uncommon to experience multiple offers on a home for sale due to the low available inventory, but we are not receiving as many offers that we did in the Spring of 2023. The current housing situation is making it more challenging for buyers to even find a home.



February Gardening Tips

Mulch planting beds in early spring to retain moisture, reduce weeds naturally and protect plant roots from extreme temperatures.

Organic mulch will add nutrients to the soil, so it's perfect for mulching flower beds. Look for shredded hardwoods, nuggets of pine bark, pine needles or straw. First, clean up your annual and perennial flower beds. Then work compost into the soil and finish with a 3-4 inch layer of mulch.
