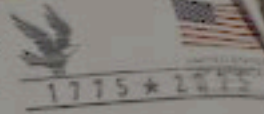

The American Arbitration Association (“AAA”) has determined this demand for arbitration involves a domestic commercial matter. Further, the AAA has determined that this demand for arbitration involves an online marketplace or platform and an individual user. Therefore, pursuant to the footnote in R-1 of the Commercial Arbitration Rules, the Consumer Fee Schedule applies to this dispute. The Commercial Arbitration Rules and the Consumer Fee Schedule are both available on the AAA’s website [www.adr.org](http://www.adr.org)

**Under the Consumer Fee Schedule, the individual pays a filing fee of \$225 and the business pays a filing fee of \$375. However, we note in the parties’ agreement that for monetary claims of \$10,000 or less, the Respondent will pay all filing, administration, and arbitrator fees associated with the arbitration at the Claimant’s request. Therefore, and based on both the Claimant’s request and the monetary claims of less than \$10,000, the AAA requests **the business submit the full balance filing fee in the amount of \$600 on or before October 30, 2025.****

Please note payment should be submitted by credit card or electronic check. A secured paylink will be forthcoming with

instructions to submit payment via either method.

Please note: no answering statement or counterclaim is due at this time. The AAA will notify the parties of the response deadlines when all fees have been received.
