Washington State Jet Ski Rental Checklist

Motor Vessel Rental Safety Checklist

- [] U.S. Coast Guard-approved
- [] Properly fitted for each rider.

Whistle or Sound Signaling Device

Fire Extinguisher

[] If applicable to the watercraft

Emergency Contact Info

[] Laminated or waterproof card

Age Requirement Policy

- [] Minimum age to operate a jet ski in Washington is 16 years old.
- [] Valid government-issued photo ID needed.

Rental Documentation

- [] Signed Rental Agreement
- [] Signed Liability Waiver
- [] Copy of Photo ID
- [] Proof of Age Requirement
- [] Damage Deposit or Credit Card Authorization

Personal Prep for Riders

- [] Quick-dry clothing or swimsuit
- [] Water shoes or secure sandals
- [] Sunglasses with strap
- [] High-SPF sunscreen (water-resistant)

Waterproof phone case [] Towel & change of clothes

Extras for Comfort

- [] Water bottle or hydration pack
- [] Light snacks (granola bars, fruit)
- [] Dry bag for valuables
- [] Small first aid kit

Operational Briefing

- [] Safety rules and no-wake zones
- [] Local waterway map or route guidance
- [] Jet ski controls and emergency shut off.
- [] Fuel level and refueling instructions.
- [] Return time and location.

Non-Compliance with Safey Checklist/Policy:

1. **Denial of Rental**: If renters do not meet the requirements (e.g., age, valid ID, or signed agreements), they may be denied access to the jet ski rental.

- 2. **Fines or Penalties**: Non-compliance with Washington State safety regulations, such as not wearing a life jacket or working a jet ski without meeting age requirements, could result in fines or legal penalties.
- 3. **Liability for Damages**: If renters do not follow operational guidelines and cause damage to the jet ski or other property, they may be held financially responsible.
- 4. **Termination of Rental Agreement**: Failure to adhere to safety rules or operational instructions could lead to the rental being ended early.
