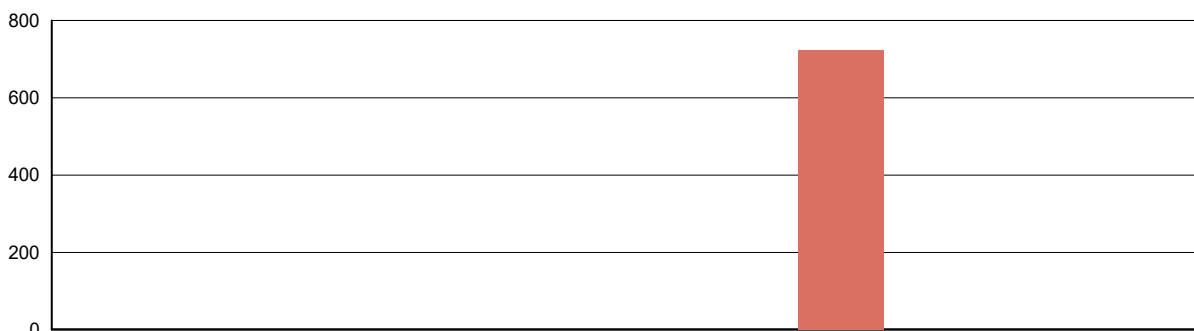

The measurement uncertainty is calculated using a coverage factor of 2.
