Adoption Agreement

This Agreement is made on this _____ day of _____, 2020, by and between _____, hereinafter referred to as the "Adopter" and Palomino Ridge Ranch Horse Rescue, Inc., hereinafter referred to as "PRRHR."

Adopter agrees to pay the adoption fee of \$_____.

1. Adopter understands and agrees that the Equine identified in this contract may not be sold, given away, lent, leased, sent to an auction, sent to slaughter, removed from Adopter's personal supervision and control or removed from the address listed herein.
2. Adopter agrees to contact PRRHR in the event that the owner no longer wishes to keep said Equine identified in this contract and Adopter must return said Equine to PRRHR.
3. Adopter agrees to accept all responsibility for any action or lien resulting from any action, directly or indirectly involving said Equine while it is in Adopter's possession, care and control. Adopter agrees and understands that neither PRRHR nor its board members, employees or agents will be liable for any damage or injury caused to Adopter, third parties or property by said Equine once Adopter takes possession of said Equine, including but not limited to damages or injuries caused by said Equine. Further, if any third party makes a claim against PRRHR or any of its board members, employees or agents as a result of any conduct of said Equine after the Adopter takes possession of said Equine, Adopter agrees to indemnify and hold PRRHR, its board members, employees and agents harmless from any such claims, including all costs and attorney's fees resulting from such claim.
4. In the event of the Adopter's death, an Adopter's heirs may complete a new Adoption Application to keep said Equine or shall return said Equine to PRRHR.
5. Adopter understands that breeding of said Equine adopted from PRRHR is strictly prohibited unless otherwise agreed upon in writing by PRRHR.
6. Adopter understands that PRRHR makes no representations or warranties to Adopter regarding the physical condition other than what is apparent to both parties. PRRHR has made no representations as to the future fitness, soundness, health or welfare of said Equine.
7. Adopter understands that there is no refund of adoption fee if said Equine is returned to PRRHR.
8. Adopter represents that he/she has read, understands and agrees to this Adoption Agreement in its entirety and shall be bound by all conditions listed herein.
