

RAFFLES, RAFFLES

Basket raffles, 50/50 raffles, Donated Item raffles. The list goes on and on.

Raffles are definitely a favorite fundraiser for every GFWC-SC Club.

But do you know and understand the SC Secretary of State registration and filing regulations for raffles?

Generally, in order to conduct a raffle, a nonprofit organization must file an <u>annual raffle registration form (PDF)</u> with the Division of Public Charities. Registered organizations are also required to file an <u>annual raffle financial report (PDF)</u>.

However, if an organization only conducts "exempt" raffles, it is not required to file a raffle registration or annual raffle financial report. "Exempt" raffles are different from "nonexempt" raffles (PDF) in terms of prize limits, raffle participants, and frequency of raffle events. A summary of the differences can be found via the link above.

The two types of exempt raffles are:

(1) Raffles in which a noncash prize or prizes have been donated to the nonprofit organization, and the total value of the prize or prizes of a single raffle event is not more than \$950.00;

and

(2) Fifty-fifty raffles in which the total value of the proceeds collected is not more than \$950.00, and raffle tickets are sold ONLY to the nonprofit organization's members or its guests, and not to the general public.

If your raffle does not meet either of these criteria, then you MUST file a registration form and an annual raffle financial report. The filing fee for the raffle registration form is \$50.00. In addition, your nonprofit must file an annual raffle financial report 4 ½ months after the end of its fiscal year.

Rules for Non-Exempt Raffles

Don't let the filing requirement for Non-Exempt raffles scare you. It isn't difficult and can be done online at the same time you are filing your annual registration documents with the Secretary of State. But you do need to track certain information in addition to the value of each prize. These include how many tickets you have sold and the total amount earned for each raffle through raffle ticket sales.

For each raffle event, the fair market value of all prizes offered cannot exceed \$300,000.00. Furthermore, the fair market value of a single raffle prize cannot exceed \$80,000.00. The purchase price of a raffle ticket may not exceed \$300.00. You can hold only 4 non-exempt raffles each year.

However, it is important that you complete the filing on a timely basis.

Non-compliance with the Nonprofit Raffles for Charitable Purposes Act, including but not limited to failure to submit all forms and documents in a timely manner, will result in the assessment of administrative fines as well as criminal prosecution. The Secretary of State may, upon his own motion or the complaint of any person, investigate persons and organizations that violate South Carolina law governing raffles. Some GFWC-SC clubs have had to pay such fines. And, they received a letter from the Secretary of State stating that they were no longer considered a recognized charity within South Carolina because of their failure to file the annual raffles report. From the date of that letter until the situation was corrected, they could not accept donations or have ANY fundraisers. All was quickly cleared with submission of the filing and payment of the fines. But don't risk that!

GFWC-SC club treasurers need to stay on top of the filing and reporting requirements. If you have questions or need help in understanding the rules, reach out to me. I'll be glad to help you.

In the meantime, I hope I see you at Headquarters and that you participate in the raffles there.





- All reports must be emailed by midnight of the due date listed please send one report package/ subject (cover sheet, report, and/or addenda) in one email with the club's name and CSP/Special Project name in the email subject line.
- Report all club approved projects your club has done for each CSP, GFWC Special & Signature Program,
 Advancement Plan and President's Special Project -Complete a Statistical & Narrative Cover sheet on
 EVERY club approved project even if your club is not providing a narrative.
- INCLUDE IN EACH REPORT: A separate Statistical & Narrative Cover Form with Submission Type clearly marked, a separate narrative for each program report, as well as addenda (if you are providing any of these). Make sure you indicate Narrative and/or Addenda or both on the cover sheet form
- Clubs are asked to put special emphasis on up to three (3) TOP projects in each of their reports by BRIEFLY describing the INTENT of the project...who, what, when, where & why of the project in the narrative.

- Up to three (3) Narrative pages can be attached in the email with the Statistical & Narrative Cover Form marked as Narrative.
- Up to five (5) Addenda pages can be attached in the email with the Statistical & Narrative Cover Form marked as Addenda.
- Caption ALL photo addenda with Club Name, CSP or Special Project reporting under, and what is happening
- Junior Clubs must submit one additional report to the Director of Junior Clubs Michelle Blackmon at mmichelleblackmon@gmail.com.
- GFWC-SC PRESIDENT'S SPECIAL PROJECT, GFWC-SC DIRECTOR OF JUNIORS SPECIAL PROJECT, FUNDRAISING & THE CIP REPORT are the only projects that may be 'double' or 'cross' reported.
- All clubs are encouraged to, AT A MINIMUM, submit the Statistical & Narrative Cover Form
- Only reports received via email will be judged unless otherwise stated!

JUDGING CRITERIA

Evaluation of each report will be based on the following so please address all applicable items in your reporting:

- Total volunteer hours, dollars donated, dollars raised and in-kind donations will be evaluated on a per capita basis for all clubs
- Description of the projects in the narrative form
- Number of projects, hours, dollars, & in-kind contributions
- Participation of membership as compared to club size
- Community participation especially other outside organizations or individuals
- Publicity of project for club, GFWC-SC, and GFWC
- Success of project impact on community
- Any additional information i.e. awards, sponsorship relating to project
- Innovation and originality of project

DEFINITIONS FOR REPORTING

ADDENDA may include photos, handouts, publicity, etc. which help augment the understanding of your narrative and project.

ADVANCEMENT PLANS are the programs and projects clubs initiate to advance their clubs. There are 6 plan areas: Communication & Public Relations, Fundraising, Leadership, Legislation & Public Policy, Membership, Women's History & Resource Center.

AFFILIATE ORGANIZATIONS such as United Nations Program Shot@Life, Heifer International, St. Jude's Children's Research Hospital, Operation Smile, Hope for Justice, March of Dimes, Canine Companions for Independence, UNICEF and Alzheimer's Association. PLEASE SHARE IN YOUR NARRATIVE ANY IN-KIND DONATIONS AND VALUE. GFWC HAS ASKED FOR THIS AFTER OUR FORM WAS APPROVED. (As AFFILIATES do change, for a complete list, refer to the GFWC.org website.) Also complete the SC Affiliate Statistical Form – this is one form to capture ALL the work your club does with any of the Affiliate Organizations.

COMMUNITY SERVICE PROJECTS (CSPs) are the programs and projects club members initiate and participate in to serve their communities, including projects with GFWC Affiliates. There are 5 program areas: Arts & Culture, Civic Engagement & Outreach, Education & Libraries, Environment, Health & Wellness.

DOLLARS DONATED is the monetary amount given to programs and projects.

DOLLARS RAISED reflect dollars earned from fundraising and development of programs and projects. Applies to **FUNDRAISING ONLY**.

IN-KIND DONATIONS reflect the monetary value for goods provided to CSP programs and projects. Please refer to the GFWC In- Kind Donation Guide for an estimated value of commonly donated items at https://www.gfwc.org/wp-content/uploads/2018/08/In-Kind-Donation-Guide-2018.pdf You may certainly estimate a value you feel best reflects your contribution.

INTENT explains reason for project.

NARRATIVE is the written description wherein you describe the Intent of the Project and the Who, What, When, Where and How.

WHERE, HOW and WHY OF A PROJECT

NUMBER OF PROJECTS is the numerical account of the programs and projects initiated and participated in by your club.

STATISTICS are the Numbers: dollars, hours, members, etc.

VOLUNTEER HOURS are the amount of time that members worked on Club Approved programs and projects.

EXAMPLE: If a club member or even several separate members donate blood, deliver Meals-On-Wheels, make financial contributions to a charity, etc. it is NOT REPORTABLE. IF your CLUB votes to make a project of volunteering at the food pantry, delivering Meals-On-Wheels, makes a charitable grant or contribution with Club Funds, or go as a group wearing GFWC or Club apparel to donate blood, then that is a Club Project and those hours are reportable. REMEMBER: When you have a speaker (or attend a state meeting), you may count volunteer hours for the subject matter (ex: Environment) for each club member attending. Round to nearest hour!

- *Scroll about halfway down the page till you see: Customize the GFWC logo with your club name.
- *Click: Customize on CANVA.

Some things to remember:

- *Use (30pt Horizontal and 16pt Vertical) font on your club name. Remove [] when finished.
- *Capitalize each word. Do not use ALL CAPS unless it is on your official club charter.
- *If your club name is longer than 30 characters, use two lines.
- *Using GFWC in front of your name is not necessary in this format.
- *Keep the color font used on each template.

Once Finished:

- *When you've added your club's name to all the templates, it's time to export them!
- *Select "SHARE"
- *Then "DOWNLOAD".
- *Select PNG under "File Type".
- *Select Transparent Background if you are a CANVA PRO user. All other files will have a white or color background.
- *Select the pages you would like to download and save the files on your computer.

GFWC Signature Program: Domestic Violence Awareness & Prevention Connie Lawson, Chairman

I'd like to express my gratitude to all the Clubs across South Carolina for all your creative ideas and hard work related to our Signature Program Domestic and Sexual Violence Awareness and Prevention. You focused on domestic and sexual violence for our International Day of Service, then continued on during the month of October, to highlight Domestic Violence Awareness Month sharing survivor resources on your social media pages, hosting and participating in domestic violence awareness walks, and supporting the work of so many varied organizations.

As you know, GFWC South Carolina partnered with SCCADVASA (South Carolina Coalition Against Domestic Violence and Sexual Assault) to run two educational social media campaigns, one focused on Domestic Violence and Sexual Assault, leading up to the International Day of Service and the other to raise awareness during Domestic Violence Awareness Month. This partnership not only distributed numerous domestic violence/sexual assault messages along with resources but also increased our state federation's visibility and reputation as a strong advocate. Thank you for your help in achieving the following results during those campaigns:

International Day of Service

From September 21-27, 2025, we posted twice daily on Facebook and Instagram.

The results were:

Facebook: 7 messages posted 13 times 10,195 total views 4,864 estimated reach 308 interactions (likes, comments, shares) **Instagram:** 7 messages posted 7 times 383 total views 216 estimated reach 39 interactions.

Thank you messages were posted to registered clubs:

Facebook: 25 thank you posts 6,718 total views 3,293 estimated reach 267 interactions

Instagram: 25 thank you posts 1,366 total views 675 estimated reach 120 interactions

Additionally, we made 4 unique posts referencing IDS:

Facebook: 4 posts 2,801 total views 1,221 estimated reach 119 interactions Instagram: 2 posts 90 total views 29 estimated reach 9 interactions

Domestic Violence Awareness Month During the month of October, Monday through Friday, we posted twice daily on Facebook and Instagram. The results were:

Facebook: 23 posts, 11,315 views, 5,809 reach 328 interactions (likes, comments, shares)

Instagram: 23 posts, 1,154 views, 667 reach 110 interactions

Unfortunately, Domestic Violence is a topic that is not going away anytime soon, and I would like to ask each club to start thinking about and planning for February 2026 considering ways your club can help to prevent Teen Dating Violence

Romantic relationships between teenagers are incredibly complicated and riddled with problems including communication, jealousy, and selflessness. As a result, teenagers are more likely to be involved in relationships that are unhealthy, violent, and/or abusive.

Reg Flags often seen in Teenage Relationships:

- Excessive jealousy or insecurity;
- Invasions of privacy;
- · Unexpected bouts of anger or rage;
- Unusual moodiness;
- Pressuring a partner into unwanted sex; Blaming their partner for problems in the relationship and not taking any responsibility for the same;
- · Controlling tendencies;
- Explosive temper;
- Preventing a partner from going out with or talking to other people;
- Constantly monitoring their partners whereabouts and checking in to see what they are doing and who they are with;
- Falsely accusing of things;
- Vandalizing or ruining their partner's personal property;
- Taunting or bullying; or Threatening or causing physical violence.

Preserve Our Birds

Dr. Thomas Lovejoy famously said, "If you take care of birds, you take care of most of the environment problems in the world." Alarmingly, a 2019 study revealed that North America has lost 3 billion birds (29% of its population) since 1970. GFWC South Carolina's President's Special Project, Preserve Our Birds, hopes to address this decline, one member, one club, one state at a time.

Habitat loss is the primary factor in this decline, along with climate change, window collisions, wind turbines, and pesticide pollution. Restoring natural habitats is vital, and native plants play a crucial role. In April 2025, Senate Resolution 157 passed, designating April 2025 as National Native Plant Month. GFWC South Carolina was proud to lend our name as a supporter of this legislation. However, since it's a resolution and not a law, reintroduction annually is necessary, and GFWC state federations can advocate for making it permanent. https://nationalnativeplantmonth.org

GFWC Clubs can make a difference by acting:

EDUCATE: Raise awareness about birds, native plants, pesticide impacts, and bird-proofing measures like decals and screens.

ENGAGE: Promote bird-friendly legislation. Join initiatives like the <u>Great Backyard Bird Count</u> (February 13-16, 2026).

EMPOWER: Create bird-friendly spaces by planting trees and native flora, setting up feeders, and providing water. Support conservation efforts through donations or volunteer projects.

Through education, engagement, and direct action, GFWC clubs can play a pivotal role in preserving bird populations and fostering a healthier environment. We hope you will join GFWC South Carolina in helping to Preserve Our Birds.
