Equal Rights?

Recent news stories about sexual harassment and assault got me thinking about GFWC's advocacy for women's rights. Did you know that in 1934, GFWC began a ten year study to review the proposed Equal Rights Amendment? Did you know that in 1944 GFWC adopted a resolution in support of the Equal Rights Amendment?

Here is the text of GFWC Resolution 015-210:

Equal Rights and Responsibilities for Women (Convention 1944; Reviewed 1950; Amended 1967; Reviewed 1987; Reviewed 1991; Reviewed 1995; Reviewed 1999; Amended 2003, Reviewed 2007; Reviewed 2011; Reviewed 2015)

WHEREAS, The United States Constitution does not guarantee quality of status for women, except with regard to the right to vote, and will guarantee equality of other rights only when an amendment for the purpose is included therein; and

WHEREAS, Lack of ratification of the Equal Rights Amendment (ERA) continuously jeopardizes women's parity with men in the areas of health care, violence, education and employment; therefore

RESOLVED, That the General Federation of Women's Clubs reaffirms its support and urges the immediate ratification of the Equal Rights Amendment(ERA) which would provide that equality of rights under the law shall not be denied or abridged by the United States or by any state on account of gender.

Even though this resolution was adopted in 1944, the push to have the ERA passed occurred between 1972 and 1982. Supporters, many who were clubwomen to be sure, lobbied, marched, petitioned, picketed, went on hunger strikes and committed acts of civil disobedience in an effort to get the amendment passed. The Equal Rights Amendment passed the U.S. Senate and then the House of Representatives, and on March 22, 1972, the proposed 27th Amendment to the Constitution was sent to the states for ratification. Congress placed a seven-year deadline on the ratification process. Thirty eight states need to ratify the amendment in order for it to become law.

Opponents of the amendment played on the same fears that had generated female opposition to woman suffrage. Anti-ERA organizers claimed that the ERA would deny woman's right to be supported by her husband, privacy rights would be overturned, women would be sent into combat, and abortion rights and homosexual marriages would be upheld. Don't these fears seem so strange and foreign in 2017? By the way, South Carolina was one of the states that did not ratify the amendment.

The Equal Rights Amendment has been reintroduced before every session of Congress since 1982, and GFWC continues to support its passage. Some of you may wonder why this amendment is needed, and I guess I would point you back to the recent news stories of sexual harassment and assault. The ERA would clarify the legal status of sex discrimination for the courts, where decisions still deal inconsistently with such claims. For the first time, sex would be considered a suspect classification, as race currently is. Incoming GFWC International President Mary Ellen Brock at the Southern Region Conference listed resolutions and legislation as two of the six areas she intends to focus upon, so expect GFWC to return to its roots by supporting legislation. Such support is not political, but practical, to paraphrase Mary Ellen Brock.

To Budget or Not!

Does your club prepare an annual budget? Now is the time to start thinking about your club's annual budget. Many of our clubs feel that they are so small – they do not need a budget but the budget is your financial roadmap for the year.

Start with outgoing money.

Identify the key activities and programs you spend money on, as well as administrative expenses that arise each year. Look at what your club has actually spent in each of these areas over the last two or three years, and come up with an estimate of how much you need for the upcoming year.

Next, measure the incoming money.

How has your club raised money in the past? Go through the same exercise: look at your income over the last year two or three years including membership fees and fundraisers. What will you repeat? What was successful? What's not working? What's realistic? Get a total for what you hope to raise and how you plan to do it.

The balancing act...

Look at the two lists: income and expenses. If your expenses outweigh your income you probably know the two alternatives: cut back on your expenses or increase your income. Which will better serve your membership? Can you add

another fundraiser?

Should you eliminate or reduce the scope of a particular activity? If your income outweighs your expenses, you also have decisions to make. Do you cut back on fundraising and give your volunteers a break? Or do you raise the bar and provide more services this year?

Set some money aside.

Your final step is to "reserve" some money for carry over to the next year. How much is right for your club? If you plan your major fundraising activities early in your financial year, you can get by with less carry over. But if you have major financial commitments each year, you will want to ensure that you have enough money to meet these if fundraisers don't do as well as planned.

Changing the Budget

Throughout the year, adjustments may need to be made to stay on course. If a particular fundraising activity brought in more revenue than you'd planned for, you will need to look at how to spend that unanticipated income. Alternatively, if expenses were higher than anticipated, you may need to increase fundraising activities or cut back on services in order to balance your budget. Remember, your club's budget is just a plan – a living document which will help to successfully guide you through your next program year.



Reports for GFWC Special Programs, GFWC Community Service Programs and Advancement Areas:

Two (2) copies of each report should be mailed, postmarked on or before February 1, 2018, to GFWC-SC Second Vice President Kristin Fields, 230 Muirfield Drive, Columbia, SC 29212. The first hard copy of each report mailed is needed by the Second Vice President to forward to the respective State Chairman for judging. The second copy is forwarded to our State President for reporting purposes.

If you choose to email the reports, each report should be sent by separate email to kristinf11@aol.com with the name of the club and the name of the Community Service Program, Special Project or Advancement Area in the subject line.

An email confirmation will be sent to the club president upon receipt of the reports, whether you submit via mail or email.

Junior clubs must submit **one (1) additional copy** to the Director of Junior Clubs, Katie Moydell, 200 Conrad Circle, Columbia, SC 29212, or by email at KatieMoydell1020@gmail.com.

Include with each Report:

- (1) A <u>Separate</u> completed GFWC-SC State Narrative Entry Cover marked "FOR JUDGING". A GFWC-SC State Narrative Entry Cover form can be downloaded from www.gfwc-sc.org website. Note: The number to be inserted in the Total Number of Club Members is the **number of club members paid as of April 30, 2017**. This number was included on the Club Roster in the Club President's Packet distributed at Summer Board.
- (2) A <u>Separate</u> narrative for each program report consisting of a maximum of three (3) single spaced typed pages. [Do Not Combine Narratives.] Only reports submitted with narratives are eligible for consideration for state awards. If you choose not to include a narrative, the statistics provided on the cover sheet and/or on the Statistical Form will be included in the totals for composite state reports to GFWC.
- (3) <u>Addenda</u> (supporting documents) are optional. Addenda are limited to five (5) pages and must be attached <u>only</u> to the report marked "FOR JUDGING."

Reporting Criteria

Clubs should report all activities for each Community Service Program, GFWC Special Program or Advancement Areas. All activities reported must be club approved projects. A project/program may not be reported in more than one Community Service Program, Special Project and/or Advancement area report. Clubs are asked to put "special emphasis" on up to three (3) of their top projects for each of the Community Service Programs (CSP Projects and Partnership Projects), GFWC Special Programs and Advancement Areas by reporting the "who, what, when, where, how and why" of the project as well as pertinent statistics for the project. Providing complete details will assist our state chairmen with judging and writing of their reports.

Certificates of Award

Certificates of Award will be given at convention to the 1st and 2nd winning entries in each of the three (3) General membership categories and two (2) Junior membership categories, and one (1) Juniorette category.

General Categories

1 - 12 members Category I Category II 13 – 30 members Category III 31+ members

Junior Categories

1 - 20 members Category I Category II 21+ members

SILVER CERTIFICATE AWARDS TO BE AWARDED AT GFWC-SC CONVENTION BASED ON REPORTS SUBMITTED FEBRUARY 1, 2018

All Clubs submitting reports by February 1, 2018, will be considered for the following Silver Certificate Awards to be judged by the respective Community Service Program or Advancement Area Chair. Clubs do not need to send a special report for these certificates but should include in their narratives the appropriate information qualifying the club for the particular Silver Certificate. For example, the Education report would contain a description of the club's activities to eradicate illiteracy, thus qualifying the club for the Marie J. Hammond Silver Certificate.

Education:

Marie J. Hammond Award: Sponsor: Mrs. Dean C. Hammond. Basis: To the club accomplishing the most toward the eradication of illiteracy.

Debbie Alexander Adult Education Award: Sponsor: Friends of Debbie Alexander. Basis: To the club which has accomplished the most in the field of "Adult Education" by promoting adult literacy. Action Plan: Volunteer to tutor, provide transportation, offer facilities, purchase books or supplies for local literacy organizations, provide child care facilities, assist with refreshment for celebrations, promote adult education programs in your community, etc.

Fundraising:

Rebecca Robbins Award: Sponsor: Aiken Junior Woman's Club and Sand River Woman's Club. Basis: To the club or clubs working jointly, with the best overall fundraising project.

Leadership:

Leadership Silver Award: Sponsor: Saxe Gotha Woman's Club. Basis: To the club with the best overall leadership report

Legislation and Public Policy:

Legislation Award: Sponsor: Carrie Jane Hughes. Basis: To the club reporting on an unusual legislation project.

Public Issues Award:

Lexington Woman's Club Public Affairs Award: Sponsor: Lexington Woman's Club. Basis: To the club doing the most outstanding work in Public Issues.

GFWC-SC JUDGING CRITERIA

Evaluation of the report will be based on the following points of information. Please address each applicable item in your report. Total volunteer hours, dollars donated, dollars spent, dollars raised and in-kind donations will be evaluated on a PER CAPITA BASIS for all clubs.

Description of the project(s) in narrative paragraph form.

Number of projects, hours, dollars and in-kind contribution. Innovation/originality.

Participation of membership (consider club size).

Community participation (any outside organization or individuals that were involved and how).

Publicity of project, club, GFWC-SC, GFWC. Success of project (impact on community).

Any additional information requested by the award sponsor relating to a particular award.

Contest Entries due February 1, 2018

Yearbook Award - Certificates will be awarded to clubs in the same membership categories as Community Service Program Awards. Yearbooks will be judged as professional (all or any typeset and layout work done by printer) or non-professional (club members type, copy and put together). Refer to the Yearbook Rating and Release Form distributed in President's Packet for content/judging criteria.

One (1) copy of the Club Yearbook with Yearbook Rating and Release Form must be sent to the Yearbook Chairman Frances Dantzler, 101 Point Drive, Lexington, SC 29072. Yearbooks may also be delivered at the GFWC-SC Winter Board Meeting in January 2018.

Communications and Public Relations

Newsletter Contest - Clubs and States may submit only one newsletter, and the newsletter must have been printed and clearly dated during the reporting year (January 1 – December 31, 2017). Accompanying your entry must include a cover letter with GFWC specifics included.

Entries will be judged and awarded points on the following elements: 1) Content quality, including timeliness, clarity, and member impact (30%); 2) Presentation (30%); 3) Design (30%); 4) Adherence to rules (10%).

A copy of the submitted sample of the club newsletter must also be sent to the GFWC-SC Communication/Identity Chairman, Melanie Branham, 119 Richland Drive, Easley, SC 29642, postmarked on or before February 1, 2018.

GFWC Awards:

Clubs - A first, second, and third place certificate will be awarded annually at the GFWC Convention to three clubs in the nation.

State – GFWC certificates are awarded annually at the GFWC Annual Convention to the one State Federation in each membership category to recognize creativity and outstanding achievement in producing a State Federation newsletter.

Website Contest - Only one website per Club/State Federation may be submitted. The website homepage must contain a link to www.GFWC.org, and must include contact information for at least one member of the club (email address, telephone number and or mailing address).

The submission should include the website address, Club/State Federation name, website address, President's name and contact information, name and contact information of the person submitting the entry, number of Club/State Federation members, and a 250 word essay describing the website's purpose and the club's/State Federation's approach on website maintenance.

Submissions should be emailed to GFWC-SC Website Chairman, Kaye Gerrald at k.gerrald@gmail.com on or before 5:00 PM February 1, 2018.

GFWC Awards:

Club - A first, second, and third place certificate will be awarded annually at the GFWC Convention to three clubs in the nation.

State - GFWC certificates are awarded at the GFWC Convention to one State Federation in each membership category to recognize outstanding achievement in website implementation and maintenance.

Media Campaign Contest - Clubs may submit one media campaign per category: Advocacy, Fundraising, Membership Recruitment, and Special Events.

The media campaign must take place during the contest year: January 1, 2017-December 31, 2017. Campaign materials must include a medium (i.e. website, Facebook page, Twitter feed, YouTube Video, etc.) and contact information where additional information can be obtained. The following information should be included: Club President's name and contact information, Name and contact information of individual submitting the entry, Number of club members, Campaign Category, and an essay of no more than 500 words that includes the goal, budget, target audience, strategies and tactics, key messages, and post-campaign measurement and analysis.

Each campaign must be emailed separately to GFWC-SC Communication/Identity Chairman, Melanie Branham at melaniebranham@yahoo.com on or before 5:00 PM February 1, 2018.

Contest and Writing Awards due March 15, 2018:

GFWC Youth Writing Competition: Entries must be typed, double-spaced, printed on one side only, with minimum margins of one-inch on all four sides, on 8-1/2" x 11" paper. Entries must be written during the contest year (Jan. 1 - Dec. 31).

Entries must have the following in the top right hand corner of each page: author's name, e-mail address, mailing address and phone number; name of author's GFWC club and state federation submitting the author's work; category and title of work.

Grade Level Categories: 1 (Grades K, 1, and 2), 2(Grades 3, 4, and 5), 3(Grades 6, 7 and 8), 4(Grades 9, 10, 11 and 12). One entry per person per category.

Authors must be of amateur status; earnings from writings may not exceed \$500 annually. Entries may not have been published prior to the competition and must and must be original works by author. Short stories limited to 2000 words. Poems can be any style with a minimum length of eight lines and a maximum of 50 lines.

A completed and signed GFWC Creative Arts Waiver must be submitted with each entry.

Manuscripts will not be returned. Authors should keep a copy. First place state winners will be sent for national judging.

Send to GFWC-SC Writing Contest Chairman, Stephanie Williams, 274 Sun Colony Blvd. Longs, SC 29568, postmarked on or before March 15, 2018.

GFWC Clubwoman Short Story and Poetry Contest: Authors must be dues-paying members of an active GFWC club. Entries must be typed, double-spaced, printed on one side only, with minimum margins of one-inch on all four sides, on 8-1/2" x 11" paper. Entries must be written during the contest year (Jan. 1 – Dec. 31). Entries must have the following in the top right hand corner of each page: author's name, e-mail address, mailing address and phone number; name of author's GFWC club and state federation; category and title of work. Submit one entry per person per category.

Authors must be of amateur status; earnings from writing may not exceed \$500 annually.

Entries may not have been published prior to competition and must be original works by author.

Short stories limited to 2000 words. Poems can be any style with a minimum length of eight lines and a maximum of 50 lines.





