Minutes of a meeting...why in the world are they so darn important? Well...there are a lot of good reasons to keep accurate minutes of your meetings such as they save time and prevent confusion about decisions made, they provide documentation for future actions, and they protect your 501(c)(3) designation. Today though, we are going to look into on why the IRS cares about your minutes.

For your club to get its 501(c)(3) designation, the IRS required a copy of your Bylaws along with its application for tax exemption. Your Bylaws are the legally binding rules by which your club is governed. Nonprofits are required to keep records of their Bylaws however once your 501(c)(3) is approved; your Bylaws can be changed without officially filing the changes made.

So, what do your minutes have to do with your Bylaws and the IRS? Your minutes are the records which your club is run. They are in essence "proof" you are following your Bylaws and continue to be a 501(c)(3) in good standing. When the IRS refers to records, it usually means your finances as well as your club's accounting procedures. And while the IRS encourages nonprofits to keep minutes, they do not specify a format for the recording or storing of your minutes. (Note: If the IRS is asking about something that means they care about it and if you are not meeting what they consider good governance practices, you just may be on their radar!). The one place the IRS does explicitly reference meeting minutes is that the meeting minutes MUST be kept permanently. If you do not keep complete records of your club, you run the risk of losing your tax-exempt status.

So...what should you include in your minutes? At a minimum, the following information is

- Date and time (start and end) of your meeting
- Type and purpose of meeting
  If a quorum was established based on your Bylaws
- Actions taken (approved or not)
- Action items on commitments made

Make sure though that beyond these, your meeting minutes are structured to help your club and not just to satisfy the IRS...they are ultimately there to aid in the success of your club and the work you do.

## Legislative and Public Policy Advancement Area Janet Watkins, Chairperson

National Legislation to follow can be accessed from the GFWC website <a href="https://www.gfwc.org/what-we-do/public-policy/">https://www.gfwc.org/what-we-do/public-policy/</a> scroll down and click on the Legislative Action button. Be sure to sign up for the Legislative Action Center and click on the remember me buttons to continue getting updates. The current action request is to end Campus Sexual Assaults

There are two resolutions in the current Congress that GFWC is supporting. Both resolutions are calling for removal of the deadline to the Equal Rights Amendment. SJ Resolution1 is a joint resolution in the Senate sponsored by Sen. Benjamin Cardin (D-MD) and Sen. Lisa Murkowski (R-AK). HJ Resolution 17 is sponsored by Rep. Jackie Speier (D-CA) and 200 co-sponsors.

State Legislation: Because of Covid restrictions, visitors are not being allowed at the State House; but live streaming of the committee meeting can be followed. Information on each bill and updates on the hearings for each can be found at https://www.scstatehouse.gov/index.php Below are some Pre-filed Senate Bills that correspond to topics of GFWC and GFWC-SC interests.

#### Legislative:

**S 262** Joint resolution to ratify a proposed amendment to the Constitution of the USA providing rights will not be denied because of sex. (Reboot of the process for the ERA)

**S 254** requires post-election audit of all precincts before state certification.

#### **Education:**

**S 60** Establish wireless sites in underserved areas for more equitable education

**S 86** Establish and fund an Early Reading and Development Program in low economic areas and expand to all areas of the state by 2023-2024.

**S 322** Establish a teacher bill of rights establishing protection from frivolous lawsuits, guaranteed planning time, pay at the Southeastern Average

#### **Child Advocacy:**

- S 221 Extends foster care for eligible children until age 21 to aid in transition to adulthood and continue in higher ed.
- **S 222** Allows fictive kin (not blood kin but someone who has emotional bond with child) to serve as foster parent before licensing has taken place
- **S 441** Regulates placement children into qualified treatment facilities when necessary and regulates the facilities
- **S 229** Establishes a Child Advocacy Accreditation requirement for advocacy centers, sets up a network for state agencies for coordination of information and education.
- **S 243** Authorizes physicians to release information about patients who are victims of fatal or near fatal abuse.

#### **Domestic Violence and Trafficking:**

- **S 223** sets up a confidential address system for victims of domestic violence
- 5 224 increases the penalty for solicitation and establishes trafficking as a defense from prostitution for minors
- **S 230** establishes trafficking as a defense from prostitution for minors

**Hate Crimes\*** (proposed legislation says "because of his race, religion, color, sex, age, national origin, or sexual orientation"; I have used "hate crime" as a substitute to condense the verbiage)

- **S 88** establishes hate crimes as aggravating circumstances for crimes
- **S 171** adds hate crime penalty to malicious injury of person or property
- S 198 adds hate crime to conspiracy to violently interfere with a person's civil right

#### **ENVIRONMENT CSP – Darlene Rittel, GFWC-SC State Chair**

As spring approaches with recognition activities for Earth Day (April 22) and The Great American Clean-up campaign (Mar 23-June 20) we can certainly continue to address all four areas listed in the GFWC Environment CSP - 1) preserve resources; 2) protect animals, 3)live sustainably; and 4) beautify communities and nature.

During our virtual Winter Board Session, I encouraged all members to become more aware about FOOD WASTE and ways to reduce the amount of foods that are often needlessly thrown out. In our state, DHEC has a program called "Don't Waste Food SC." Some information about this program was sent to all club presidents last fall to share with club members. But for more details readers may go to www.scdhec.gov/dontwastefoodsc. Or call Adah Gorton at 1-803-898-1328; or Amanda Edwards at 1-803-898-0998. They are VERY helpful – might I say "A plus"? - and can provide much useful information (or perhaps even be a speaker [virtual?] at a club meeting)! The free "ambassador" program is an easy way to participate and can really make a difference in our state.

Meanwhile, here are some suggestions they give to help us all reduce food waste at home:

- 1. Plan ahead. Create meals based on what you already have at home. Then shop smart and buy ONLY what you need and STICK to it.
- 2. Prep and portion food as soon as you can when you get home form the store.
- 3. Cook ONLY what you will actually eat. Unless you love leftovers. Be creative with leftovers for new dishes or meals.
- 4. Store food correctly in fridges at 40 and freezers at 0 degrees F. Pull older foods towards front to use first.
- 5. Check and understand labels. "Sell by" and "Best by" are NOT EXPIRATION dates. Do a smell test to see if the item is still good to eat.

For Earth Day and Great American Cleanup, please check with your local waste control/recycling agencies for possible events and activities. Or join a volunteer group such as Adopt-a-Highway. Some clubs may be able to create or sponsor their own community clean up day or submit request to the mayor for a proclamation. Other ideas might be planting trees or butterfly gardens. Please do publicize your activities and keep track of your hours and dollars and number of volunteers for various reporting.

Of course, the GFWC manual as well as the Internet provide a wealth of information about our environment. Google a few sites to learn more about the impressive history and scope of Earth Day, Keep America Beautiful, Great American Cleanup, Project Learning Tree, or Palmetto Pride SC. In addition to increasing member awareness of the issues, these entities also provide suggestions that can be implemented in small or large ways. For example, club members could call the Palmetto Pride Litter Hotline at877-754-8837 to report litterbugs. Keep the number handy in car or phone or use the app and follow easy guidelines, all very private and anonymous. Then members could tell at each club meeting the number of calls made during the month. What a difference if all GFWC-SC members reported even one litterbug per month! This would send a message to the litterbugs as well as provide additional data that might show a need for better legislation or enforcement resources. And it is free; can be done from the car (when safe to do so); and takes just a few minutes of time.

## PROPOSED AMENDMENTS TO THE GFWC- SC CONSTITUTION & BYLAWS April 24, 2021

ARTICLE I – MEMBERSHIP Section 10

#### **CURRENT WORDING:**

Section 10. All applications for membership shall be acted upon by the Membership Committee. This committee shall consist of the GFWC-SC First Vice President, the GFWC-SC Treasurer, the District Presidents, the District Vice Presidents, and the District Secretary-Treasurers. A club applying for membership shall be notified of its acceptance by the Chairman of the Membership Committee (who is also the GFWC-SC First Vice President).

#### PROPOSED WORDING:

Section 10. All applications for membership shall be acted upon by the Membership Committee. This committee shall consist of the GFWC-SC First Vice President, the GFWC-SC Treasurer, the District Presidents, the District Vice Presidents, and the District Secretary-Treasurers. The GFWC Advancement Area Membership Chairman, if not the First Vice President, may also be a member of the GFWC-SC Membership Committee. A club applying for membership shall be notified of its acceptance by the Chairman of the Membership Committee (who is also the GFWC-SC First Vice President).

Rationale: To add the GFWC Advancement Area Membership Chairman, if different from the First Vice President, to the Membership Committee

ARTICLE V - DUES AND FINANCE Section 3

#### **CURRENT WORDING:**

Section 3. Convention Registration Fee. There shall be an advance registration fee of fifteen dollars (\$15) and a non-advance registration fee of twenty dollars (\$20) for each clubwoman and visitor attending the annual Convention, said fee to go into the General Fund, designated as the Annual Convention Restricted Fund. Registration fees shall be non-refundable. The Executive Committee shall annually set the deadline for receipt of advance registrations which will be specified in the Call to Convention.

#### **PROPOSED WORDING:**

Section 3. Convention Registration Fee. There shall be an advance registration fee of **twenty dollars** (\$20) and a non-advance registration fee of twenty five dollars (\$25) for each clubwoman and visitor attending the annual Convention, said fee to go into the General Fund, designated as the Annual Convention Restricted Fund. Registration fees shall be non-refundable. The Executive Committee shall annually set the deadline for receipt of advance registrations which will be specified in the Call to Convention.

Rationale: Due to rising costs of Convention.

## ARTICLE VI – FUNDS Section 9

#### **CURRENT WORDING:**

Section 4. The funds of the Progress Foundation shall be kept in a separate account called the GFWC-SC Progress Foundation, and all investments of Progress Foundation funds shall be made in its name. The securities and interest shall be held by the Treasurer of Progress Foundation. Except for willful misconduct or negligence the trustees shall not be responsible for losses of trust funds.

#### PROPOSED WORDING

Section 9. The funds of the Progress Foundation shall be kept in a separate account called the GFWC SC Progress Foundation, S.C.F.W.C. Progress Foundation and all investments of Progress Foundation funds shall be made in its name. The securities and interest shall be held by the Treasurer of Progress Foundation. Except for willful misconduct or negligence the trustees shall not be held responsible for losses of trust funds.

Rationale: To reflect in the Bylaws the proper name of this fund. This section becomes 9 and the other sections move up.

ARTICLE VII - OFFICERS, EXECUTIVE COMMITTEE, BOARD OF DIRECTORS, PROGRAM COUNCIL, AND BOARDS OF TRUSTEES
Section 4

#### **CURRENT WORDING:**

Section 4. The Program Council. The work of the Federation shall be further carried on by a Program Council. The Program Council shall be composed of the Dean of the Community Service Programs, the District Presidents, the Chairmen of the two GFWC Special Programs, the six GFWC Advancement Areas, and the Chairmen of the six GFWC Community Service Programs; the appointed Junior Community Service Program Chairmen, if any, and the Special Projects Chairmen. The duties of the Council shall be to plan and coordinate the programs of the Federation in compliance with the objectives set forth by the Board of Directors and to provide materials for the use of member clubs. The Program Council shall approve all awards relating to programs, and then submit recommendations to the Board of Directors. The Board of Directors shall meet immediately after the Program Council meeting to approve any recommendations.

#### **PROPOSED WORDING**:

Section 4. The Program Council. The work of the Federation shall be further carried on by a Program Council. The Program Council shall be composed of the Dean of the Community Service Programs, the District Presidents, the Chairmen of the two GFWC Special Programs, the six GFWC Advancement Areas, and the Chairmen of the six GFWC Community Service Programs; the appointed Junior Community Service Program Chairmen, if any, and the Special Projects Chairmen. The duties of the Council shall be to plan and coordinate the programs of the Federation in compliance with the objectives set forth by the Board of Directors and to provide materials for the use of member clubs. The Program Council shall approve all awards relating to programs, and then submit recommendations to the Board of Directors. The Board of Directors shall meet immediately after the Program Council meeting to approve any recommendations.

All Program Council recommendations shall be approved by the Board of Directors at its

next scheduled meeting.

Rationale: This article is referring to the Program Council and the appropriate time to present recommendations to the Board of Directors, which must take place before the Summer Board Meeting. Any responsibility of the Board of Directors would usually fall under the article relating to the Board of Directors' duties. Although the Program Council usually meets the evening prior to the Board of Directors, due to timing, it allows some flexibility in scheduling the meeting time, particularly if via a virtual meeting.

ARTICLE IX - DUTIES OF THE EXECUTIVE COMMITTEE, BOARD OF DIRECTORS, AND BOARDS OF TRUSTEES Section 5.

#### **CURRENT WORDING:**

Section 5. The members of the Board of Trustees of the GFWC-SC S.C.F.W.C. Progress Foundation shall be governed by the terms of the Trust Agreement. They shall handle all funds and property of the Foundation only in accordance with the provisions as set forth in Section Seven of the Trust Agreement.

#### **PROPOSED WORDING:**

Section 5. The members of the Board of Trustees **for** the **GFWC-SC S.C.F.W.C.** Progress Foundation shall be governed by the terms of the Trust Agreement. They shall handle all funds and property of the Foundation only in accordance with the provisions as set forth in Section Seven of the Trust Agreement.

Rationale: To list the proper name of this fund.

## ARTICLE XI - NOMINATIONS, ELECTIONS, AND VACANCIES Section 1. Paragraph 1. Nominations (Paragraph 1)

#### **CURRENT WORDING:**

Section 1. Nominations. All officers, with the exception of District Presidents, shall be elected biennially in even numbered years. To be eligible for office, a candidate (1) must be an active member in good standing of a club in direct membership; (2) has been a GFWC-SC member for three or more years; (3) has served as either a club president, District President, or GFWC-SC Chairman; (4) is a legal resident of South Carolina. The Elections Committee shall meet in January and shall have ready a complete list of nominees

for the office of President, First Vice President, Second Vice President, Secretary, Treasurer, Director of Junior Clubs, Director-elect of Junior Clubs, three District Presidents, and other various offices to be filled, to be made a part of the Call to Convention. The nominees for District Presidents shall have been selected and approved by their respective Districts at the previous District Conference. The Committee shall have a list to present to Convention for election. The Special Assistant to the President shall be appointed by the President with whom she shall serve, and shall be installed at the same time as other officers.

Additional nominations may be made from the floor, provided the consent of the nominee has been secured. If there is only one candidate for each office the election may be made by acclamation. A majority of the votes cast shall constitute an election.

shall elect a Chairman from among the members. This representative and one alternate from each district shall be elected in the odd number of calendar years at their respective District Conferences prior to Convention and shall serve for one term. No state officer shall be eligible.

If an elected member or her alternate is unable to attend a meeting, the District President shall appoint someone to represent the District on the Committee.

#### **PROPOSED WORDING:**

Section 1. Nominations. All officers, with the exception of District Presidents, shall be elected biennially in even numbered years. To be eligible for office, a candidate (1) must be an active member in good standing of a club in direct membership; (2) has been a GFWC-SC member for three or more years; (3) has served as either a club president, District President, or GFWC-SC Chairman; (4) is a legal resident of South Carolina. The Elections Committee shall meet in January and shall have ready a complete list of nominees The Elections Committee shall meet no later than January in the even-numbered years to prepare a complete list of **nominees** for the office of President, First Vice President, Second Vice President, Secretary, Treasurer, Director of Junior Clubs, Director-elect of Junior Clubs, three District Presidents, and other various offices to be filled, to be made a part of the Call to Convention. The nominees for District Presidents shall have been selected and approved by their respective Districts at the previous District Conference. The Committee shall have a list to present to Convention for election. The list of proposed nominees shall be submitted for publication in the call to Convention in the March issue of the Clubwoman Magazine. The Special Assistant to the President shall be appointed by the President with whom she shall serve, and shall be installed at the same time as other officers.

Rationale: Better clarity of the duties of the Elections Committee.

Article XI – Nominations, Elections, and Vacancies. Section 1. Paragraph 3. The Elections Committee

#### **CURRENT WORDING:**

The Elections Committee shall consist of one representative from each District and they shall elect a Chairman from among the members. This representative and one alternate from each district shall be elected in the odd number of calendar years at their respective District Conferences prior to Convention and shall serve for one term. No state officer shall be eligible. If an elected member or her alternate is unable to attend a meeting, the District President shall appoint someone to represent the District on the Committee.

#### **PROPOSED WORDING**:

The Elections Committee shall consist of <u>one representative and one alternate from each District and they shall elect a Chairman from among the representative members</u>. This representative and one alternate from each district shall be elected in the odd number of calendar years at their respective District Conferences prior to Convention and shall serve for one <u>two-year term</u>. No state officer shall be eligible. If

an elected member or her alternate is unable to attend a meeting, the District President shall appoint someone to represent the District on the Committee.

Rationale: Better clarity.

The Trustees so elected shall serve for a term of **two** years. each. Each year **At the beginning of each administration**, the Trustees shall elect a Chairman and a Secretary from the elected members. No Trustee may stand for re-election until two full years have elapsed since the close of her last term of service. Any vacancy shall be filled by the Executive Committee until the next annual District Conference at which time there is an election of a member for the unexpired term. If the unexpired term is less than one-half of the full term, the Trustee so elected may succeed herself.

Rationale: Three year terms with rotation may have lost their usefulness, since there are now a number of qualified members who could serve on this board, so the need for rotation may no longer be necessary. Also, two year terms (lined up with each administration) would be smoother to organize and fill the positions.

Section 6. The nine elected members of the Board of Trustees of the GFWC-SC S.C.F.W.C. The Trustees so elected shall serve for a term of three years each. A Trustee shall not be eligible for re-election until two full years have elapsed since the close of her last term. Any service exceeding one and one-half years shall be considered a term. In the event of a vacancy occurring in the Board of Trustees of the GFWC-SC Progress Foundation between Conventions, the Trustees shall elect a Trustee to serve until the next District Conference. The Trustees shall elect from themselves each two years for a two-year term a Chairman, a Secretary, and a Treasurer.

#### **PROPOSED WORDING:**

Section 6. The nine elected members of the Board of Trustees of the GFWC-SC S.C.F.W.C. Progress Foundation shall be nominated and elected at their District Conference and their names submitted to the Convention for affirmation. The Trustees so elected shall serve for a term of three years each. A Trustee shall not be eligible for re-election until two full years have elapsed since the close of her last term. Any service exceeding one and one-half years shall be considered a term. In the event of a vacancy occurring in the Board

of Trustees of the GFWC-SC Progress Foundation between Conventions, the Trustees shall elect a Trustee to serve until the next District Conference. The Trustees shall elect from themselves each two years for a two-year term a Chairman, a Secretary, and a Treasurer.

Rationale: To reflect in the Bylaws the proper name of this fund.

Article XI – Nominations, Elections, and Vacancies Section 7. The Nine elected members...

#### **CURRENT WORDING:**

Section 7. The nine elected members of the Board of Trustees of the GFWC-SC Scholarship Fund shall be nominated and elected at their District Conference and their names submitted to the Convention for affirmation. Trustees shall be elected for a three-year term. The trustees shall elect every two years a chairman to serve for two years. No trustee may stand for re-election until two full years have elapsed since the close of her last term of service. Any vacancy occurring shall be filled by the Executive Committee until the next District Conference at which time there is election of a member for the unexpired term. If the term is less than one half of the full term, the Trustee so elected may succeed herself.

#### **PROPOSED WORDING**:

Section 7. The nine elected members of the Board of Trustees of the GFWC-SC Scholarship Fund shall be nominated and elected at their District Conference and their names submitted to the Convention for affirmation. Trustees shall be elected for a <u>two</u>-year term. <u>At the beginning of each administration</u>, the trustees shall elect a chairman from the elected members. No trustee may stand for re-election until two full years have elapsed since the close of her last term of service. Any vacancy occurring shall be filled by the Executive Committee until the next District Conference at which time there is election of a member for the unexpired term. If the term is less than one half of the full term, the Trustee so elected may succeed herself.

Rationale: Three year terms with rotation may have lost their usefulness, since there are now a number of qualified members who could serve on this board, so the need for rotation may no longer be necessary. Also, two year terms (lined up with each administration) would be smoother to organize and fill the positions.

## **ARTICLE XII- COMMUNITY SERVICE PROGRAMS AND COMMITTEES**Section 1

#### **CURRENT WORDING:**

Section 1. Community Service Programs, and Special Committees shall be established by the Executive Committee of GFWC-SC in conformity with those of the General Federation of Women's Clubs. Additional Community Service Programs and Committees may be established if deemed necessary to implement the program of GFWC-SC.

Section 3. Special Committee Chairmen shall be appointed by the President.

Section 4. A vacancy in any Community Service Program or Special Committee shall be filled by an appointee of the President.

#### PROPOSED WORDING:

Section 1. Community Service Programs, <u>Advancement Area Committees</u>, and Special Committees shall be established by the Executive Committee of GFWC-SC in conformity with those of the General Federation of Women's Clubs. Additional Community Service Programs and Committees may be established if deemed necessary to implement the program of GFWC-SC.

Section 3. <u>Advancement Area Committee Chairmen</u> and Special Committee Chairmen shall be appointed by the President.

Section 4. A vacancy in any Community Service Program. <u>Advancement Area</u> <u>Committee</u>, or Special Committee shall be filled by an appointee of the President.

Rationale: To list the Advancement Area Committees category in the Bylaws.
