Back in the spring of 2020, we were faced with conducting our club business in different and innovative ways. We all scrambled, learned modern technology, and made it work! Now that we have worked thru this, have you thought about your bylaws and how to make sure they reflect how your club will operate in the event of another emergency or disaster?

First, check out your bylaws...do they include any governance regarding how your club will function if an emergency is declared like 2020? GFWC will be voting at our convention in Atlanta on a bylaw amendment to add new articles to outline their process. Your club should consider doing the same thing.

Some points to consider and include are:

- Who decides meetings should be held remotely?
- What online platform will be used?
- What procedures regarding questions, making motions, etc. will be implemented for remote meetings?
- How will elections and votes be conducted?

If you take the time now to document these procedures in your bylaws, your club will be better prepared for the future.

GFWC-SC Ladies! I hope you're doing well. With Summer Board coming to a close and District meetings and Southern Region on the horizon please remember that we cannot forget to enroll with the Secretary of State of SC and do our taxes!

Below are some dates and websites to help you complete these tasks.

GFWC-SC Annual Dues: Annual dues shall be paid to GFWC-SC Treasurer on or before the first day of November. Clubs must pay their dues by Nov 1st in order to earn points on the rating sheet and to be eligible to apply for a grant from GFWC-SC Progress Foundation. IRS Tax or Informational Return Filing. You are required to file an annual return of your income and expenses with the IRS. Small tax-exempt organizations with gross receipts \leq \$50,000 can file an electronic notice. The 990-N or E-Postcard filing is due every year by the 15th day of the 5th month after close of your tax year.


Legislative and Public Policy Advancement Area, Janet Watkins

The 124th Legislative Session has passed legislation SC Child Abuse Protocol Act related to standardizing and accrediting Child Advocacy Centers. They passed legislation to reinstate the step increases in pay for teachers that was suspended during Covid, and passed a requirement to have a suicide hotline phone number printed on the back of student ID badges.



Suggested Actions for Clubs/Members: (Club Presidents- There is much more detail on the following in your Club Manual that can be accessed from the GFWC website member portal.)

- 1. Sign up and use the Legislative Action Center link on the GFWC website. This is a national goal to increase the number of members signed up. SC has 1115 federation members but only 209 have registered, which is 19%. Let's make it a goal to have at least 50% by the end of 2021. Funding for the Violence Against Women Act has not been approved yet and losing the funding could have serious impact on our women's shelters.
- 2. Clubs should report any actions they take related to Legislative and Public Issues and submit the reports. The participation this past year was very low.
- 3. Follow your Representatives/Senators and legislation at www.scstatehouse.gov
- 4. Invite your Representative/Senator to speak at a meeting and let them know what issues are important to you and what work your club and state organization does.
- 5. Look up your Representative/Senators contact information and give it out to the members of your club. Encourage them to contact the official.
- 6. Hold a post card campaign for a specific issue.
- 7. Ask a local or state official to make a proclamation to recognize a specific awareness day, etc.
- 8. Educate the club about GFWC's Advocacy Efforts.
- 9. Educate members on the legislative process and how to advocate.
- 10. Educate members on the issues.
- 11. Help members take action.
- 12. The Hughes Legislation Award will be given for the most creative project in Legislative and Public Policy Advancement area.





Our Inspiring Code Girl, Sara Stringfellow

Code Girls is a New York Times Best Selling book about the untold story of the American Women Code Breakers of World War II. The author, Liza Mindy, brings us a history of our country that would have been lost without this book which required heroic archivists to dig deeply. Code Girls were recruited from small Southern towns and posh New England colleges to serve the U.S. Army (WAC) and Navy (WAVES) as code breakers during World War II. Over 10,000 American women moved to Washington, D.C. (Arlington, Virginia) to learn the meticulous work of breaking Japanese and German military codes. Their code breaking skills shortened the war,

saved countless lives, caused battles to be won, and gave the women access to careers previously denied to them. In 2017 after this book was published, some of these women were honored by The Library of Congress and appeared on a NBC television program.

Why have you not heard about these code girls? They were under a strict vow of secrecy. The women could have faced time in prison and/ or pay a large fine if they had been caught talking about their project, so they never told anyone. They also believed, "Loose lips sink ships". The project was so secretive that records were not kept of classes taught of who took the classes.

Our Sara Stringfellow, who has been a member of the Woman's Club of Rock Hill since 1988, was one of these remarkable code girls. In May 2020, a graduate student seeking a Master of Arts in History at Winthrop University wrote about Sara in her thesis. Winthrop is where Sara attended college. There were classes on code breaking. Sara was accepted in the program and went to Arlington after graduation.

Sara even met General Dwight Eisenhower. One day as she was working, he stopped by her table and asked her how she liked her job. "I love it. I really love it," she replied. The General who later became President told her what a great job she was doing.

Although Sara is 99 years of age, she is very active in our Club. She helped paint our Little Free Library with her granddaughter, an art major at Winthrop. She bought benches for the reading area and grounds and arranged to have them delivered. She created one of our biggest fundraisers in the past, the Bridal Fair. Sara is very active in the Education and Libraries CSP and helps to shape our program with her suggestions. She served on the Historic Preservation Committee and is active in Junta Literary Society. To her surprise, our Little Free Library was named in her honor, Sara Stringfellow's Book Nook. Sara is the mother of four, a former librarian and teacher, and drives her convertible around town for her many activities. Code **Girls are exceptional people.**

ESO: Read All About It

Our GFWC-SC ESO Book Club—The Girlfriends Book Club—is now at 28 members, representing 8 clubs in our state. Through your membership (which is only \$2) you can read books as a group or on your own, and select the books from our state list or GFWC's list. To

become a member you just have to complete the application and pledge form that is found at our website. You will become a full member after you have read 16 books (from either reading list) and completed a very brief book report – we just want to know what you read and if you would recommend it – super easy. The more you read the higher the level in ESO you will go! If you are interested in either reading list, just send me an email (jcasper@rclawonline.com) and I will get you a copy.

You can find the GFWC 2020-2022 ESO Book Club on Facebook. Each month a book is selected for members to read, and on Tuesday each month members post thoughts about the book. There have been some great books this summer: The Charmed Wife by Olga Grushin (June), The Book Woman of Troublesome Creek by Kim Michele Richardson (July), and The Break-up Book Club by Wendy Wax (August).

On the state level, I would like to suggest that members this fall consider reading Code Girls: The Untold Story of the American Women Code Breakers of World War II by Liz Mundy. This book would fall under the ESO category Women's Studies. The code girls were women secretly recruited and trained to become code breakers for the U.S. Army and Navy. The women worked in centers in D.C. and provided valuable intelligence to the troops fighting in Europe and the Pacific. The author interviewed surviving code girls, in addition to extensive archival research. There are other great books that touch on the similar themes found in Code Girls. Check out Lilac Girls by Martha Hall Kelly, The Nightingale by Kristin Hannah, The Bletchley Girls, by Tessa Dunlop, and The Rose Code by Kate Quinn.

The legal name of the foundation is South Carolina Federation of Women's Clubs Progress Foundation. Our Federation did not change its name to G.F.W.C-SC until late in the 1990's from S.C.F.W.C. Progress Foundation is a private foundation and is registered as such with the Internal Revenue Ser- vice and tax ID is S.C.F.W.C. Progress Foundation I hope this will clarify the difference in the name. When you acknowledge the receipt of your grant you may say S.C.F.W.C. aka GFWC-SC. The funds are coming from investments in the account S.C.F.W.C. Progress Foundation. The CPA, that does the tax return, is required to send the name and address of each club receiving funds and occasionally one or two of the acknowledgements from a club receiving grant funds.

*One other item that clubs are not addressing is the final report on the grant that the club received. Omission of this can result in your club not being eligible for a grant the following year. Don't confuse this with the acknowledgement letter you write when you receive your check this is item #10 on the application and is due to the treasurer by July 15th which summarizes the project and should include documentation like, pictures, letters from the recipient and/or publicity. Progress Foundation needs to be able to justify that the grant funds were used for what was applied for.
