Remembering Elise Cain, Past President of GFWC-SC 1990-1992

Elise Cain passed away February 5, 2010. She was born and raised in Dillon, SC. After receiving an education degree, she taught math and science in the middle school in Dillon. Elise was one of the founders of Avalon Academy, a private school in Dillon and served as a Board Member for over 35 years; she was a member of the SC Medical Association Auxiliary for Women; a member of the Board of Friends of Francis Marion College; a member of the Dillon Business and Professional Women's Club and was a member of GFWC Avon Study Club. One of her greatest accomplishments was being involved in the initial legislation of the Guardian ad Litem Program. Elise was a

member of Main Street United Methodist Church in Dillon where she served as President of the Methodist Women, a Sunday School teacher and on the Board of Trustees of the United Methodist Center of South Carolina. She was predeceased by her husbands, Walter Ewing Belk and Dr. Rufus H. Cain, Jr. She leaves behind five children, nineteen grandchildren and nine great-grandchildren.

Elise will be remembered for her volunteer service, not only in Dillon but throughout South Carolina as she led the 1990-1992 GFWC-SC theme of "Remembering the Past-Focusing on the Future" and also as a soft spoken, southern lady.

In both 2007 and 2008 she received the First Place Junior Director's award in South Carolina's category at GFWC's International Convention. Since June 2008 Linda has served as the GFWC-SC Treasurer.

During her membership with CJWC, Linda assisted the club with many projects benefiting the Florence Crittendon Home, Habitat for Humanity - Woman Build Program, Keep America Beautiful, Operation Smile and Operation Christmas Child.

With CFWC she assisted in organizing the annual Fine Arts Tea reception for high school students and their families whose artwork was submitted for the First Federal of Charleston Annual Scholarship Contest. On the Southern District Level, Linda has served as a member of the District Nominating Committee. At the State level, she represented GFWC-SC at the 2004 International Convention in Orlando, Florida as the GFWC-SC LEADS candidate and assumed the role of Junior Director in 2005.

In 2002, Jo Ann was selected as Woman of the Year, Charleston Federation of Women's Clubs and was one of fifteen women in a feature article on "Women of Charleston Making A Difference in Non-Traditional Workplace Roles". She is a recipient of an outstanding student service award of the Charleston Higher Education Consortium and was honored by the Medical University of South Carolina with a bronzed plaque placed in the Harper Student Center recognizing her greater than 30 years of service to her colleagues and the students upon her retirement December, 2006.

South Carolina Federation of Women's Clubs Progress Foundation

The Club members of General Federation of Women's Club are indebted to those who have gone before us for their wisdom and foresight in establishing South Carolina Federation of Women's Clubs Progress Foundation. The Foundation was created as a charitable organization and holds a 501 C (3) tax status. This status was held as follows long before GFWC-SC held this status. In 1978 during my term as President, the IRS ruled that SCFWC Board did not have to approve the grants made by Progress Foundation.

The Executive Committee of South Carolina Federation of Women's Club on August 31, 1951 created a fund called "The South Carolina Federation of Women's Club Progress Foundation." This fund shall be and operate as a trust under South Carolina laws and only for the purposes and under the terms and conditions provided: 1. This Foundation is established and organized and shall operate exclusively for charitable, educational, literary and scientific purposes, and for the prevention of cruelty to children, all exclusively, within the State of South Carolina (said confinement to the State of South Carolina to be in effect only so long as Section 2440 (1) Laws of South Carolina (1946) {Legislative Supplement} remains in statutory effect, but in any event shall be limited to the United States of America or its possessions). Among such purposes, but not completely inclusive there of are: 1) Promotion of Libraries, 2) Family Counseling, 3) Maternity care, 4) Health Education and Child Welfare, 5) Promotion of scout troops, parks, play grounds, swimming pools, teenage canteens, 6) Education and rehabilitation of juvenile delinquents, 7) Assistance to feeble-minded and hard of hearing children, 8) Education of needy girls, 9) Aid to Cancer control, 10) Aid in tuberculosis control, 11) Aid to crippled children, 12) Education in mental hygiene, and 13) Education in the field of international relations.

2. No part of the net earnings of property of the Foundation shall inure to the benefit of any private shareholder or individual. 3. No substantial part of the activities of this Foundation shall be that of carrying on propaganda, or otherwise attempting to influence legislation. 4. Refers to the terms of office. 5. This Foundation shall continue in existence until terminated by proper official act of South Carolina Federation of Women's Clubs, Inc., or by operation of law. Upon Termination of this Foundation all of the property of the Foundation of whatsoever type and what- soever situate, shall be conveyed and distributed in equal shares to the tax supported county libraries in South Carolina, and if none are in existence at such time, then said property of the Foundation shall be conveyed to the State of South Carolina for use of the bother property and funds of the S.C. State Industrial Schools [Penal] in equal shares to each school. 6. This Foundation shall keep its property and funds separate and apart from the funds and property of any other person, corporation or other entity

I, Janet Agnew, have tried to give you a little background on SCFWC Progress Foundation. The above statements were taken from the 1978-1980 SCFWC Handbook printed by the 1978-1980 Administration. If you would like further information, I, Janet Agnew, will be glad to make you a copy of this entire section of the Handbook. It also includes a list of donors to the Foundation.

Thirty Clubs requested Grants from SCFWC Progress Foundation in the amount of over twenty-two thousand (\$22,000) dollars. The Committee found one of the clubs had not paid their dues on time and another club had not submitted a thank you note for the money received in a previous year. The Trustees of SCFWC Progress Foundation were proud to award Grant for the following projects of GFWC-SC members: 1) Approximately one hundred four scholarships for students to attend technical schools, colleges, universities, and other training schools were provided; 2) Six libraries were helped with books and other materials; 3) A homeless shelter was helped to provide heat and air condition for their clients; 4) Three historical land marks were provided with grants to meet federal requirements for the physically challenged and to restore the area in a cemetery; Needy and physically challenged children were provided with gowns in which to graduate high school and gifts of clothing, school supplies, and other necessities. The eighteen thousand (\$18,000) dollars SCFWC Progress Foundation had to distribute was stretched to provide for as many projects qualifying under the Federal guidelines for this Foundation. The amounts of the Grants requested ranged from seventy-five dollars to two thousand four hundred dollars. Some clubs could not be awarded the total amounts requested as there was not enough money to fulfill all requested monies. The following Clubs were Awards Grants: Aiken Woman's Club, Belvedere Woman's Club, Chapin Woman's Club, Charleston Federation of Women's Clubs, Easley Junior Woman's Club, GFWC Jubilee Club, GFWC-SC Sax Gotha Club, Junior Woman's Club of Columbia, Junior Woman's Club of Lexington, Junior Woman's Club of Rock Hill, Lake Murray Irmo Woman's Club, Lexington Woman's Club, Monetta Woman's Club, North Myrtle Beach Woman's Club, Palmetto Woman's Club, Sandy River Woman's Club, St. Andrews Woman's Club, Wagner Woman's Club, Walhalla Junior Woman's Club, Walhalla Woman's Club, Woman's Club of Fort Mill, Woman's Society of Batesburg/Leesville, Woman's Club of Cayce, Woman's Club of Midlands, Woman's Study Club of Ridge Springs, and Woman's Club of West Columbia.


