GFWC-SC Director of Junior Clubs Michele Hood

I had a wonderful time with everyone in Greenville at Convention. It was good to see familiar faces and meet new people also.

Wow!!! What a year 2010 was for South Carolina. Our 10 junior clubs were very busy in 2010. We did 394 projects, donated 22,227 hours, and raised \$212,217.00 with 2757 members participating. There was a wide spectrum of people and agencies that we helped in our communities.



In the Arts Programs, we donated art supplies to schools and shelters. We made Valentine's Day Cards for troops overseas. One club has a monthly craft night at a local women's and children's shelter to make all kinds of different crafts with the children and women. There were clubs that donated time and money to their local theaters and went to shows as a group. There were clubs that also donated watches to the American Mural Project.

In the Conservation programs, most clubs went to a paperless meeting and used email to correspond about upcoming events within their clubs. There were a number of clubs that planted plants and flowers at local shelters. One club started a recycling contest to see who could recycle the most in a year. A few clubs addressed on numerous occasions the importance of using canvas bags to shop, including grocery shopping. Two clubs participated in Adopt-A-Highway program and picked up trash on the highway once each quarter. One club volunteered at the local aquarium. One club collected "Pennies for Pines" which goes to forest preservation and reforestation of forests.

In the Education Programs, our clubs collected and donated school supplies for local schools and we volunteered our time and money to schools and after school programs in our communities. Some clubs also went to schools and libraries and read books to children. One club also held a book fair. Another club raised \$500 for a scholarship for a student going to college. A few clubs collected and donated books for schools and shelters.

In the Home Life Programs, South Carolina Juniors were very busy. We donated time and money to several shelters, for women, children, men, and animals. Clothing was collected for a women's and children's shelter and dropped off for them. One club had a meeting that information was given on couponing. One club participated numerous times in their local Meals on Wheels program by boxing up meals and helping deliver them to the clients. Toiletries and other supplies were collected and donated to several shelters. One club had a seminar on Breast Cancer Awareness. Another club volunteered at a Medical clinic held in their community. Several clubs volunteered at local animal shelters, including one club helping out a Feline rescue. All clubs raised money, donated items, or volunteered at local hospitals or causes in the community.

In the International Outreach Programs, we donated money to many different groups, including the United Nations to fight malaria, to Operation Smile, and UNICEF. Money was also donated to missionaries in Sudan. One club collected and donated soccer uniforms to Kenya. One club sponsored a child in Guatemala.

In the Public Issues Programs, South Carolina junior clubs had meetings focused on voting. There were a few clubs that had members contact their local legislators regarding issues being debated in the State House. One club rang bells for the Salvation Army at Christmas time. One club had a meeting about Food Safety and food recalls. Another club volunteered at their local Historic Preservation Society.

I am so proud of all the work ya'll have done. Please keep it up!!!!

Minutes from the 113th General Federation of Women's Clubs of SC Convention

April 29-30, 2011 Greenville, South Carolina

The 113th Annual Convention for the General Federation of Women's Clubs of South Carolina was held April 29 - 30, 2011, at the Embassy Suites Hotel in Greenville, South Carolina. President Laurie O'Kelly called the meeting to order at 11:30 a.m. Invocation was given by Jolene Bryant, GFWC-SC Chaplain. The Easley High School National Junior ROTC presented the colors. National Anthem was sung by Clarka Wickliffe, Miss Clemson 2011. Pledge of Allegiance was led by Joan Musselwhite, GFWC York County Woman's Club. The South Carolina Pledge was led by Norma England, Woman's Club of Rock Hill. "Collect for Clubwomen" was led by Karen Kaylor, North Central District President. National Pledge of Junior Clubwomen was led by Michele Hood, GFWC-SC Director of Junior Clubs. Tammy Garland, GFWC-SC Advisor, offered grace and a wonderful "Royal Garden Party" theme luncheon was served. Due to an unforeseen delay, Terri Wilfong, Chief of Police, Greenville City Police Department, issued the official Welcome to Greenville during lunch.

Marian St. Clair, GFWC-SC Parliamentarian, introduced our Guest Speaker, Meta Armstrong of the Greenville Garden Club. Ms. Armstrong demonstrated floral arrangements for your home.

At the conclusion of lunch, Karen Kaylor, North Central District President, announced the "Best Hat" Awards. A winner from each table was announced and they received the table centerpieces as their gifts.

President Laurie O'Kelly reconvened the convention at 1:00 p.m. Trudie Heemsoth, Woman's Club of Fort Mill, introduced the GFWC-SC Past Presidents and GFWC-SC Executive Committee. Sheila Shea, GFWC Second Vice President brought greetings from GFWC. She provided a snapshot from international and encouraged everyone to share what they learn with their club members.

Elizabeth Herring, Credentials Committee Chairman, presented the preliminary credentials report which showed a voting strength of 82, non-voting of 19, 5 guests, for a total attending 106. Marian St. Clair, Parliamentarian, presented the Rules and Procedures and they were adopted as presented. The convention program was presented by Kaye Jones with corrections noted and the convention voted to accept it as the official program of the convention.

JoAnn Bolchoz, GFWC-SC First Vice President and Membership Chairman, recognized first time attendees to the convention and presented Honor Club and Net Gain Club ribbons. Jo Ann Bolchoz, GFWC-SC First Vice President, and Linda Rodgers, GFWC-SC Treasurer, presided over the presentation of Rating Sheet and Contribution Sheet Silver Awards and Certificates. Jackie Boland, Communication and Identity Chairman, presented the Communication and Identify Awards; Nina Chitty, Fundraising Chairman, presented the Fundraising Award; Caroline Mahaffey, GFWC-SC Second Vice President, presented the Leadership Awards; Jo Ann Bolchoz, GFWC-SC First Vice President and Membership Chairman, presented the Membership Awards; and Julia Hoyle, Public Policy and Legislation Chairman presented the Public Policy and Legislation Award. Sally Killough, WHRC Chairman presented the Women's History and Resource Center Awards. Gail Elfert presented the "Girlfriends Who Care" Awards for Cathy Dixon, President's Special Project Chairman. The Community Service Program Awards were presented by: Susie Childress, Chairman, Education Collaboration; Pat Estep, Chairman, Education Partnership; Gail Elfert, Chairman, Home Life Collaboration; Lynn Cleckler, Chairman Home Life Partnership. Having no further announcements, the convention recessed at 2:30 p.m. until the "Wear One/Share One" Pajama Party & Junior Auction at 7:00 p.m.

The convention resumed at 7:00 p.m. ShirLee Alfors offered grace. The Junior Auction "It's In The Bag" was held through-out the evening as entertainment. Following dinner, awards and certificates were given for the Community Service Programs – Arts and Community Service Programs - Conservation. Jo Ann Bolchoz, GFWC-SC First Vice President, announced the GFWC-SC Juniorette of the Year. The GFWC Signature Project: Domestic Violence Awareness & Prevention award was presented by Misty Konow, Chairman and the GFWC Juniors' Special Project: Advocates for Children, was presented by Caroline Mahaffey. Convention was recessed until the business session on Saturday, April 30, 2011.

President Laurie O'Kelly reconvened the convention at 9:00 a.m. on Saturday, April 30, 2011. Jolene Bryant, GFWC-SC Chaplain provided inspiration. Melanie Branham, Northwestern District President introduced the GFWC-SC Past Presidents, members serving GFWC and the GFWC-SC Executive Committee. Reports from Standing Committees were given. Bobbie Sox, Chairman of the Constitution and Bylaws Committee, moved the adoption of the proposed amendment to Article VII of the Constitution and Articles VI, VIII and XIII of the Bylaws (attached). The motion was approved. Princa Wright, Chairman of the Headquarters Committee, announced that the next work day would be May 14, 2011, and that the advanced loan (made to the Headquarters Committee in April 2004) had been repaid in full to the GFWC-SC General Fund. Jan Hadwin presented the headquarters budget and it was adopted as presented. Kristin Fields, Chairman Budget & Finance, presented the 2011-2012 General Fund Budget. The 2011-2012 Budget was approved and adopted as presented. Reports from the GFWC-SC Officers' were given. GFWC-SC Director of Junior Clubs Michele Hood, GFWC-SC Treasurer Linda Rodgers, GFWC-SC Recording Secretary, Janet Prince, GFWC-SC Second Vice President Caroline Mahaffey, GFWC-SC First Vice President, Jo Ann Bolchoz and GFWC-SC President Laurie O'Kelly.

The report from the GFWC-SC Executive Committee was given by GFWC-SC Recording Secretary Janet Prince. Reports from Boards of Trustees were given. Pat Estep, Chairman of the Trustees of GFWC-SC Endowment Fund; Janet Agnew, Chairman of the Trustees of Progress Foundation and Misty Konow, Chairman of the Trustees of GFWC-SC Scholarship. ShirLee Alfors, Chairman of the Community improvement Program, gave an update on the award to be presented at the 2012 GFWC-SC Convention.

In accordance with GFWC-SC Bylaws, at 11:00 a.m. elections were held. Elizabeth Herring, Chairman of the Credentials Committee gave the credentials report indicating a voting strength of 83. GFWC-SC Recording Secretary Janet Prince read the Rules of Elections. Jackie Boland, Elections Committee, presented the Confirmation of District Elections, and moved the affirmation of the report (attached). The motion passed. GFWC-SC Recording Secretary Janet Prince reported the recommendation from the GFWC-SC Board of Directors to endorse Jackie Boland for the office of GFWC Southern Region Vice President. The letter of endorsement from her club, The Woman's Club of the Midlands, was read to the convention. IMPORTANT NOTICE FOR ALL CLUBS – TAX FILING REQUIREMENTS

The Internal Revenue Service (IRS) has recently placed more emphasis on its requirement that non-profit organizations must file a return with the IRS each year. For annual tax periods beginning after 2006, the law requires most tax-exempt organizations, other than churches, to file an annual Form 990, 990-EZ, or 990-PF with the IRS, or to submit a Form 990-N e-Postcard to the IRS. If an organization fails to file an annual return or submit a notice as required for three consecutive years, it will automatically lose its taxexempt status. That means, regardless of your club's size or income amount you will be required to complete one of the following for the IRS each year to ensure your club maintains tax-exempt status:

- 990 required for clubs who have a large dollar value of gross receipts and total assets
- 990 EZ required for clubs who have gross receipts above \$25,000 (above \$50,000 for fiscal years ended after December 31, 2010) but less than the threshold for filing form 990
- 990 N (ePostcard) required for small non-profit organizations with less than \$25,000 in gross receipts for fiscal years ending prior to December 31, 2010 and less than \$50,000 in gross receipts for fiscal years ending after December 31, 2010

990 PF - required for private foundations

Most clubs in GFWC-SC should be able to file the e-Postcard, which is due every year by the 15th day of the 5th month after the close of your tax year. For example, if your tax year ended on May 31, 2011, the e-Postcard is due October 15, 2011 and you cannot file the e-Postcard until after the end of the club's tax year. Additionally, most clubs probably have a fiscal year that is different from the calendar year and this information should be spelled out in the club by-laws.

For clubs with annual gross receipts that are normally greater than \$25,000 (or \$50,000 as noted above), those clubs will continue with regular filing (as described in the table below). Be sure to include all receipts for the club (dues, fundraising, contributions, meals, etc.) when calculating gross receipts. All funds of the club must be considered and included in the filing. The due dates for these returns are also on the 15th day of the 5th month following the close of the club's fiscal year. (The amount of gross receipts a club earns each year that would allow it to file a 990EZ have changed each year since 2008, see the table below for details.)

File Form 990-EZ for	If gross receipts are less than	And if total assets are less than
2008 (generally filed in 2009)	\$1,000,000	\$2,500,000
2009 (generally filed in 2010)	\$500,000	\$1,250,000
2010 and later	\$200,000	\$500,000

For clubs who are required to file a 990 or 990EZ, I would recommend consulting a tax professional, or a Certified Public Accountant for assistance with these filings.

As a reminder, the completion of the e-Postcard can only be filed online; there is no paper form so it cannot be mailed. If you have never filed the e-Postcard you will need to register as a new user and set up a login and password. The user name is the club's employer identification number (EIN) followed by a two digit identifier in sequential order (e.g. if you are the first person setting up a user name for your club, it will be the EIN followed by 01, if you are the second user, it will be the EIN followed by 02, and so on).

To file the e-Postcard, go to the IRS website at www.irs.gov; select "charities and non-profits"; then scroll down and select "annual electronic ---for small exempt organizations" or use the following link, which will take you directly to the 990N information page. http:// www.irs.gov/charities/article/0,,id=169250,00.html

From this page, there is a link under the section entitled "How To File". This link will take you to a third party site that is authorized by the IRS to file all 990-N e-Postcards.

To file the e-Postcard you will need the following:

- 1. Employer identification number *FOR YOUR CLUB* (not the GFWC-SC identification number)
- 2. Club's Tax year (fiscal year)
- 3. Legal name and mailing address of organization
- 4. Any other names the organization uses
- 5. Name and address of a principal officer

Once you have entered all of this information, you will just click the checkbox that states "annual gross receipts are normally \$25,000 or less"




Janet Ricard GEWC-SC Volunteer of the Year
