It is my information from Atty. James J. Ravelle, Jr. there is zero (0) risk of losing money by housing me as a result of the foregoing, and I believe Atty. Fred Rooney would know this, too. I respectfully plead for the soonest possible help moving in. The Fred B. Rooney BLDG is my first choice. I have also applied at Holy Family Apartments and Moravian House in Bethlehem, PA.
