Live-in Nurse Practitioner Wanted

We are seeking applicants for the position of professional live-in certified registered nurse practitioner. Specifically, we seek a reliable CRNP, personal chef and housekeeper rolled into one. This is a full-time contract employment position with the successful applicant (the "employee"). This position offers a great salary and a stable living and working arrangement.

The employee must pass a pre-employment background check¹, drug test, and have a valid United States driver's license and passport. As part of his² living and working arrangement with us, he must be willing to commit to living in our properties, including but not limited to in the Lehigh Valley, PA, Washington, DC, St. Petersburg, FL, New York, NY and in Zürich, Switzerland.

The employee will apply with a consistent work history and professional and personal references. He must be professional, competent, responsible, and accountable. The employee must have at least 25 years of combined life, work and educational experience relevant to the duties and responsibilities of the position. He must be a certified registered nurse practitioner with a current license to practice anywhere in the United States and possess absolute fluency in German as well as English, both with medical terminology. As our prescribing authority, he will specialize in addictions issues and practice in psychiatric, medical and pediatric advanced practice clinical nursing.

The duties and responsibilities of the position are:

- 1. Language requirements
 - a. Fluent in German, and in English, both with medical terminology
 - Functional interpreter into and out of the target languages (Swiss Court Certified Preferred)
- 2. Being a qualified certified registered nurse practitioner
 - a. Adult behavioral health
 - b. General practitioner
 - c. Pediatrics
 - d. Emergency medicine
 - e. Specializing in addictions issues
 - f. Overseeing a home healthcare aide or RN/BSN
- 3. Being housekeeper

- h. Other cleaning as may be required
- 4. Being chauffeur
 - a. Driving errands
 - b. Safely navigating with GPS
 - c. Driving up to 10 hours per day out of 12 on the road
- 5. Being personal chef
 - a. Professionally trained to prepare and serve meals
 - b. Grocery shopping for food
- 6. Other labor requirements
 - a. Oversight for property management services (property manager)
 - b. General handyperson (general knowledge of carpentry, HVAC, electrical work, plumbing...)
 - c. Amateur interior decorator (e.g. hanging curtains, decorating...)
 - d. Weeding garden areas
 - e. Verifying work performed by contractors (landscaper, pool service, professional contractors...)

The employee may take no more than 10 consecutive days off in a row per 182 days, elsewise interspersed. The employee may use his quarter in our homes for vacation anywhere we own a home he is expected to clean at least annually.

The employee shall have an expense account for all rational and related expenses of living and working with us, to include furnishing his areas, except for food and clothing. Time will be permitted. All air travel shall be first class commercial or private. No other benefits are provided.

The employer mandates a strict confidentiality agreement. This position is exempt from overtime.

We anticipate the successful candidate will be a male career nurse practitioner competent in the required areas who has a penchant for meticulous housekeeping and professional cooking. Pay is thus commensurate.

This advertisement is a model manservant skillset for WitSEC Protectees. It may be modified for your unique language needs, medical specialties, and preferred professionally prepared cuisine (e.g. Trained in New-American Food, French Food, or trained Pastry Chef...). The employer may also modify it for either a her or a him to work for the employer. Redress Grievance knows CRNP's to be highly qualified medical practitioners who simply don't perform specialty surgery. A CRNP who oversees an RN/BSN or Home Healthcare Aid can make sure the Protectee dies at home, under Specialty Geriatric Care, working as long as s/he can think for the United States and her allies.

The Relevant Story of Henry Hill, of fame from the American movie "The Goodfellas":

Henry Hill was a Mob Enforcer provably responsible for personally brutally murdering and torturing to death over 50 people. He was a regular cocaine abuser. He was a self-made cash money millionaire at

this advertisement seeks to employ, being only a replaceable professional service, is known to Redress Grievance as safer than the family and friends who support the Primary Secured Party's mental, emotional, and physical well being in an ongoing way. Fitting this skillset and being employed by a protectee inevitably gets the CRNP secured on at least a 10-20 year plan and we seek applicants willing to commit to this timetable for continuous working and ending up forgotten before relocation. Like to Henry Hill, it does not rule out retirement in free society with millions in the bank.

Effective already, The Secret Service is forever disbanded and dissolved. There is no more Secret Service in the United States of America. All protective custody is performed by the FBI and United States Marshal's Service.

Most people have thought about WitSEC at some point in their lives. Beware! Most ordinary people are rightfully scared to death at the thought of daily interaction with federal agents. Most ordinary people are rightfully scared to death of any contact with their Federal Government, much less ongoing. Most ordinary people refuse to go under the gun on a lie detector about their whole life story, expounding every detail and every contact they've ever made to the best of their ability. This is the normal for long-term serious protectees. We endeavor to work remotely as often as possible from highly secure areas.

FBI Protective Custody Personnel only die for the primary secured party. A Heavy Loss is a primary secured party, as this skillset seeks for WitSEC protectees. With care and prudence, you can survive as a primary secured party.

It's real serious to have "Federal Agents!" or "FBI!" appear daily around you both in person and in telepathy, monitoring you both in person and in telepathy in every moment for as long as you're in the program. FBI do not secure criminals. The FBI are still the finest, most incorruptible, most highly trained, educated, able and intelligent law enforcement officers in the United States. Do not interfere with identified FBI or Federal Agents on the job, at your own risk. They're just doing their job. You must presume they're not your friend, although they can be friendly, and are to never be bothered when they're working. If you're a Protectee your life is at grave risk if you distract your protective custody detail outside of known security.

Badgering the United States Government, presenting while drunk or on drugs to any federal officer or officeholder, or being indiscreetly stupid in a way the United States finds offensive will get you audited by state and federal tax authorities for the rest of your life is the beginning of the United States Government's retaliatory efforts against persons wasting the United States time. Beware! Unsolicited contact may or may not be read, or heard, by your government. We prefer to talk to clergy representing the people and tenured faculty at the colleges and universities for expert advice and opinions of governmental need.

If you're a Protectee reading this or an interested servicemember or private deep pocket, the contract completion bonus is the amount of the bounty on the Protectees head. Thus the manservant knows the big money is in legally completing the contract year over year, for as long as s/he signs up to work.⁵ It will be no secret in short time to your manservant federal agents contact you an awful lot, multiple times per day, and it will slip you're in security, in very short time, if you're the employer. Also, write in the employment contract if the manservant is liable in your death, they do not receive the contract completion bonus (e.g. if they're civilly liable for your wrongful death or in any way responsible for killing you, they do not receive the contract completion bonus and will be prosecuted. This incentives good medicine. This disincentives negligent medicine. The contract completion bonus is paid if the bad guy gets you or otherwise die and the employee is not at fault in early release from the contract's obligations of her.)

If you're a CRNP, the above skillset (as a trained personal chef, spotless cleaner, property manager, and CRNP) merits pay up to about USD 1.5 Million per annum with your medical liability insurance picked up by the employer about the 10^{th-} 15th year of service. Employement in this position for a WitSEC protectee is considered Hazardous Duty. Being in WitSEC on duty is considered per se Hazardous Duty.

For military personnel, we can close out your contract (at the lieutenant colonel level or higher rank is preferred for this skillset) or keep you on your military contract in private employment for United States parties, depending on employer and United States need.
