70 per cent of the population is below the poverty line (BPL), and 15 per cent are poor and have weak economic conditions. Only 30 per cent of people are above the poverty line (APL). Around 90 per cent of the population is engaged in agriculture and cattle rearing, their staple source of income.

Most of the populations are seasonal migrates to Chennai, Andhra Pradesh, Karnataka and Kerala for construction and farming works.

Schools are inaccessible, and drop-out rates are high.

There are no check dams hence water is a major problem during summer.

More than 80% of adults are liquor addicts and exhaust all money on the consumption of liquor. This is one of the attributing factors of tribal poverty.

Adult men and women suffer from Communicable diseases. Reproductive tract infection is one of the major health problems of women. 80% of the children are malnourished. Infant Mortality rate and maternal mortality rate are around 5 times higher than the national average. The traditional faith healers play an important role in healing. Their health-seeking behaviours and health practices are harmful.

Almost 100% of women are anaemic. Anaemia among pregnant women and at-home births are the major reasons for the increased mortality of infants and mothers.

Communicable diseases like diarrhoea, Jaundice, typhoid, venereal diseases, sexual diseases, tuberculosis, HIV/AIDS etc., are mostly due to lack of awareness of preventive methods, poor hygiene and sanitation.

The suicide rate has increased drastically over the last decade due to poverty-induced problems, unemployment, alcoholism, disturbed family organization and migration.

Thick forest trees are felled. People do not have much awareness of tree plantation and cut trees for firewood purposes. Alternative energy use is not known to them.

The mean age for marriage for boys is 15 age and for girls is age 13. Premarital sex, elopement, plurality of sex, and extramarital sex are commonly accepted, which leads to several social and health problems. Around 70% of Tribals are illiterate and marriages are strictly from their tribal community.

The Jawadhu Hills are the home of about 80,000 indigenous Malayali (meaning "people of the hills.") tribal people. They are one of the earliest indigenous groups native to the Indian Subcontinent. The ethnically distinct and remotely located Malayali people live outside of the mainstream of Indian society. Most of these tribal people work as small-scale subsistence farmers or land labourers. The Malayali people's lack of running water and basic hygiene presents a health hazard that results in unnecessary critical illnesses and deaths. The remote situation of their habitat, combined with a lack of proper infrastructure in healthcare and transportation, has resulted in high morbidity and low life expectancy.



Certain portions of the project site will be retained by the Chief Functionary of SFRD. Lease amount negotiable The possibility of renovating a few structures only and required assistance will be provided by SFRD if needed.
Viability of Site:	Low productive attitude of people due to lack of commitment and short-term benefits
Inference:	Dr K. Arjunan closed education and rural welfare activities in 1992 after the loss incurred through income-generating units in Vilvarani and reached the SFRD Educational Centre and School in Guniganthur Village managed from inception by the principal, his wife Mrs Silambi. Site not suitable for continued educational, health care and other community welfare activities as the investments can not be recovered in the interest of the people or the Trust. Dr. Arjunan is not keen to associate with Acwerk in Tribal Welfare activities.
Conclusion:	The idea of Lease agreement and investments does not go in favour of an Ecologically Sustainable Village model.
