# Board meeting November 4, 2022 6:00 PM Zoom

Call to Order: Joe Sesack called the meeting to order at 6:00 PM

# Welcome to Roxanne Thompson, VP for Finance and Campus Operations and Doug Hasbrouck, VP for Advancement:

- Roxanne and Doug joined us to discuss:
- CREATING AN MOU (memorandum of understanding) between the parents association
  and Maritime college or (suny). Joe informed them that there is already a MOU written
  up from 2016. According to former president Val Pfundstein the meeting to sign this
  agreement was canceled at the last minute by the Maritime administration. We again
  discussed with Admiral Alfultis in Nov. 2020 and we were told he was waiting on a
  template from SUNY. Doug suggested using a similar MOU created for the Alumni
  Association. Jeannine will send the 2016 MOU to Roxanne and Doug.
- LOGOS- once the MOU is in place we should be able to continue to use the Maritime logos.
- COLLEGE PERMISSION TO HAVE US SELL AT CERTAIN CAMPUS EVENTS- once the MOU is in place clear guidelines will be in place.
- Doug explained that the decision to move us away from the main event at Homecoming
  was made a few years ago by Admiral Alfultis as he wants the fundraising to focus on
  alumni, athletics, and the campus bookstore. When we asked if we could make a

donation to athletics or alumni for a spot by the athletic fields next year Doug could not guarantee at this time.

- How long is the process of setting up the MOU? Not overnight
- We reminded Doug and Roxanne that we have been selling the same exact items since 2017.
- We have our holiday party scheduled for December 2nd. Can we proceed? Yes
- Discussed an email sent to us by both Doug and Dean Romeo asking us if we have donated to the SGA 9/11 memorial. To our knowledge we have never given funds to this cause. Doug said the idea came from Austin Ford, SGA President in 2019/2020. The SGA raised about \$2000 but have not started on any plans. At this time Doug is not asking for any more funding for this project. Joe let him know we have retired FDNY and NYPD on our board and could help with this memorial if needed. The memorial will also honor those who assisted in the boat lift.
- Joe also discussed wanting to help fund the new student union. They will speak with the project managers regarding where funds will be needed.
- Doug and Roxanne left the meeting around 6:35.
