

HORSE TRAILER RENTAL AGREEMENT

I, _____, the undersigned, am renting the 2017 Shadow 2 Horse bumper pull horse trailer (called "Trailer") from Holly Enterprise/Sarah Roch (called "Owner), and agree to the following terms:

Failure to return the trailer on time, will be charged \$10.00 every hour after Trailer is due back.

Proper Use and Trailer Contents:

Upon taking possession of this horse trailer, I understand that I will assume full responsibility for it. I understand that it is my responsibility to furnish a towing vehicle of sufficient size (trailer weighs 3500lbs empty; it is rated for 7,000lbs gross weight) and with necessary components such as a strong towing receiver, hitch, electrical wiring, towing ball (2 5/16'), etc. To safely tow this horse trailer.

I will not tow the Trailer through or under any structure without sufficient overhead or side clearance. I will not use Trailer to transport dangerous, hazardous, illegal material, or living persons. I will not allow anyone other than myself to tow or use the trailer.

Owner is not responsible for any of the contents of this Trailer, including but not limited to horses, persons, tack, tie downs. Owner will not provide any tack needed to properly secure my horse, tack, and/or any other contents while inside or outside of the trailer. It is my responsibility to provide and properly use all tie downs and tack necessary while in or out of the Trailer. It is my responsibility to know how to properly secure my horse or any other contents while in or out of the rented horse trailer.

All conditions apply regardless if the trailer is moving or at a standstill. All conditions apply regardless if the Trailer is attached or detached to my or any other vehicle.

Rental, Indemnity and Warranties:

This contract of lease only and not of sale. I agree that I have leased the trailer herein described upon the express condition that it will always remain the property of the Owner. Owner may repossess the Trailer at my expense without notice to me if the Trailer is abandoned or used in violation of the law or this Agreement. I agree to indemnify Owner, defend Owner, and hold Owner harmless from all my claims, liability costs and attorney fees Owner incurs resulting from, or arising out of this rental and my use of the Trailer. Owner makes no warranties, express, implied, or apparent, regarding the Trailer, no warranty of merchantability and no warrant that the Trailer is fit for a particular purpose.

Condition and Return of Trailer:

I have examined the Trailer and found it to be in good condition. I will return the Trailer to Owner on the date and time specified in this Agreement, and in the same condition that I received it, except for ordinary wear. Service to the Trailer or replacement of parts or accessories during the rental must have Owners prior approval. I will not alter the Trailer by placing signs, lettering or painting on the Trailer.

Responsibility for Damage or Loss; Reporting to Police:

I am responsible for all damages to, or loss or theft of, the Trailer, including damaged caused by weather, road conditions and acts of nature, whether or not I am at fault. I am responsible for the cost of repair or the actual retail cash value of the Trailer if it is not repairable or if Owner elects not to repair it. (The trailer is valued at \$14,700) I am also responsible for any missing equipment, and a reasonable charge to cover any administrative expenses connected with any damage claim. I will report all accidents involving the Trailer to Owner and the police within 24 hours of occurrence.

Current Body Damages:

Passenger Side Fender flare slightly out
Inside Horse Trailer/Driver Side gouge (1" thick)

Release of Liability:

Owner is not responsible for any injuries, accidents, or death of any persons, any animals, or any contents, while in or out of the Trailer. I release Owner, property owners, employees and contract personnel, agents and volunteers, successors or assigns, lessors and joint ventures from any and all liability, claims, demands, actions and cause of action whatsoever arising out of any damages, both in law and in equity, in any way resulting from personal injuries, conscious suffering, death, or property damage sustained by me or by others arising out of my use of the Trailer.

I am at least 18 years of age and I have read each part of this Agreement. I understand that it is a promise not to sue and to release Owner, property owners, employees and contract personnel, agents and volunteers, successors or assigns, lessors and joint ventures from any and all liabilities, claims, lawsuits, losses, costs, cause of action and damages of any kind. I have made a free deliberate choice to sign this Agreement as a condition to use of the Trailer.
