FIRST AMENDMENT TO THE BY-LAWS OF THE KIRKWOOD COUNTRY HOMEOWNERS ASSOCIATION

KNOW ALL MEN BY THESE PRESENTS

WHEREAS, it is desired to amend the By-Laws of the Kirkwood Country Homeowners Association to change the duration of the terms of the Trustees of the Association in order to improve continuity on the Board, and

WHEREAS, Article IV, Section 2 of the By-Laws currently reads as follows:

Section 2. Term of Office. The initial Trustees for the Association set forth in the Articles of Incorporation shall hold office until the 1980 annual meeting. At the annual meeting of 1980, the members shall elect one trustee for a term of one year two trustees for a term of two years; at each annual meeting thereafter the members shall elect that number of trustees equal to the number of trustees whose terms expire at such time.

WHEREAS, the By-Laws can be amended in accordance with Article XII, Section 1 of the By-Laws by a vote at a regular or special meeting of the members at which a quorum is present, and

WHEREAS, a meeting of the members was duly called in accordance with Article III of the By-Laws and held on November 16, 1987, and

WHEREAS, a quorum of members was present at such meeting and a majority of the members present or represented by proxy voted FOR amending Article IV, Section 2 of the By-Laws as listed below;

NOW THEREFORE, Article IV, Section 2 of the By-Laws of the Kirkwood Country Homeowners Association is amended to read as follows:

Section 2. Term of Office. The initial Trustees for the Association set forth in the Articles of Incorporation shall hold office until the 1980 annual meeting. At the annual meeting of 1980, the members shall elect one trustee for a term of one year, two trustees for a term of two years, and two trustees for a term of three years; at each annual meeting thereafter the members shall elect that number of trustees equal to the number of trustees whose terms expire at such time.

Beginning with the 1989 Annual Meeting, all Trustee positions shall be 2 year terms. In order to stagger the positions, the following will occur at the 1988 Annual Meeting:

Position 1 will be elected to serve until 1990 Position 2 will be elected to serve until 1990

Position 3 will be elected to serve until 1990 Position 4 will not be up for election until 1989 Position 5 will be elected to serve until 1989
