WATER SAVING TIPS FOR LAWN CARE

Use these water saving tips for lawn care during extended periods of heat and drought.

- Make sure your irrigation system is in good working order. Find any leaks and broken heads.
- Turn off automatic sprinkler settings. Irrigate based on plant stress or on-line tools.
- Don't water lawns during heat of the day; water in early morning.
- Watch your landscape watering don't water sidewalks, driveways or streets, or let water run down the street.

- Use low volume drip or trickle irrigation for garden and bedding plants.
- Mulch shrubs and other plants to keep moisture in the soil longer.
 This also controls weeds that compete with garden plants for water.
- Fewer but heavier lawn watering encourages deeper roots which withstand dry weather better. A deeply watered lawn should be able to go 5 to 8 days between waterings.
- To irrigate trees and large shrubs in the lawn, water at their drip-

- lines—that is where the feeding root system of a tree or shrub is.
- Raise mower height slightly in hot, dry weather. Mow frequently to avoid cutting more than one third of the leaf blade on any cutting.
- Rainwater harvesting systems can provide supplemental water for landscapes and pets.
- Don't use the hose to clean off sidewalks or driveways; sweep them clean.
- Don't put debris, yard clippings or leaves down storm drains.

CRIME PREVENTION TIPS TO PREVENT THEFT

R esidents should avoid opening their doors for strangers and never allow them access into their homes. Residents are reminded that City work crews wear uniforms, carry official identification, and drive marked vehicles. Contractors are also expected to be identified by official identification.

Useful tips to help prevent similar crimes:

- Never open the door for strangers; however, it's important to acknowledge people knocking on the door to prevent thieves from forcing their way into a home they believe is empty.
- There's never a reason for work crews to enter a house.
- To ensure the validity of workers in the area, call Houston's non-emergency number at 713-884-3131. Immediately report any suspicious activity in the area, including strangers or vehicles that seem out of place. Many crimes are prevented by alert citizens.

Please obey all speed limits in and around our neighborhood, and be especially careful when around schools, buses and children walking to an from school.

HOME INSURANCE AND ALARM SYSTEMS

Everyone wants to save money, but to save money while increasing the safety of your family and protecting your property is an added bonus. For decades security systems have been regarded as effective deterrents against home burglaries; so much so that some insurance companies offer

PROHIBITED YARD PARKING ORDINANCE

The Board of Directors is pleased to announce that the Prohibited Yard Parking Ordinance, Ordinance 2013-1132 was passed by Houston City Council on December 11, 2013, and is now in full force! All residents should be advised that parking any vehicle in your yard is a misdemeanor and violators will be fined not more

than \$150.00 per day.

Vehicles and equipment refers to and includes any house trailer, mobile home, motor truck, passenger motor vehicle, motor home, camper cabin, motorcycle, trailer, boat, farm machinery or similar equipment or any truck with more than two (2) axles or any trailer, mobile home or motor home

with a length exceeding 20 feet.

If you witness a vehicle parked in the front yard of any home in our community, please report it to HPD by calling (713) 884-3131. The address where the vehicle is located, make, model, color and license plate number of the vehicle is required.

Your assistance is appreciated.

ACC GUIDELINES AND DEED RESTRICTIONS

Please keep in mind any improvements or revisions to the exterior of your home must be approved prior to any work being performed. You may call MASC Austin Properties, Inc., 713-776-1771, for an ACC form or with any questions regarding your renovations. Failure to follow these guidelines may result in immediate removal and/or legal action being

taken.

Residents should keep up with trimming trees, repairing fences and maintaining mailboxes. If replacing an entire fence, an ACC form must be completed and submitted prior to the work beginning.

Help keep Kirkwood Country beautiful and attractive to new buyers and keep

our property values up.

The ACC Guidelines and Deed Restrictions were put in place to protect our values. Buying a home is one of the biggest investments you make in your lifetime. Help protect your investment and your neighbors. Please abide by the ACC Guidelines and Deed Restrictions.

TRASH PICKUP

lease be advised of the trash pickup days in our community:

- City of Houston Garbage Pickup: Every Mon-
- Recycling: Every other Monday
- Tree Waste Pickup 1st Monday of January, March, May, July, September and November
- Junk Waste: 1st Monday of February, April, June, August, October and December

Household trash must be placed inside the cityprovided container and placed at the curb no earlier than 6 p.m. the day before and 7 a.m. the day of collection. Containers must be placed out of public view. Violation of any provision of the solid waste ordinance is punishable upon first conviction by a fine of no less than \$250 nor more than \$2,000.

To report a violation or file a complaint, call 3-1-1. All Solid Waste Management Department Supervisors may issue citations.
