



Quick Reference: Hemp Transportation Requirements

Date: July 2020

Interstate Commerce and Hemp Transportation:

In order to transport hemp into and throughout the Midwest HIDTA, transporters are required to maintain bills of lading that meet the plan requirements of the origin and destination states. If a law enforcement officer encounters a shipment of hemp originating from a Midwest HIDTA state, the bill of lading must include the following information:

Iowa

- The name and address of the owner of the hemp;
- The point of origin and delivery;
- The kind and quantity of packages or, if bulk, the total quantity of hemp in shipment; and
- The date of shipment.

Kansas

- The licensee's license number;
- The total quantity of hemp transferred;
- The date the transfer occurred; and
- The name of person acquiring the hemp.

Missouri

- A copy of their valid producer registration or agricultural hemp propagule and seed permit;
- A certificate of laboratory analysis for each lot in transport; and
- A chain of custody form.

Nebraska

- If the transporter is a cultivator, they must carry a copy of their cultivator license and a copy of the test results pertaining to the hemp;
- If the transporter is a processor, they must carry a copy of their processor-handler license and a copy of the test results pertaining to the hemp;
- Any person transporting hemp other than a cultivator or processor-handler must have a bill of lading indicating the owner of the hemp, the point of origin and destination, and a copy of the test results pertaining to such hemp ensuring the hemp was produced in compliance with Federal law.

North Dakota

- As North Dakota operates under the 2014 Pilot Program, only licensed processors are able to possess hemp.

South Dakota

- The Department of Agriculture has not yet established hemp transportation requirements, nor are there any registered cultivators or producers at this time.
