Safety Pledge and Liability Waiver

- waive your rights concerning business on Motion, dinner on the dark, Ayesha liability for injury, as outlined below.

What are the RISKS in participating in the Event?

- You and other guests will be entering an immersive Experience, which will involve movement through a low or dim light setting which may result in reduced, low and/or poor visibility, disorientation, or physical injuries;• Improper use of eating utensils due to low visibility may lead to spilling of food, stabbing or general messiness.
- Low or zero visibility of what you are eating and drinking means the ingredients used in the food and beverage of the meal may be unknown to you and outside of your dietary restrictions and contain certain allergens; and
- The Experience is taking place during the COVID-19 endemic phase in the US. COVID-19 is contagious (can spread from person to person contact) and can cause serious illness

What does this mean?
