Canadian Human Trafficking Bills

Human trafficking is a pressing issue in Canada, affecting thousands of vulnerable individuals each year. Below is an in-depth explanation of four key bills that aim to combat trafficking and exploitation in Canada.

Bill S-210 – Protecting Children from Online Exploitation Act

Purpose:

Bill S-210 seeks to protect minors from exposure to sexually explicit content online by requiring strict age verification measures on adult websites and platforms that host explicit content.
