Officers Who Were Present

Interviewed by Carbo + Cchevarria

* hung his head + eyes filled with tears said he wanted to tell the truth *

"Should be noted that this typewritten statement encompassed Everything that transpired in our verbal interview, but in greater detail"

Cousin Wheeler brought Joseph to his house in Darby Tuesday (Nov 29th) before shooting

* Wesley said he needed someone killed who was going to testify against him.

Right after he got into a sedan with Wesley drove to Norristown (Phone Records ? GPS)

In the car outside of house Wesley says it's a female ~~that needs to~~ who is target explains she will testify to guns and drugs. No price discussed. But told Wesley that he would connect him w/ someone who could do the job.

Dec 1 Drove to Norristown w/ [REDACTED]. Gave [REDACTED] Morales phone to speak with Wesley and gave Morales Wesley's phone number.

Sat in car both on phones. [REDACTED] says Wesley will pay 5K for murder and 1K to Bean for being driver. Spent the night there and left the next morning. (?)

Dec 2 Dropped [REDACTED] off at his house in Chester. [REDACTED] called in afternoon and they together returned to Norristown. Both walked to victim's house. Bean stayed at bottom of St. While [REDACTED] proceeded with shooting.

Admitted to Not being ^{fully} TRUTHFUL

* Couple days prior to October 21st Bean contacted by Waheed (his cousin) regarding a job. Found out job when met w/ Wesley directly. Paid \$500 at initial meeting to kill victim. \$4500 upon completion. October 23rd Bean says he and Wesley are in Norristown. Wesley shows Bean victim's home and escape routes.

inconsistencies

21 * First time he met Wesley couple days prior to 10/21 ↖ Call happened 1

- Received a call from Waheed about a job a couple days prior to 10/21

(- Did not know what job was until meeting w/ Joseph directly) * Consistent

* Meeting took place @ apartments that are near a bridge few blocks from Baltimore on Lansdown

Followed him to a gas station that day & Lansdown & State Rd across from McDonalds

* (Fed information about Wesley's whereabouts) Inconsistent with previous statement that Wesley came to his house

* In statement Why did you take screenshots on your cellular telephone of Haws Avenue?
Response To get you familiar with the area.

(Goes to mindset of Detectives - feeding info to defendant)

* Claiming on Oct 23rd Wesley met up with him in Norristown
drove separately but got into passenger seat; this time goes into detail about "escape routes"

* Lied about ~~taking~~^{making} call from phone to Wesley to say "It's Done" Not ~~about~~ it

* Spent \$500 on bills

* Nov 24th saw Wesley on 69th St. driving a F-150 gray

* Inconsistent - Says he did not see Wesley since 11/54 but first statement claims they met one week prior to incident

Ran back to car. Used GPS.(?) While driving let Morales use phone to call Wesley. ~~He~~ says Its Done and asks Wesley where they can meet for payment. Wesley told ~~him~~ they would be in touch. Wasn't until after he got off the phone that ~~he~~ said he shot victim and some boy who was with her.

*Claims ~~he~~ got picture of victim from FB
Doesn't know how he got pic.

After shooting dropped him off in Chester.

Last time he spoke w/ Wesley was days after shooting Wesley. ~~He~~ tells him he will be in touch w/ money.

No payment rec'd

Spoke to ~~him~~ after shooting about ~~the~~ asking if he heard about getting paid.

Sent ~~him~~ newspaper articles about shooting.

Had metro LG touch screen - white AND Samsung 7 - Black

Trial Prep

~~He~~ stated as his cousin, person who introduced him to Wesley

Inconsistent

- * 10/21 - Back to ~~He~~ brought him to his house in Alexander (kids getting off bus)
- * This was the first time they met and the first time they were in Norristown together.

- * Paid \$500 on 10/21

2 Bean drives to Norristown to get familiar with the area

3 ~~He~~ gives him the gun. ^{Bean could not follow through w/ shooting}
* First statement says ~~He~~ had gun
* First statement says he told Wesley up front he doesn't shoot women so would put him in contact with someone who could

3 States Wesley showed him a house in Norristown where he could run and hide after shooting but doesn't recall address
* Second statement says that took place same day as meeting
