Forest Service allows homeowners to cut 500 ft into forest at own expense. Trees must be sprayed to prevent beetle spread in Spring
Warren duly moved to approve up to \$1,000 for an assessment of Pine
Beetle damage adjacent to Forest Service land, Dennis 2nd, passed unanimously
Authorize May meeting to review beetle assessment results
Possibility of dues increase/special assessment to proceed with beetle treatment
