The CCO serves in a supervisory role that oversees and provides guidance and direction to the Directors of Residential Treatment, Community Programs and Performance Improvement and the Nursing Team, while also collaborating closely with the Medical Director and Advanced Nurse Practitioner.

This agency practices the Sanctuary Model which is a non-hierarchical, highly participatory, trauma-informed and evidence-supported whole culture approach, which helps the organization function in a safe, democratic and socially responsible manner and thereby provide effective treatment for clients and the community.

Required education, background, and skills include:

- Knowledge in working with children and families who have experienced significant trauma in their lives. This would include children and families with Severe Emotional Disorders.
- Master's degree in mental health or related field.
  - A preference will be given to those with professional license in social work, behavioral health or similar clinical licensure.
- A minimum of five (5) years experience in a clinical setting serving persons in relevant target population(s).
- At least four (4) years of relevant supervisory/program management
- Preference will be given to an individual who worked within a Joint Commission accredited organization.
- Problem solving and the ability to work on multiple concurrent tasks, plan and develop programs, and balance vision for the big picture while understanding daily operational intricacies.
- Must be able to plan and develop programs to respond to the need of the populations served.
