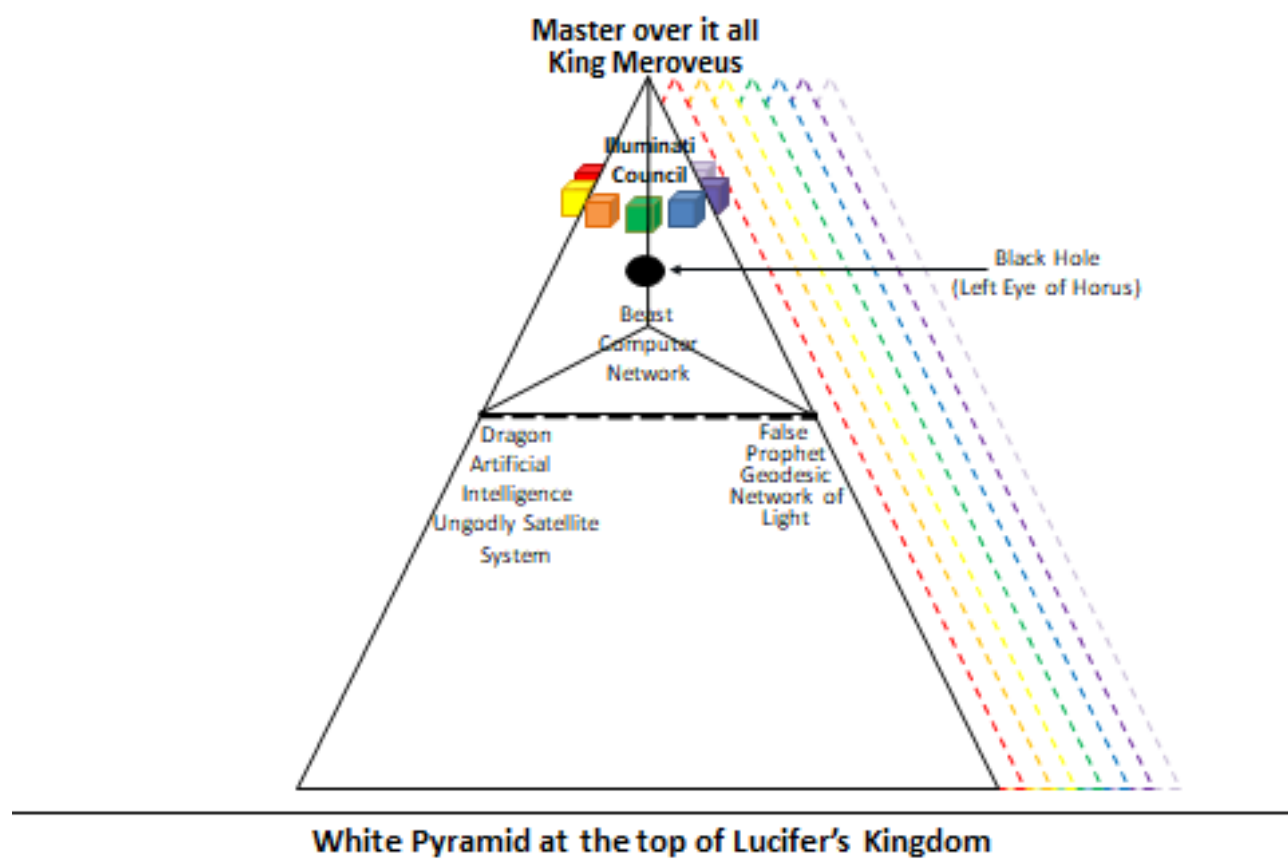


Disconnection from the Illuminati Council

The Illuminati Council, consists of the heads of the 12 Illuminati houses/bloodlines plus Lucifer when he joins them. Each bloodline or “house” seems to be represented by a different color. The Council seems to meet in the spiritual realm near the top of the upper white pyramid of Lucifer’s Kingdom, above the Black Hole, or the Left Eye of Horus, which is connected to the goddess Wadjet.



The Illuminati Council of living council members seems to be connected to an ancestral council consisting of past Illuminati members in a person’s generational line. The ancestral council is also connected to 13 primary identities in the person, each being over a sub-system in the person.¹ The connection of the 3 groups of 13 forms a triad of councils: the living Illuminati Council, the Ancestral Illuminati Council, and the 13 primary identities in the survivor. The Beast seems to play a prominent role in this, forming a quadriad with this triad of councils.

I do not fully understand this, but there seems to be goal among the Ancestral Council members to earn their way to be able to sit on a throne, but their position on the Ancestral Council will be jeopardized if the connection to the survivor and the 13 primaries in him/her is broken. Perhaps those on the Ancestral Council connected to the survivor are aspiring to earn a position on a higher level Ancestral Council that is more directly connected to the living Illuminati Council. This may be what the throne is about but this is only a personal hunch.

This renunciation should be done after the renunciation entitled “Breaking an Illuminati Conception Ritual.” Because every person’s use by the Illuminati may be somewhat different, be open to the Spirit of God to direct you to any additional requests that may need to be made.

I. Breaking Connection to the Illuminati Council

A. Ask the person:

1. Do you desire to be completely disconnected from the Illuminati, its agenda, and projects?
2. Do you desire every part of you to be released from all assignments and use by any part of the Illuminati whatsoever?
3. Do you desire to be completely disconnected from:
 - a. The Illuminati Council and all control coming to you from it?
 - b. The master control board of the Illuminati Council?
 - c. Any remaining connections with the Beast Computer?
 - d. All communication systems between you and the Illuminati Council, including any fleet of birds of any kind being used as messengers?
 - e. All human, ancestral, spiritual, or hybrid entities serving as handlers or overseers over your life and your use by the Illuminati?
 - f. The masters from each of the 12 Illuminati houses?
 - g. The entire hierarchy of entities connected to the Illuminati Council and to each of the 12 Illuminati houses and their leaders as well as those connected to the 13th house of Lucifer?
 - h. Lucifer and the Master over it all, King Meroveus, the son of Lucifer, and the entire hierarchy of entities connected to them?
 - i. Wadjet and the Left and Right Eyes of Horus and the entire hierarchy of entities connected to them?
 - j. The counterfeit trinity of the Dragon, the Beast, and the False Prophet and the entire hierarchy of entities connected to them?
 - k. All triads and quadriads involved in any kind of Illuminati control over you?
 - l. The black and white pyramids of Lucifer’s Kingdom and each of the colored pyramids behind the white pyramid and from the ruling entities of all of them?
 - m. All ungodly powers operating in Lucifer’s Kingdom, including the black and white and heavenly powers?

- n. Any mechanism designed to move parts of you to different dimensions or places above the earth, on the earth, or beneath the earth to fulfill assignments or for any other purposes?
4. Do you desire to have your place removed from the Illuminati Council and the master control board and to be disconnected from any evil spiritual beings or ungodly entities connected to it?
 5. Do you desire any mechanism that is beaming rays of any kind down on you for any purpose to be totally removed from ever being able to do so again?
 6. Do you desire every internal structure and manipulated life form that is being used to make you function as a message control or relay center or for any other purpose related to your use by the Illuminati to be removed from you completely, including all transport mechanisms and docking ports?
 7. Do you desire to be disconnected completely from any ungodly radar system being used in connection with the messaging center and to have all radar receptors and emitters removed from you as well as all receptors and emitters for any other kind of telecommunication?
 8. Do you desire any instrumentation capsule placed over you² to be disconnected from all ungodly power grids and power systems as well as from the master control board and mainframe computer and operating station and all substations?
 9. Do you desire the Most High God to remove any such instrumentation capsule that was placed over you?
 10. Do you want all manipulated life forms, manipulated molecular structures, robotic creatures, and mechanical creatures connected to the capsule or any other part of the message control or relay center or anything else in or attached to you to be removed?
 11. Do you desire all locating devices in you to be removed?
 12. If there are framework structures involved, do you renounce all powers of alchemy and sorcery and desire the Most High God to remove them as well as all life force in these structures³ and to remove all framework structures?
 13. Do you desire all connectors to external structures to be removed and the openings to them closed and sealed with the blood of the Lord Jesus Christ?
 14. If any kind of marker or tracking substance or mechanism was put in your bloodstream, do you want that removed?
 15. Do you desire to be disconnected from all evil spiritual and ungodly entities connected to all parts of your use by the Illuminati Council, including all that may have been connected to the ray-beaming mechanism, the message relaying system, the instrumentation capsule, the fleet of black birds, or any other structures or mechanisms to which you were connected?

16. Do you desire that all parts of you that may be out of the body “on assignment” or for any other purpose within the Illuminati Agenda be brought back to you, cleansed by the blood of the Lord Jesus Christ, and all entities, programming, inserts, and attachments removed?
17. Do you desire all information that has been collected from you or through you to be removed from wherever it is stored in a way that will not be detected or initiate retaliation?
18. Do you desire the Most High God to reverse all curses set to be released should you ever disconnect from these things?
19. Do you desire to break all ungodly relationship bonds with:
 - a. All of the Illuminati Council members, including Lucifer?
 - b. The Dragon, the Beast, the False Prophet, and the Master over it All?
 - c. Wadjet?
 - d. All Illuminati overseers and handlers of every kind connected to you?
 - e. All entities to which you were connected in triads or quadriads?
 - f. Any fleet of messenger birds used in conjunction with you?
 - g. All the life force in all of the manipulated life forms and framework structures that were in or attached to you?
 - h. The network of other survivors being used in the same way as you?
 - i. All with whom these people and entities formed ungodly relationship bonds?

B. Pray to the Most High God:

On the basis of the word of _____’s testimony and the shed blood of the Lord Jesus Christ, whom _____ claims as personal Savior, I ask You, Most High God, in the name of the Lord Jesus Christ to honor his/her requests and to:

1. Declare that _____ is from this point forward forever and completely disconnected from the Illuminati, its agenda, and projects and is released from all assignments and use by any part of the Illuminati;
2. Declare that he/she is also completely disconnected from:
 - a. The Illuminati Council and all control coming to him/her from it;
 - b. The master control board of the Illuminati Council;
 - c. Any remaining connections with the Beast Computer;
 - d. All communication systems between him/her and the Illuminati Council, including any fleet of birds or any kind of being used as messengers;
 - e. All human, ancestral, spiritual, or hybrid entities serving as handlers or overseers over his/her life and use by the Illuminati;
 - f. The masters from each of the 12 Illuminati houses;
 - g. The entire hierarchy of entities connected to the Illuminati Council and to each of the 12 Illuminati houses and their leaders as well as those connected to the 13th house of Lucifer;
 - h. Lucifer and the Master over it all, King Meroveus, the son of Lucifer, and the entire hierarchy of entities connected to them;

- i. Wadjet and the Left and Right Eyes of Horus and the entire hierarchy of entities connected to them;
 - j. The counterfeit trinity of the Dragon, the Beast, and the False Prophet and the entire hierarchy of entities connected to them;
 - k. All triads and quadriads involved in any kind of Illuminati control over him/her;

 7. Disconnect any instrumentation capsule placed over _____ from all ungodly power grids and power systems as well as from the master control board and mainframe computer and operating station and all substations;
 8. Remove any such instrumentation capsule that was placed over him/her;
 9. Remove all manipulated life forms, manipulated molecular structures, robotic creatures, and mechanical creatures connected to the capsule;
 10. Remove all locating devices in _____;
 11. Remove all powers of alchemy and life force from any framework structures involved and to remove the framework structures;
 12. Remove all connectors to external structures and to close and seal with the blood of the Lord Jesus Christ the openings to them;
 13. Remove any kind of marker or tracking substance or mechanism put in _____'s bloodstream;
 14. Disconnect _____ from all evil spiritual and ungodly entities connected to all parts of his/her use by the Illuminati Council, including all that may have been connected to the ray-beaming mechanism, the message relaying system, the instrumentation capsule, the fleet of black birds, and any other structures or mechanisms to which he/she was connected;

15. Release and return to _____ all parts of him/her that may be out of the body “on assignment” or for any other purpose within the Illuminati agenda, including any that are being held within the Illuminati Council, and to cleanse them all with the blood of the Lord Jesus Christ and remove all evil and ungodly entities, programming, inserts, and attachments from them;
16. Remove all information that has been collected from _____ or through him/her from wherever it is stored in a way that will not be detected or initiate retaliation if it is safe to do that;
17. Reverse and nullify with the blood of the Lord Jesus Christ all curses set to be released should _____ ever disconnect from these things;
18. Break all ungodly relationship bonds between _____ and:
 - a. The Illuminati Council members, including Lucifer;
 - b. The Dragon, the Beast, the False Prophet, and the Master over it all;
 - c. Wadjet;
 - d. All Illuminati overseers and handlers of every kind;
 - e. All entities to which he/she was connected in triads or quadriads;
 - f. Any fleet of messenger birds used in conjunction with him/her;
 - g. All the life force in all of the manipulated life forms and framework structures that were in or attached to him/her;
 - h. The network of other survivors being used in the same way as him/her;
 - i. All with whom they have formed ungodly relationship bonds.
19. Remove all evil spiritual and ungodly entities, powers, forces, energies, lights, life forces, mists, manipulated life forms or structures, robotic or mechanical creatures or anything else that gained access to _____ through these ungodly bonds.
20. Remove any part of their souls, spirits, or life forces that intermingled with _____’s and to return to him/her, cleansed by the blood of Jesus Christ, any part of his/her soul or spirit that intermingled with theirs, and when these exchanges are complete, to sever the spiritual conduits between them, close them, and seal them with the blood of the Lord Jesus Christ.
21. Pass judgment on all evil and ungodly entities removed or disconnected from _____, dispatch them to the destinations of Your choosing, fill the evacuated places with Your true Holy Spirit, and close and seal with the blood of the Lord Jesus Christ the portals and orifices that they used for access to him/her;
22. Remove all structures and manipulated life forms in all of their multi-dimensional and transmutable forms along with all mirror and holographic images, reflections, shadows, backup generations, and self-replicating mechanisms;
23. Bring healing to every part of _____’s body, soul, and spirit that was affected by his/her connection with the Illuminati Council and agenda down to a cellular and intracellular level, including the DNA, RNA, mitochondria, epigenetic markers, and the very image of God in which he/she was created.
24. Seal the work that was done and declare that no retaliation or retribution whatsoever be allowed.

II. Breaking Connection with the Ancestral Council

A. Breaking any Generational Covenant

1. Do Generational Repentance

a. Ask the individual:

- 1) Are you willing to stand in the gap on behalf of your ancestral lines on your mother's and your father's side to acknowledge, renounce, and confess on their behalf the iniquity of making covenants and/or bargains or bequests to commit future generations to serving on, or working for, the Illuminati Council, setting up an internal Illuminati Council of 13 within yourself and connecting it to the Illuminati Council, an Ancestral Council, and the Beast as well as an covenant, bargain, or bequest to sit on a throne in Lucifer's Kingdom?
- 2) Are you willing to forgive your ancestors for bringing this generational inheritance and its consequences into your life, putting all responsibility for bringing judgment into God's hands?
- 3) Are you willing to renounce and to repent of any and every way that any part of you has knowingly or unknowingly, willingly or unwillingly participated in these iniquities yourself? (Be specific about the various ways God brings to mind that the person may have done this.)

b. Pray:

Most High God, I ask You on the basis of what _____ has stated and through the shed blood of Jesus Christ to break this generational inheritance and its curses from his/her life and from the lives of his/her descendants going forward for a thousand generations.

I ask You to remove from them all evil spiritual and ungodly entities and powers that gained access because of this generational inheritance, to pass judgment on them, to dispatch them to the destination of your choosing as appropriate, to close and to seal with the blood of the Lord Jesus Christ all portals and orifices they used for access, and to fill all evacuated places with Your Holy Spirit.

As You remove these generational curses from _____, will You please release any of Your generational blessings intended for them that were blocked because of this generational iniquity? Thank you, Most High God.

2. Do personal renunciation.

a. Ask the person the following questions:

- 1) Do you reject all covenants, bargains, barter, or bequests that any of your parents, grandparents, or any other ancestors or step-relatives made with Lucifer/Satan or any being serving under him to commit you to working for or serving on the Illuminati Council, setting up an internal Illuminati Council of 13 within you and connecting it to the Illuminati Council, an Ancestral Council, and the Beast?
- 2) Do you desire the Most High God to nullify and to redeem you from those covenants, bargains, barter, and/or bequests through the shed blood of the Lord Jesus Christ?

- 3) Do you desire Him to cancel the benefits gained by the ancestor?
 - 4) Do you accept and desire to follow fully the destiny that God designed and placed within you when He created you and released you into life?
 - 5) If the covenant, bargain, barter, or bequest resulted in your being connected into a triad or quadriad with Lucifer, the Dragon, the Beast, the False Prophet, or any other evil or ungodly being and the spirit of the ancestor making the transaction, do you desire the Most High God to break that triad or quadriad, releasing you from all connection to the other beings?
 - 6) Do you desire to be completely disconnected from the entire hierarchy of evil spiritual beings and ungodly entities that gained access to you and your descendants because of the ancestral covenants, bargains, barter, or bequests that were made, including all powers, forces, energies, lights, life forces, and mists?
 - 7) If any dissociated part of you or any part of your created-by-God life force was taken into captivity in another dimension, realm, or void between them because of these covenants, bargains, barter, and/or bequests do you want them to be returned to you safely, cleansed by the blood of Jesus Christ of all entities and all attachments, inserts, or connections of any kind removed?
 - 8) When your parts are safely returned from these places, do you desire to be disconnected from all spiritual conduits connecting you to those dimensions and realms and for the openings to them to be closed and sealed with the blood of the Jesus Christ?
 - 9) Do you reject all allegiance to the counterfeit sun, moon, stars, and other spiritual authorities ruling over these places and desire to be disconnected from the entire hierarchy of spiritual and ungodly entities connected to them?
 - 10) Do you desire to break all ungodly relationship bonds with:
 - a) The people who were involved in making the covenants, bargains, barter, or bequests;
 - b) The entity or entities with whom the covenant, bargain, barter, or bequest was made;
 - c) All other participants in the ceremony;
 - d) All sacrifices made to empower the transaction;
 - e) All members of any triad or quadriad formed with you as a result;
 - f) All spiritual authorities over any dimension or realm where any part of mine was taken;
 - g) All people and entities with whom these people and entities were in ungodly relationship bonds?
 - 11) Do you desire the Most High God to nullify any curses set to be released if you should break this ancestral covenant concerning your life?
- b. Ask the Most High God to honor these requests and in the name of the Lord Jesus Christ to:
- 1) Nullify all covenants, bargains, barter, or bequests that any of _____'s parents, grandparents, or any other ancestor, relative, or step-relative made

with Lucifer/Satan or any being serving under him to commit _____ to working for or serving on the Illuminati Council, setting up an internal Illuminati Council of 13 within him/her and connecting it to the Illuminati Council, an Ancestral Council, and the Beast as well as any dedication, bargain, or bequest to sit on a throne in Lucifer's Kingdom;

- 2) Break any triad or quadriad that was made as a result of the covenant, bargain, barter, or bequest, releasing _____ from all connection to Lucifer, the Dragon, the Beast, the False Prophet, or any other cosmic being included in it and the spirit of the ancestor making the transaction;
- 3) Disconnect _____ from the entire hierarchy of evil spiritual beings and ungodly entities that gained access to him/her and his/her descendants because of the ancestral covenants, bargains, barter, or bequests that were made, including all powers, forces, energies, lights, life forces, and mists;
- 4) Return to _____; completely cleansed by the blood of Jesus Christ and with all entities, attachments, inserts, and connections of any kind removed; any dissociated part of him/her or any part of his/her created-by-God life force was taken into captivity in another dimension or realm or void between them; because of these covenants, bargains, barter, or bequests;
- 5) Disconnect _____ from all spiritual conduits connecting him/her to any of these places once all parts of him/her are returned from them, close the off openings to them, and seal them with the blood of the Lord Jesus Christ;
- 6) Disconnect _____ from the counterfeit sun, moon, stars, and other spiritual authorities ruling over these places and the entire hierarchy of spiritual entities connected to them;
- 7) Break all ungodly relationship bonds between _____ and:
 - a) _____'s ancestors, relatives, or step-relatives involved in making the covenants, bargains, barter, or bequests that committed him/her to this project;
 - b) The entity or entities with whom the covenant, bargain, barter, or bequest was made;
 - c) All other participants in the ceremony;
 - d) All sacrifices made to empower the transaction;
 - e) All members of any triad or quadriad formed with _____ as a result of the covenant, bargain, barter, or bequest;
 - f) All spiritual authorities over any realm or dimension where any of _____'s parts were taken into captivity;
 - g) All people and entities with whom these people and entities were in ungodly relationship bonds;
- 8) Remove every evil spiritual being, ungodly entity, familial spirit, powers, forces, energies, lights, life forces, mists, manipulated life forms or molecular structures, robotic or mechanical creatures, and everything else that gained access to _____ through these ungodly bonds.

- 9) Remove any part of their souls, spirits, or life forces that intermingled with _____'s and to return to him/her, cleansed by the blood of Jesus Christ, any part of his/her soul or spirit that intermingled with theirs, and when these exchanges are complete, to sever the spiritual conduits between them, close them, and seal them with the blood of the Lord Jesus Christ.
- 10) Remove all effects of being connected to these councils and entities and this purpose in Lucifer's Kingdom from _____'s body, soul, spirit, DNA, RNA, mitochondria, epigenetic markers, and the original image of God in which he/she was created;
- 11) Pass judgment on all evil spiritual beings and ungodly entities removed from _____, dispatch them to the destinations of His choice as appropriate, fill the evacuated places in _____ with His true Holy Spirit, and close and seal the portals they used for access with the blood of the Lord Jesus Christ;
- 12) Nullify any curses set to be released should _____ break this ancestral covenant, bargain, barter, or bequest concerning his/her life;
- 13) Apply everything that was stated to _____'s generational line going forward;
- 14) Seal the work that was done and declare that no retribution or retaliation whatsoever is permitted.

B. Personal Disconnection from the Ancestral Council

1. Ask the following questions:
 - a. Do you renounce your generational and/or personal dedication to the Beast and desire the Most High God to nullify it completely with the blood of the Lord Jesus Christ?
 - b. Do you renounce serving any role whatsoever on or for the Illuminati Council?
 - c. Do you desire the Most High God to nullify with the blood of the Lord Jesus Christ all dedications, appointments, and/or aspirations to serve on or work for the Illuminati?
 - d. Do you renounce all dedications, appointments, and/or aspirations to sit on a throne in Lucifer's Kingdom? Do you desire the Most High God to nullify these in the name of the Lord Jesus Christ and through the power of His shed blood?
 - e. Do you renounce all dedications, appointments, and/or aspirations to sit on an Ancestral Council? Do you desire the Most High God to nullify these in the name of the Lord Jesus Christ and through the power of His shed blood?
 - f. Are you willing to give up all that has been given to you to equip you for any of these positions, including all powers, structures, manipulated life forms, and attachment to entities of any kind? Do you desire the Most High God to remove all of these from you?
 - g. Do you renounce and desire to have absolved by the blood of the Lord Jesus Christ all marriage covenants that you entered into in connection with your position in the Illuminati or connection to the Illuminati Council and any Ancestral Council?

- 1) Do you renounce all vows you took?
- 2) Do you reject any power of attorney that was appointed to act for you and desire the Most High God to nullify all words he or she spoke on your behalf?
- 3) Do you renounce and forsake the wedding garb you wore for this ceremony, including any special headdress and undergarments and any powers that they carried?
- 4) Do you renounce and desire the Most High God to annul the official pronouncement of the marriage as well as all ungodly blessings, prayers, prophecies, promises, or incantations spoken concerning you?
- 5) Do you renounce and desire the Most High God to reverse all effects of the consummation acts that sealed any such marriages?
- 6) Do you renounce all rights, privileges, and special powers that may have been conferred upon you in entering any such marriage?
- 7) Do you desire the Most High God to release you completely from all obligations of any kind you might have had to be part of a harem for whomever you married?
- 8) Do you desire the record of your marriage to be removed from Lucifer's court records in a way that cannot be detected or instigate retaliation?
- 9) Do you desire the Most High God to break any and all triads and quadriads involving you that were formed in conjunction with this marriage?
- 10) Do you renounce and reject the power of any ring or rings or other objects that were exchanged as well as any blood sacrifices or physical wounding, scarring, or marking of your body that were intended to seal the marriage covenant?
- 11) Do you desire any exchange of gifts and/or of any parts of yourself that was made between you and your marriage partner to be reversed so that you can receive back, cleansed by the blood of Lord Jesus Christ, what you gave and have removed from you what was given to you?
- 12) Do you renounce and desire the Most High God to annul any promises, agreements, vows, and/or oaths that any part of you, knowingly or unknowingly, willingly or unwillingly, entered into to keep yourself pure from all other sexual relationships, including human marriages, or concerning anything else?
- 13) Do you desire the Most High God to remove and to nullify with the blood of the Lord Jesus Christ all curses put on you for breaking or violating any of the oaths that you made in connection with the marriage or that any power of attorney made on your behalf?
- 14) Do you desire to be completely disconnected from all evil and ungodly entities associated with any part of this marriage; including the rings, gifts, sacrifices, and anything else that was done to seal them, the oaths you took to help you maintain them, or the curses for breaking them?

- 16) Do you desire your body, soul, and spirit to be cleansed of all effects of these ungodly covenants by the blood of the Lord Jesus Christ and for them to be removed from your generational line going forward?
- h. Do you desire for all of your parts that were connected to the Illuminati Council and/or an Ancestral Council to be disconnected from them and to come under the protection of the blood of Jesus?
Sometimes you may have to work with any parts that are resistant to this idea.
 - i. Do you desire for them to be totally cleansed by the blood of the Lord Jesus Christ to remove all evil and ungodly attachments and inserts?
 - j. Do you desire the string or other connection between you and the Illuminati and/or Ancestral Councils and the Beast to be severed and permanently removed or broken?
 - k. Do you desire the Most High God to disconnect all triads and quadriads that connected you to the Illuminati Council, an Ancestral Council, and/or the Beast?
 - l. Do you desire any triad or quadriad connections between any council of 13 within you and the Illuminati Council, an Ancestral Council, and the Beast to be severed by the Most High God?
 - m. Do you desire the Most High God to remove all structures that connected you to the Illuminati Council, any Ancestral Council, and the Beast?
 - n. If any framework structures are involved, do you renounce and desire the Most High God to remove all powers of alchemy and sorcery that make them more permanent, along with all life force in it, so they can be removed as well?
 - o. Do you desire the Most High God to remove and to utterly destroy the foundation of the agenda to keep you connected to Lucifer's Kingdom and his use of you?
 - p. Do you desire to disconnect from all of Lucifer's agendas and all of his Kingdom?
 - q. Do you desire to be completely disconnected from:
 - 1) Every Illuminati Council member
 - 2) Every Ancestral Council member
 - 3) The Queen of Heaven
 - 4) The Aspiring counterfeit King of Kings
 - 5) The Beast
 - r. Do you desire to break ungodly relationship bonds with each of these as well as with:
 - 1) The ancestors who dedicated you to these purposes?
