Phil is well suited for parochial ministry. He possesses several strong personality traits which will positively influence his work with people. He is open, warm, friendly; he enjoys being among people. He is interested in and concerned about people. He enjoys the parochial experience.

Because of his ease with people, I think Phil will have to pay close attention to the strength of his interior life. At present Phil is serious and constant in prayer, reflection, and some reading beyond the demands of school work. The value of this inner facet of life must still be strengthened, I believe. Keeping up with theological trends through his reading, maintaining a solid spiritual dimension to his life through regular prayer and reflection - these are factors which I think he will have to be deliberately conscious of.

In my judgement Phil has a good grasp of the faith and morals of the Church. He is dedicated to serving people in the context of faith.

In other areas of his life Phil is doing well. He has matured considerably over the past few years. He is able to deal with conflicts, inner and exterior, in a rational and satisfactory way. He maintains a healthy and happy outlook on life in general.

Date of Evaluation: February 11, 1976

Phil is an ordained Deacon for the Archdiocese of Portland and is currently completing his fourth year academic program, and will be leaving at the conclusion of the Winter term.

The main thrust of our interview was with the topic of readiness for ministry. We discussed both positive and negative aspects of his readiness. On the positive side, Phil sees himself very much as a Sacramental person. He is ready and enthused about serving through Word and Sacrament. He can see himself in the role of a confessor and realizes the importance of the same. Phil is a prayerful person and is learning to become more so as an advocate of God's people. Phil has a real outgoing personality and is willing to use it to best advantage, while endeavoring to avoid the pitfalls such can bring.

We also discussed some possible hazards he might encounter. The first of these was, for lack of a better term, designated "guruism". By this was meant creating a following or a cult of personality. Phil realizes that this danger is there and that it must be guarded against. We discussed this in the context of what it means to have a true pastoral mentality. Phil is a very sensitive person and is strongly attracted toward personal friends, hence the danger of over dependence on him by others, or his overdependence on others could prove a hindrance to effective priestly service. Phil must learn to say "no" on occasions when service is required and not be afraid to admit that he does not have the answer in a given situation.

We also discussed the possibility of compromising on sensitive issues in order to retain acceptance. This is something I feel will have to be watched. At times this will demand a greater use of the head than the heart.

We discussed the centrality of Christ in priestly life and the idea of the Incarnational, the pastoral and the eschatological outlook to priestly service. We dealt with the idea of keeping it in the Christocentric realm and not relegating priesthood to some form of mere social work.

Phil has grown much in our program and feels he is ready for priestly service. I feel that he will be quite effective in the same. He is a very generous and kind person and is quite willing to serve in any capacity he is called upon to do so. I recommend his advancement to priesthood at a time to be determined by the Archbishop and concerned officials.

Philip is completing his final term of field education here at Mt. Angel Seminary. He received his Master of Divinity at the conclusion of the 1974-75 school year. Over the past three and a half years he has been involved pastorally in parishes, general and mental hospitals, and this year is helping to coordinate the undergraduate program of service-oriented apostolates.

Philip has demonstrated good and consistent pastoral attitudes. He enjoys pastoral involvement, and has been willing to develop his own talents by taking on extra involvement, e.g., a Summer of clinical pastoral education in Pennsylvania. He has a sense of pastoral presence, is aware of himself and how he affects others, and has the personal initiative to be creative in his sermons, utilizing various techniques. He has been well received by the people and priests with whom he has worked.

At this point I think Phil has two areas for ongoing growth in ministry. One is the ability to say 'no'. He has made progress in this, and I suspect that practical experience will be a good teacher. The other area is a bit more nebulous. Because Philip is open and friendly with people and makes a favorable impression, it will be a constant process of self-discipline for him to prepare seriously for different pastoral tasks, and not just slip by on the strength of his personality.

I am happy to recommend Phil and wish him success in his ministry.

"Accept the sacrifice of my confessions from the hand that is my tongue, which you have formed and aroused to confess to your name. Heal all my bones, and let them say, 'Lord, who is like to you?' No man who makes confession to you teaches you what takes place within him, for a closed heart does not close out your eye, not does man's hardness turn back your hand. You loose it when you will, either in mercy or in vengeance, and there is no one that can hide himself from your heart. It is the Lord who ultimately heals my bones and to Him I make the confession of my life. It is the Lord who knows me as no one knows me. Only He knows how honest and full of integrity this self-evaluation is or is not. After the Lord, it is my spiritual director and a few close friends who are best able to read what I write here. In hopes to praise the Lord and love Him, I thank all of you who have helped me see and evaluate my life as I prepare to serve as a priest in the Archdiocese of Portland in Oregon. May the Spirit of God guide you and help you guide me.

My primary strength which I bring to my diaconate and priesthood is the gift of my faith and my conviction that I have been called to serve as a minister in the Church. I have studied for the sake of learning in itself, but I have been motivated by faith. Now, at the very end of my formal preparation in the seminary, I have many many encounters with peers, teachers, friends and parishioners which reinforce that I am able to minister God's love to them. Last summer and last year at Queen of Peace Church in Salem, the previous summer as a student chaplain at a Clinical Pastoral Education Program in Delaware are two of the most obvious indications to me of my ability and gift to serve the people of God.

Academically, I did well in college and well at Mt. Angel Seminary. I have grown in my appreciation of theology and the several other related disciplines. I only regret, in some respects, all of the time I have wasted by not studying more. I am, however, quite adequately academically prepared. I have the necessary time and framework to continue to study and learn. I believe that I have a very good and healthy balance between my academic sense and my faith perspective and am able and willing to blend the two in efforts to give and take from the people I am ordained to serve.

Friends and prayer are very important to me. I do not believe I can be a good Christian or a good priest without them. Become permanently committed to me—friends—and I use the words permanently committed most carefully—is integral to my understanding of my Christian faith, my diaconate and my priesthood. I want, with the help of God, to become permanently committed to my friends which will be a sign of the permanent commitment of the God of the Scriptures to His people. I believe this is only possible for me because I cannot do it without shared and private prayer. Struggling to pray the Liturgy of the Hours for the entire Church is further deepening my love of the Lord, myself and the Church. The more I pray, the more I painfully am discovering how little I know the Lord but the more fully I feel drawn to try to be faithful to Him so that I will know him all the more.

I believe firmly that I will be a loving and honest deacon and priest and am ready to begin.

Phil is presently completing his academic and formational readiness for his diaconal experience in our program. He will finish our requirements on March 12, and will at that time be ready for his diaconal assignment and placement.

Phil has come a long way in his over-all growth and development in our program and he is the first to admit its impact and goal setting in his life. He has achieved a certain depth of prayer and spirituality which he longs to deepen and develop. His awareness of where he was when he started our program four years ago and where he is going in the sense of ministry is a healthy appreciation of himself and what has happened within him and which will continue to happen. He feels general well prepared for the future in the ministry while at the same time knows that he has areas of deficiency that he will have to continue to work on with the help of others. He will have to continue to be aware of his somewhat noticeable tendency to procrastinate in some areas of personal responsibility and follow-up. He has become aware of these qualities and is setting about in a determined way to prevent their becoming problems for him.

In ministry, he may tend to become over-extended or involved and will need some on-going direction in matters of this sort. His tendency to respond affirmatively to others in whatever situation he finds them may result in his becoming or allowing some deficiencies to develop in his own spiritual life and progress. He is aware of this factor and hence will probably be able to handle it alright with positive support and understanding from those with whom he works and lives. It will be best for Phil to be placed in a situation where he will receive an healthy amount of affirmation and support, at least initially in his diaconal and priestly experience. He is a young man who works best in dialogic situations and this in the area not only of work but also prayer. He is a very affable and likeable young man who will respond well with the right relationships and direction.

Phil's time with us has not been without its share of growth pain and identity sorting but it seems to me that he has done well. He may still have to endure a bit of frustration in varying areas but I am confident that he will seek out help and advice when these areas become evident to him. He has a healthy appreciation of the priesthood and the demands that it will place upon him.

He has been a source of freshness and creativity in our student Body and his presence will be missed. We personally wish him every success in his ministry and we feel he will make use of his time here and this Seminary as a place of resource and strength.

In general, the Board was pleased with Phil's over-all progress and development since coming into our theological program nearly four years ago. He has certainly made some very important changes in his life and expectations and all of these seem to be for his more effective working in ministry and for his personal growth in prayer and spirituality. It was mentioned that Phil will have to be concerned that he does in fact keep a balance in his life so that his response to the demands of the parochial setting will not, in fact, cause a minimization of his practice in matters spiritual.


Almost a consistent theme throughout these reports and a fact which was mentioned in the evaluation session will be that Phil will have to learn to be able to say "no" to demands and expectations when these might bring him into too much involvement. Such over-involvement would cause him to compromise in effectiveness and there would be some resulting feelings of inadequacy and frustration. It was also felt that he will work best in a situation in which there is an ongoing dialogue and mutuality of planning and programming. This student may yet have to develop some consistency in planning, scheduling and organization but we feel that such will happen through his diaconal experience.

Dear Phil,

I simply want to write you a short note to express my gratitude for your letter to me of February 20th. The rôle of Vocation Director has changed so much since I first assumed the position a few years back. The Church has also changed. There are fewer priests and more people to serve. There are many people who do not agree or even know what kind of changes have taken place in formation programs, a number are not even aware of a diaconate internship experience. This is a list of things which have led to the mutual decision between Father Gerace and myself to terminate the assignment.

- 1) Absolutely no home Masses unless the party is very ill and cannot come to Mass at Church - Father Gerace says "if they want Mass they can come to scheduled Masses". I reminded him that it is allowed by the Church.
- 2) I cannot hear confessions before Masses - the parish custom is to hear them before all Masses. It is simply contrary to everything I have learned about celebrating the Sacrament. Father Gerace: "I don't know where you get that. It has been done for a long time and the people expect it." I responded that understanding of the celebration of the Sacrament has expanded and that I cannot and will not rush people in and out. Already I was hearing a very serious confession of a woman and had to cut her off because it was Mass time. I have heard about forty-five confessions in the parish and it is as if the people have never heard of the new rite of penance. Father Gerace said he doesn't blame me, but blames my training. He said he has complained before and will do so even louder now.
- 3) I asked Father Gerace where Tuality Hospital was because there is a man from St. Cecilia's there who will be operated on and wants to see a priest from his parish. Father Gerace told me that I couldn't see him unless he had a problem he wanted to talk about because that is not in the parish. I would have to call the priest from Hillsboro to give him the Sacraments. That seems very cold to me and is not the sort of pastoral care I have learned.
- 4) After one Mass, Father Gerace said he noticed that I don't join my fingers after the consecration. I responded that it was became optional long before I was even in the seminary. He said he'd like to see it in black and white.
- 5) Father Gerace told me that I was to stop blessing babies and children who come to communion with their families, but who were too young to receive. He said it is forbidden by the Church and until he sees in black and white that it isn't, I'm not to do it. I told him that in the Bible it says "Bring the children forth".
- 6) When talking about our working together, Father Gerace commented that "Well, I never told you to go ahead and unpack anyway. You just came here and started to do it on your own".
- 7) I'm completing the marriage process for a couple in Salem. The bride and her family moved about a year ago from St. Cecilia's. When I was assigned to St. Cecilia's she asked me if she could have the wedding in Beaverton as that is where most of her friends are and it was her former parish. Father Gerace said no, absolutely not because it isn't her parish now. I told this to the

young woman who was quite upset and after she relayed it to her father, he called Father Gerace. Father Gerace hung up on him three times in a row and then came to my room to tell me to tell the father off if he called again. I couldn't do it and am not prepared to.

- 8) When we sat down to talk, Father Gerace told me that:
 - a) I shouldn't try to fool him; he could see that I was in knotts and he suggested that I go to see the Archbishop and the personal board;
 - b) that he would not and could not live with anyone who did not agree with him and do things his way;
 - c) as long as I am with him I will do exactly as he says;
 - d) he has no antipathy towards me (nor I towards him) but that if I cannot live this way then we'd better end it.
- 9) I explained that I foresee many situations of ministry where I will not be able to minister as I understand I should and that I too want to terminate this assignment before any parishioners get hurt.
- 10) Father Gerace told me that he told the Archbishop that whoever he gets for an associate, he doesn't want to have to babysit and that he won't. I told him that is fine and I agree and do not want to be babysat which I think has been happening already.
- 11) I asked Father Gerace if he had an extra old couch which I could put in my study-living room. He said, "Okay, now stop. Wait! What do you want it for?" I explained that it was for sitting on and I didn't understand what he was getting at. He said, "Well, there are absolutely not to be any laymen upstairs for anything. Priests, alright, but that is it". I could appreciate no women upstairs, but beyond that, it is my home and I cannot live that way.
- 12) We have mutually agreed that I should leave as soon as possible as I cannot and will not minister and live as he wants me to and he will not have me there if I will not do exactly as he say, i.e. not disagree with him at all.
- 13) Several times in our conversation Father Gerace kept blaming the seminary - my training for the way I am just as he several times observed something I did - such as when I forgot to put a corporal on the altar, and commented, "Did you learn that in the seminary? Are corporals out now?"

I am in knotts and do not in any way feel free to minister to the people without the hanging fear that he will put down or stop what I am doing.

Fr. Steigerwald has been associate pastor at St. Paul's Eugene, since October 1977. His responsibilities there have been pretty much across the board. He was involved totally in all activities of the parish.

Among his activities, he enjoyed most: 1) Christian initiation program; sacramental preparation. In future would like to have a position in a parish that is open to such programs. 2) working with sick and dying -- hospital work.

In the future, he would like an assignment that allowed him 1/2 time in parish and 1/2 time in hospital work. He has done 1/4 term of CPE and really enjoyed working in the State Hospital. In Eugene, he spends 3 - 5 days a week in hospital work -- visitations.

Strengths:

Feels he is a good counselor; with some training, background; has empathy with the sick

Feels he is a good liturgist, a good homilist.

Feels he is good in working with people going thru separation, divorce, etc.

Weaknesses:

Administration; His present pastor is a strong administrator.

He is ~~poor~~ weak in financial affairs.

He feels that he lacks preparation to run a good marriage prep program

He thinks he has had a fine relationship with parishioners, staff and committees. He has done some limited teaching to 7th and 8th grade boys -- supplementing the religious class in sex education. On the high school level, he has had no formal classes, but he has conducted retreats for this age group and thinks they were quite successful. The parish has a young married couple that runs the youth ministry.

Present Assignment: He likes it; feels it has been very profitable and a growth period for him. He does not like the life style of the parish. Has tried to form a house of prayer but all of those who had been interested in it, have moved from the area. He does desire some kind of community living. He feels that with Pat Corcoran coming to the parish, he may be able to develop some kind of common prayer, office, liturgy within the framework of the rectory. Fr. Harrington does not feel the need for such a life support -- although he respects Fr. Steigerwald's need for it.

Future Assignment: He would like a place where lay ministry is going on or where people and pastor are open to it. He would not like to go to a parish where there is no ~~sub~~ ministry or where pastor is not open to it. If St. Paul is to become a non-man parish in a year or so, he is ready to move; if not, he would like to stay 2 or three years more.

In addition to his interest in hospital work, he is also interested in working in the inner city parishes as associate and ultimately pastor.

His overriding concern and felt need is for a community of priests-laity living together, praying together, sharing liturgy together.

I suggested that he could not expect this kind of community to happen in the near future -- but that he begin to develop some of his objectives.





I have a rather unusual request to make of you, although you have been forewarned by Father George Matanic and shouldn't be too surprised.

A young priest of the Archdiocese of Portland, Father Philip Steigerwald, feels a serious possibility that he might be called to religious life. He thought that spending a year in a religious community would help him to assess the authenticity of this call. Because he was stationed in Eugene, Oregon, he approached the Dominicans of the University Parish to discuss the proposal with them. He likewise consulted with Archbishop Power about his feelings.

For a variety of reasons, our three parishes in Oregon did not seem to be the answer to his needs. St. Dominic's Parish in Eagle Rock emerged as a good possibility, probably because Father Steigerwald knew George Matanic fairly well in Eugene and would be comfortable with him. St. Dominic's also has a small but supportive religious community and would provide an active parish setting in which to work. For my part, this arrangement would be quite agreeable, contingent upon approval of the Archdiocese of Los Angeles.

To clarify the situation a little further, it is my understanding that this proposal involves no commitment on any side. While I would suspect, from the circumstances, that Father Steigerwald might have some leaning to the Dominicans, that is not a condition explicit in the situation. We are providing him with a religious community experience to help him arrive at a better informed conclusion, whether it be to return to his Archdiocese, to seek admission to our Province, or to opt for another religious community. We are not committed to accept him if he were to apply to us. Any of these decisions are at least a year away.



Thank you for your recent letter, reporting that Father Philip Steigerwald, a priest of the Archdiocese of Portland, has been accepted on a trial basis by the Western Dominican Province, so that the young priest can determine whether he has a vocation to religious life.

Frankly, I do not believe that Father Steigerwald really knows what he wants to make of his life. From seminary days he has needed the company and support of his peers. While he has been living in a three priest rectory in Eugene for several years, his desire for community life seems to be very strong, and he feels that he might be able to have the kind of life he seems to need in the Dominican order. Evidently he feels a close kinship with Father George Matanic, an association which began while Father Matanic was pastor of St. Thomas More Parish in Eugene.

Dear Archbishop,

By now you have been informed of Father Phil Steigerwald's intention to return to full and active duty in the Archdiocese of Portland. His experiment in living with a religious community has come to an end -- rather more suddenly than any of us had expected. But Phil seems at peace with his decision and appears anxious to leave Los Angeles and return to Oregon.

No doubt you will be concerned whether Phil has given himself sufficient time to make such an important decision. My initial reaction was to be doubtful myself that he had taken sufficient time. But you should be pleased to learn that Phil is a fast learner. He does, and did, spend a good deal of time reflecting on religious life while he was here. I encouraged him to spend one full day each week at prayer and reading, and to avail himself of regular spiritual direction -- all of which he did. I think this regime helped to speed the decision.

There are a number of realizations that Phil came to while he was with us that made him more deeply aware of the great love he has for the diocesan priesthood. First of all, I think he had a glamorized view of religious life. Living in a religious house exposed him to the daily routine of such a life. Prayer life was not holier, living together was not easier; and the formality of this particular community caused an uneasiness with Phil.

While Phil is not a materialistic person, he does admit to liking the idea of owning his own things. While this never surfaced as a problem within our community with Phil, he did say that this was an important discovery for himself; and obviously, one which would not be compatible with religious life.



Priests not assigned as Assistant Pastors, but who share the pastoral ministry of the Archdiocese of Boston, are given the following basic faculties:

1. They may celebrate Mass twice on weekdays when there is a just reason, scarcity of clergy, and the demand of genuine pastoral necessity, and, under the same conditions, may celebrate Mass three times on Sundays and Holy Days of Obligation with due observance of Archdiocesan regulations concerning stipends.
2. They may preach the word of God, observing all pertinent provisions of the law. (Canons 1328, 1337, 1338)
3. They may hear in the whole Archdiocese, the confessions of all the faithful.

(By agreement of the Ordinaries of all the New England dioceses, priests who have the faculties to preach and hear confessions in one diocese have the same privilege in all the other dioceses.)

4. They may absolve in the sacramental forum from censures imposed by Canon 2350,1 when hearing confessions in a parish where missions, novenas, or tridiums are being held.
5. They enjoy all general permissions and faculties granted to priests by the Ordinary in the Synodal Statutes, Supplementary Regulations, and directives of the Liturgical and Ecumenical Commissions of the Archdiocese of Boston.
