CONTRACT SERVICES

Contract Review Package | \$650

A focused review of a single contract before you sign. You'll walk away knowing exactly what you're agreeing to and where the risks are.

What's Included:

- Review of one contract (up to 10 pages)
- Written summary of key terms and risk areas
- Suggested revisions and points to negotiate
- One 20-minute follow-up consultation

Contracts exceeding 10 pages or requiring negotiation with the other party are quoted separately.

Contract Drafting | Starting at \$1,050

A custom contract drafted from scratch and tailored to your specific business relationship and goals.

What's Included:

- Initial consultation to understand the deal and your priorities
- Custom contract drafted to fit your business and the matter at hand
- One round of revisions based on your feedback
- Final review to walk through the document before delivery

Final fee depends on contract length and complexity. A custom quote is provided after the initial consultation.

Contract Negotiation | Starting at \$2,000

Representation in negotiating contract terms with the other party, whether you're presented with their draft or working from yours.

What's Included:

- Strategy session to identify your priorities and red lines
- Redlines and counter-proposals
- Direct communication with the opposing party or their counsel
- Final review of the executed agreement

Final fee depends on the complexity of the deal and the number of negotiation rounds. A custom quote is provided after the initial strategy session.

Startup Essentials Bundle | \$2,500

The core legal documents every new business needs to operate professionally and protect itself from day one.

What's Included:

- Operating Agreement (LLC) or Bylaws (Corporation)
- Client/Customer Services Agreement
- Independent Contractor Agreement
- Non-Disclosure Agreement (NDA)
- Website Terms of Service and Privacy Policy
- One 45-minute consultation to walk through the documents

BUSINESS DISPUTE SERVICES

Demand Letter | \$1,250

A formal demand letter sent on firm letterhead. Often, a well-crafted letter with the legal issues is enough to resolve the matter without further action.

What's Included:

- Initial consultation to understand the dispute
- Review of relevant documents and correspondence
- Drafting and delivery of the demand letter
- One follow-up communication if needed

A custom quote will be provided after the initial consultation for continuation of services if the dispute remains unresolved after a demand letter and follow up.

Pre-Litigation Dispute Resolution | Starting at \$3,000

Full representation in resolving a business dispute before it ever reaches court. Most disputes settle at this stage when handled correctly.

What's Included:

- Comprehensive case assessment and strategy
- Drafting and delivery of demand letter
- Legal Hold Issuance
- Negotiation with the opposing party or their counsel
- Drafting and review of settlement agreement

Final fee depends on the complexity of the dispute and the volume of negotiation. A custom quote is provided after the initial consultation.

FLAT FEE MONTHLY RETAINER OPTIONS

For businesses that need ongoing legal support, a monthly retainer provides predictable access to counsel and priority response times. Retainers include email and message access for quick legal questions with a 48-hour response window.

Tier	Monthly Fee	Hours Included	Best For
Essential	\$1,500/mo	Up to 3.5 hours	Solo entrepreneurs & small businesses with occasional contract needs
Growth	\$2,800/mo	Up to 6.5 hours	Growing businesses with regular contract activity
Premier	\$4,500/mo	Up to 10 hours	Established businesses needing ongoing legal support

Hours do not roll over month to month. Work beyond included hours is billed at \$400/hour. Either party may adjust the retainer tier with 30 days' notice.

CONSULTATIONS

Initial Consultation | \$175

A 30-minute consultation to discuss your matter, evaluate next steps, and determine whether we're the right fit. The consultation fee is credited toward your engagement if you retain the firm within 10 days.

A NOTE ON FLAT FEES

Flat fees are designed to give you certainty about cost. Each package includes a defined scope of work. Matters that fall outside that scope (additional contracts, additional negotiation rounds, related but separate issues) are quoted separately before any additional work begins, so there are never surprises on your invoice.
