

Date:	Timeline of the Te-Moak Tribal Elections
08.24.21	SF Election Calendar of Events 2021 – South Fork had posted elections for October 12, 2021.
09.18.21	South Fork Band Council appoints Elwood Mose and Kathy Honestewa to South Fork Band Election Committee without a resolution. Elwood Mose term of office had expired in 2019. He had been performing official duties while not being properly appointed.
09.19.21	Te-Moak Resolution No. 21-TM-117 102521 Setting a re-calendar of events for the general election of Band Councils.
09.23.21	Judge Hayes Oath of Office – sworn in by Elwood Mose who was not sworn in as Tribal Election Board Chair. Judge Biers was never recalled by a vote of the people as required by the Te-Moak Constitution.
09.29.21	Elwood oath of office – Elwood Mose not sworn in properly. No judge signing his oath. He was not the Te-Moak Tribal Election Board Chair.
10.14.21	Elwood Mose 10.09.21 SF eligibility of candidates . South Fork Election Committee members falsify official election documents by declaring that all candidates were eligible for the October 25, 2021 South Fork Band Elections having met all eligibility requirements. So Fork qualified Candidates 10 14 21
10.25.21	Elko Band Elections were held at the Wellness Center.
10.25.21	Battle Mountain Band elections not done or advertised. Battle Mountain had a valid election committee but was not told to post or hold elections by their Council.
10.25.21	Southfork Band elections held and tribal member takes a photo of the results of the election. Willard Knight photo of SF election results 102521 b
10.25.21	Wells election 2022 was not posted, people did not have access to go and vote and the committee would not certify the elections.
10.26.21	After refusal to post the results of the South Fork election, Elwood Mose sends a letter declaring the election null and void due to the election committee's failure to do background checks, which was deemed to be a pre-election matter. SF election committee response 102621 dispute South Fork Committee invalidates their election because of felons, even though the committee had knowledge of the felons when they declared the candidates eligible and sent them letters stating so. Court hearing scheduled for 1-27-22
10.28.21	Elko Band Elections certification . Elko Band election committee validates candidates. No protests regarding candidates or the election.
11.05.21	Elko Resolution 21-EBC-44 Oct 25 21 Election recognition of Nick Knight, Susannah Sandoval, Jay Allison, Chauna Cota, Danena Ike, Dana Lopez, Juan Arevalo
11.05.21	Elko Resolution 21-EBC-46 Te-Moak Representatives Elko Resolution 21-EBC-46 to place Jay Allison, Suzannah Sandoval, Chauna Cota and Danena Ike on Te-Moak Tribal Council

12.20.21	Newly elected South Fork Band Council dissolves the appointment of Elwood Mose, Kathy Honestewa and Cheryl Mose-Temoke to the South Fork Election Committee: SF Resolutions 22-SF-07, 22-SF-08, 22-SF-09 .

12.27.21	Resolution 22-TM-24 Commence with Tribal Chairman and Band elections. Tribal Chair election set for Jan, 17, 2022.
12.28.21	Case No. 2021-TM-SC-004 In the Matter of Te-Moak Tribal Council and Tribal Assets issued: recognizing the results of the October 25, 2021 Elko Band and South Fork Band Election results.
12.31.21	South Fork Resolution 22-SF- 10, 11, 13 SF Election Committee appointments
01.03.22	The SF Election 2021 of October 25, 2021 was certified by the newly appointed South Fork Election Committee
01.26.22	Te-Moak Election held in Elko at Wellness Center. No protests or disputes were presented in the 24 hrs. after the elections.
01.27.22	South Fork Band elected members challenged the South Fork Election Committee in CFR Court. Honorable Marsha Harlan informed South Fork Election Committee Chairman, Elwood Mose, that law enforcement back-ground checks were not required if it was known in the community if a candidate was a felon or not. 01.27.22	Te-Moak Election Board certification of Te-Moak Chair Election
02.08.21	Elko Band did not hold another election on Feb. 8, 2022.
02.08.22	Battle Mountain Band Election was held on Feb. 8, 2022.
02-08-22	Second – SF election - Due to the fact that the newly elected SF council <u>did not</u> submit their names to the previously removed election committee, no information regarding this election was shared. Everything was posted in a locked building and access to the building was limited. Candidates were not notified of the election so there was no

	knowledge that the candidates were eligible. Candidates were not informed of the date of the election. Results of the election were not shared. Also, same felons that were protested were allowed to run in this election again.
02.08.22	Wells election 2022 was posted and a new council was elected.
02.09.22	Wells certification of 2022 elections. No protests
02-18-22	Resolution 22-TM-35 Recognized Band Councils of Te-Moak
03-02-22	Nick Knight, Susannah Sandoval, Dana Lopez and Juan Aravelo resign from Elko Band Council. Elko Resolutions 22-EBC-05, 06, 07, & 08 Council resignations on March 2, 2022
03.02.22	Elko Resolutions 22-EBC-09 Council vacancies on March 2, 2022, Elko Band Special elections. Calendar of Events set for April 1, 2022 Valid Elko Band election committee. Committee sworn in by Judge Biers.
04.01.22	Elko Band Special Vacancy Elections for 4 council people that resigned from Elko Band Council. Posters posted around the community, Elko Band Special Election Eligible Candidates Elko Band Special Elections 04 01 2022 held.
04.06.22	Leah Brady, Robert Brady, Penny Stevens, and Derrick Tybo elected to Elko Band Council. Certification of Elko Band Special Vacancy Elections. No protests or disputes filed within the election process timelines. Elko Band Special Election Certification done.
04.09.22	Elko Band Council Oath of offices sworn in by Judge Biers.
