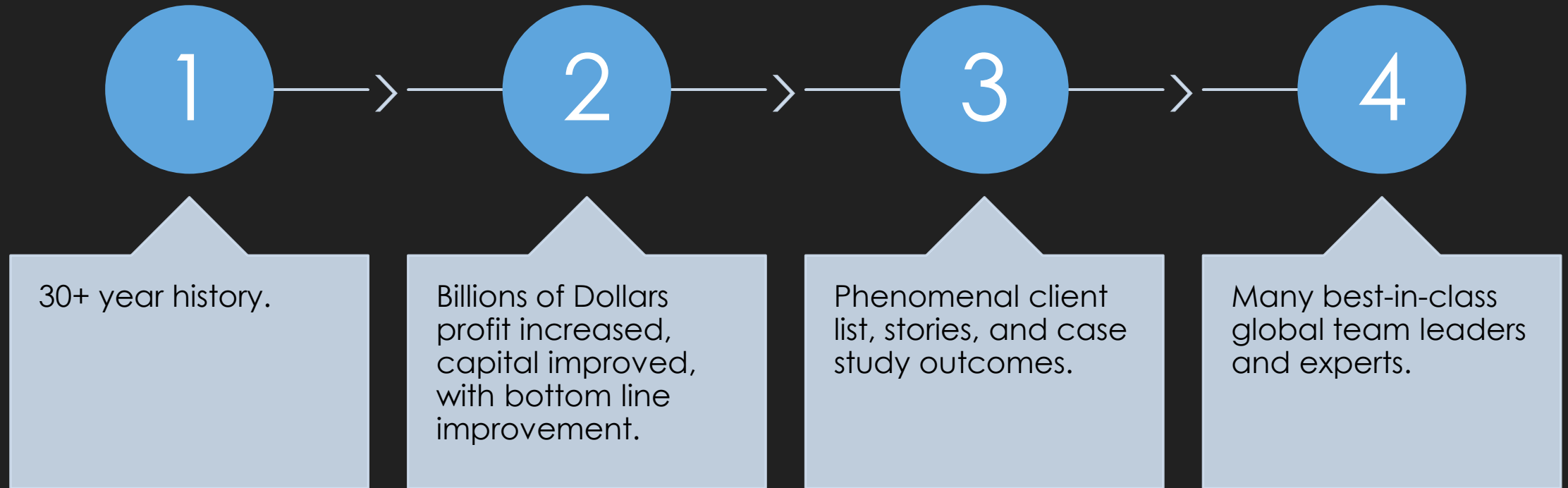

Next Steps
