\$1410.84 – chicken, REC, National Media, kitchen supplies, chain saw (\$369.99 – only ended up costing \$69.99 thanks to donations from our substation fund and Edwin Wright)

\$53,594.65 \$52k Tbill that matured, donation for chainsaw, Tom's store, collected on sponsorships, yard sale income, found some additional \$114.50 from Redbud; refund from lowe's for tax

\$131500.32 ending balance – reinvested \$52K 4.118% for 6 months: Feb 5, 2026

Submitted request to WC for \$2000 and received that today.

Debbie Sutton is going to take over the merchandise. We have 603 items in Tom's store right now. Consider zip up hoodies for Christmas bazaar. Considering additional cutting boards as well. 8/12 – Loraine Smelzer is doing an audit on our books. We are supposed to have an audit committee according to our by-laws.

Clarification, it is a rolling \$52K every 6 months, we return the interest income to the BCCA checking account.
