Thank you to the group working on these projects.

### **Old Business**:

Art camps have been merged; one more next week.

Jim Sylvester: Insurance on the building – Cincinnati Insurance Company: trying to check specifically on the coverage if there is an issue with our stove. Rec call Element directly, but they have directed him to the national number. Martha is still working on the indemnity insurance for the officers and trustees. She will follow up on the stove question at the same time.

Redbud wrap up meeting has not happened yet. Tentatively set for Monday, July 28 at 6pm. There will be a forthcoming message to see if that date works for most.

AED has new batteries. Warren County Citizen Fire Academy is returning – 7 week program: for adults. Sept 24, 6-9pm to November 5 on Wednesday nights.

Emma is working on the vendor application for the bazaar.

Nancie: Jackie asked if we want to move the newsletter to a quarterly paper v continuing monthly. Concern we will miss events if we go to quarterly. Martha is going to follow up with Bunky when he is well. We are also looking for someone to help keep up with the merchandise. There are only 2 vendors we use. Ordering and coverage for merchandise sales during events. Looking for interest in taking over these two items

# **New Business**:

Trex bench – we can get one for free if we commit to collecting plastic for 1 year: 1000 pounds. Mike shared a flyer for consideration.

Watch out flooding and downed trees: these could be tangled in power lines.

We do not have a specific fund for the fire dept.

Browntown was shared as the #1 small town in VA.

Allan Brockway mentioned needing a new chainsaw to keep at the fire station. Motion to purchase a chainsaw for the fire dept from Rural King - \$369: Debbie Sylvester, Mike Prosise second: approved. Tax exempt form will be provided.

To do: urinals –Goal to have them done by the fall yard sale (Sept 12&13, 19&20). There are currently 2 toilets and 2 urinals. We could take both urinals out and replace with 1 toilet. Motion by Jim Sylvester, second Allan Broackway – Approved. Will work on contacting plumbers.

Gypsy moths update at BOS meeting last week: Edwin Wright: Cheryl requests we report defoliation d/t spongy moths. Dept of Forestry – is doing a grant program to help cover the cost of spraying; we need enough people reporting to get the coverage for reduced cost. Will help prevent loss of oak trees. They will likely not die during the first year or two, but if we allow them to continue into the 3-5 years, we will lose the oak trees. They would not be spraying until next year.
