EXPRESS ASSUMPTION OF RISK AND RESPONSIBILITY

In recognition of the dangers, hazards and risks (foreseen and unforeseen) associated with attending and participating in the TLC R3 Camping Retreat, the undersigned confirms that the participant is physically and mentally capable of attendance and participation in all activities and use of all equipment associated with the TLC R3 Camping Retreat. The participant is willingly and voluntarily attending and participating and the Undersigned agrees that they and the participant shall assume all dangers, hazards and risks (foreseen and unforeseen) inherent in, arising from or related to the participant’s attendance and participation in the TLC R3 Camping Retreat.

PARTICIPANT RESPONSIBILITIES

The Undersigned and the participant agree to the following:

Acceptable Conduct by Participant.

During attendance and participation in the TLC R3 Camping Retreat, which may include travel to and from the camp site, the participant will act in a responsible manner and will abide by the rules and policies of the park and the community culture agreement of TLC, International. The parent/guardian is responsible for the care and conduct of accompanied children at all times, with the full understanding that activities in which children participate are voluntary and unsupervised by TLC, International staff, volunteers, members and the Metro Park staff and/or volunteers.

WAIVER OF TRANSFORMATIVE LIVING COMMUNITY, INTERNATIONAL LIABILITY/RELEASE AND HOLD HARMLESS

In consideration of the attendance and participation in the TLC R3 Camping Retreat and knowingly the dangers, hazards and risks (foreseen and unforeseen) of attending and participating in the TLC R3 Camping Retreat, the Undersigned, agrees to RELEASE AND HOLD HARMLESS Transformative Living Community, International, (TLC, Int'l) and its current and former members, officers, directors, employees, and volunteers, and waive any claim for injury and damage resulting from the participant's attendance and participation in the TLC R3 Camping Retreat.

It is the express intent of the Undersigned that this Agreement shall bind the undersigned, any other parent, the participant, the participant's family, estate, heirs, administrators, Apersonal representatives or assigns. The Undersigned agrees that this Agreement shall be construed in accordance with the laws of the state of Oregon, without giving effect to the conflict of laws provisions thereof, and that the state of Oregon shall be the forum for any lawsuits filed under or incident to this Agreement. The terms and provisions of this Agreement shall be severable, such that if a court of competent jurisdiction holds any term to be illegal,
