LARGE SHED:

Neighbor concerns:

- The Sacks claim that they were not told of any plans before surveyors came out. When
 they saw the surveyors were there, the Sacks asked what was going on and were told
 that the Vandusen project was a small shed in the back corner.
- Drainage concerns since the Vandusen property in higher in elevation.
- It's uncharacteristic of our neighborhood and may be against the CC&Rs.
- How much extra noise and activity will it cause?
- How will they build this workspace without using the greenway and going between the houses?
- What utilities will there be? Will there be lights on the outside of the structure and how will it impact the neighbors?
- Can they change placement?

George offered to be a moderator in whatever discussions happen between the Vandusen and Sacks properties regarding this workshop project. The board will discuss and decide on approval.
