ATTENDANCE: Richard Osmon, June Heer, Sam Riley, Bobbie Tyler, Kathy Pettigrew, Patti Schilasky, and Marcia Speed.

MEETING CALLED TO ORDER: The meeting was called to order at 7:10 p.m. The facilitator was Richard Osmon.

PREVIOUS MONTH'S MINUTES for June 2005 were unanimously approved with minor changes. These changes will be made to the minutes by the secretary. (Motion by Sam, 2nd by Kathy)

TREASURER'S REPORT:

Insurance was paid for the upcoming year. So far 69 checks have come in for yearly dues owed. June will present information on changing banks at August's meeting. (Motion by Sam, 2nd by Kathy)

COMMONS AREA:

- * There is a tree branch that has broken off on a tree down by the creek and is hanging over the pathway. Patty feels it is a liability. June will ask the lawn service to look at it and see if they can remove the branch. June reported there is money in the account to cover this expense. (Motion by Sam, 2nd by Patti)
- * Patti reported that there have been several vehicle "break-ins" in our area. Also a mailbox was broken into on Deline. Marcia reported that there were some signs up on the mailboxes on Deline regarding the vehicle break-ins and that the sign said to call Washington County Sheriff's office if you had any information. June will make more signs to alert the homeowners and Richard Osmon's son will put the signs on all the mailboxes.
- * Trash removal schedule will coincide with who will facilitate the homeowner's meeting for the month.

RV LOT:

Sam gave June a list of all the recreational vehicles up in the RV lot - this list serves as the key deposit list. So far Sam has \$96 in cash for key refunds.

Rich has cut down some of the branches hitting up against the RV's in the lot. He needs to do some more cutting, but will do that when it is not raining. He will also help paint the shed later this month.

NEWSLETTER:

Kathy will have the newsletter done this month. The cover letter include an article on ID Theft. Some of the topics Kathy will let the homeowners know is: mention the thefts in the area; when the annual homeowner's picnic is; ask if anyone needs help cleaning up their yards; and let them know there are three spots available in the RV lot.

WELCOME COMMITTEE:

Lot #256 have new homeowners and Rich will make sure they are welcomed.

ACTIVE PROJECTS:

TENNIS COURT REPAIR:

The "Sport Court" surface recovering will soon start. Kathy has a meeting with Wayne Friday, July 15th, to see exactly what needs to be done in preparation for the resurfacing. Kathy will then send out an e-mail to the Board letting them know the details of the project. Questions brought up were: how much of the fence will need to be removed.

WORK PARTY:

A work party has been set for July 23. Wood chips need to put down around the play structures and bolts need to be tightened on the play structure. Boards on the benches need to be replaced also. Kathy will check out the cost of wood to replace some of the bench boards. She thinks we need around 10 new boards.

ANNUAL PICNIC: The Board did not think they could put the picnic together by the end of July. The newsletter will let the homeowners know that it will be on August 13th. June will bring a "to do" list to the next meeting regarding the picnic.

LOTS THAT NEED WORK: It was decided that each homeowner would check out the neighborhood and write down five lots that do not meet the CC&Rs regarding up keep on their property. This will be done in the interest of making sure each homeowner is keeping their home and yard area in good condition. The Board will report back their concerns at the next board meeting.

The Wise's home needs to be worked on again. Damon Heer has volunteered to head a work party again. Things that were mentioned may need to taken care of were: buckets hanging off garage; garage door needs to be painted; holes in garage door need to be fixed; and concern about all the cars. No one on the Board has to work any work party, it will be volunteers only.

OPEN DISCUSSION:

- * Marcia mentioned that the sign notifying the homeowners of any meetings has been damaged.
- * A concerned homeowner asked Marcia to ask if addresses were given out to real estate agencies as she had received a letter from one with her lot number on it. June said anyone can call the Washington County Assessment Office and get that information. This information will be relayed back to the concerned homeowner.

NEXT MONTH'S MEETING will be facilitated by June Heer. Patti signed up for February 2006.
