Homeowner's Bar-B-Que: The board decided to wait until October 13 to have a bar-b-que from 12 noon to 2 p.m. We will have pumpkin carving for the kids and ask the fire station to bring a fire truck.

Work Party: The board decided a work party was not necessary until spring when we will need to put bark dust down around the play structures. Marcia will ask Dan about greasing the merry-goround.

MEETING ADJOURNED at 7:48 p.m. Motion by Neal, seconded by Thelma, unanimously approved by the board.
