We will ask June about this.

**Lot 308 (Wise) Lot 304 (Botiz):** Happy Mowers came out and did the yards on both properties. The HOA board was billed separately for each yard.

**NEWSLETTER:** We will update the questions on the survey and put it in the newsletter. The newsletter should go out between September and October. I have attached the updated Questionnaire to the minutes. It will be suggested they submit this via e-mail or give it to a board member. A motion was made to approve the updated questionnaire -- motion was made by Neal, seconded by Violet, and unanimously approved by the Board.

keeping fowl and also changes to their property such as fences. They have chickens for their Autistic son as a form of therapy. The Feltus' will write a petition letter to the HOA asking for special circumstances to keep them. As for their garden -- they have a very nice garden growing in raised beds. The lawn is not green due to the hot weather. The Board will wait for the letter to move on this matter.

**LOT #261 -- Quinton Cummins:** This is a new homeowner. June asked him about the side yard. He has been concentrating on the inside of the home as the bathrooms were in a terrible state. June asked him if he would get to it as soon as possible and he said he would.

**LOT #307 -- Violet Munger:** She is getting new siding on her home on August 14. There will be work equipment in front of her home for around two weeks. This was approved by the Board.

**WELCOME COMMITTEE:** Since the Kistlers were at the meeting, Marlys and Violet gave them cookies and welcomed them to the HOA. They are getting a new roof and this work was approved by the board.

GREENWAY: There is a broken swing on the greenway. Neal will look at it.
