Patti will contact the Boy Scout Troop she is familiar with and see if they are willing to come help clean up some yards as a community service project.

Lot #308: Damon Heer helped Nancy Wise fixe up their yard, the garage door, and the gutters. It is really looking good. Ken Ackerman came and helped also, along with June and their children. Nancy is open to any board member stopping by and helping from time to time. Damon deserves special recognition for all his efforts in getting Nancy to open up to letting people help.
