Mare owner agrees to pay the Stud fee of \$_____, All payments must be made payable to **Shaunte Robert**. Whether this is a donated breeding or discounted breeding all shipping fees are due prior to shipment of semen.

****PLEASE NOTE: **** Cooled semen is on a first come/first serve basis so call early to be put on the list.

PRE-BREEDING ARRANGEMENTS: The mare owner must provide the following when booking a contract:

- Copy of both sides of registration certificate, if breeding a thoroughbred mare, an AQHA "T" number is mandatory for registration.
- Signed breeding contract
- All applicable fees:
 - The stud fee and shipping fee must be paid in full before any semen will be shipped unless discussed otherwise.
 - Booking Fee of \$250.00 non-refundable is due when contract is returned. We prefer Venmo or Cash.

- Any incomplete registration certificate or unpaid charges will result in a hold of the mare's name on the appropriate stallion breeding report.

SHIPPING/ ORDERING:

- We collect every day of the week to try and fill mares needs. Contact Soul Wind Stallion Station by 5 p.m. previous night and 8 a.m. next morning for confirmation. All holiday schedules may be subject to change. It is the mare owner's responsibility to confirm our breeding/shipping days.

- Every effort will be made to accommodate your mare's breeding timeframe; however, it is the mare owner's responsibility to keep in touch with Soul Wind Stallion station so that your veterinarian and ours can get your mare in foal on a timely basis. Failure to adhere to these arrangements may result in missed heats and delayed shipments at the mare owner's expense. A veterinarian knowledgeable in successful insemination techniques must oversee off-site inseminations in order to maximize the potential of a timely pregnancy.
- Semen that is picked up from Soul Wind Stallion Station by mare owner or agent will have a pickup fee.
- Semen will be sent via UPS or FedEx Overnight (next day arrival) within the United States at the rate of \$400 per shipment.
- Semen sent counter to counter airline shipments (same day arrival) are available and determined by shipping costs of Soul Wind Stallion station. Availability of airline shipments depends on air cargo routes operated by airlines contracted with Soul Wind Stallion Station.
- Soul Wind Stallion Station is NOT responsible for shipments for the COSTS lost, damaged, or delayed in transit, or condition of cooled shipped semen upon delivery. We have no control of the shipment once it leaves our facility! **(Initial Here)**
- The mare owner agrees to have mare checked within 30 days of insemination and report back to Shaunte' Robert with results of pregnancy. It is the mare owner's responsibility to return a signed copy of the insemination certificate (sent in the shipment of semen) signed by administering veterinarian or breeding facility manager back to stallion owner. Mare owners are also responsible for DNA testing their mare as per AQHA and APHA rules.

- **MARE WILL NOT BE PUT ON BREEDING REPORT UNLESS ALL FEES HAVE BEEN PAID IN FULL, PREGNANCY STATUS AND LAST BREEDING DATE HAS BEEN PROVIDED TO SHAUNTE' ROBERT.**

Live Cover:

The mare shall be in healthy and sound breeding condition, free from infectious, contagious, or transmissible disease. Enclose a copy of Mare's registration and Lease Agreement if applicable when returning this contract. Proof of current culture not more than 30 days old, proof of immunization, worming, and Coggins shall accompany mare. Diamond SR Ranch reserves the right to refuse mare if not in satisfactory health, if the mare is refused, the booking fee shall constitute liquidated damages. This breeding may be used for a different mare other than the one specified below and may be used in a different breeding season if owned or leased by Client. However, this must be mutually agreed in writing. This contract is non-assignable and non-transferable.

- Upon Arrival, mare owner will have hind shoes removed
- Current Coggins test if coming outside of Oregon and negative uterine culture.
- Mare Care \$_____ a day dry, Wet \$_____.

LIMITED LIVE FOAL GUARANTEE:

- If the contracted mare dies or is deemed unfit to breed during the season she is contracted, a substitute mare, approved by the stallion owner, may be bred without any additional breeding fee for that same season. **NO REFUNDS GIVEN ON ANY FEES ASSOCIATED WITH THIS CONTRACT!!!**
- A live foal is defined as one that will stand and nurse. If foal is born dead, mare owner agrees to tell the stallion owner, within 7 days. In such case, the mare owner will have the right to rebreed contracted mare the season following the original contract only or substitute a different mare for the rebreeding providing that the substitute mare is of same quality and condition as the original mare approved, determined in the stallion manager's discretion. In such a case, return privileges will be available for the season following the original contract season. If the mare owner fails to rebreed the following year after original contracted season, then all fees become forfeited, the right to rebreed is cancelled and the stallion owner is released from all further obligation of this contract, unless otherwise agreed in writing and signed by both parties.

- We **DO NOT** offer color guarantee on APHA and ApHC registered mares.

EMBRYO TRANSFERS: If more than one embryo is produced from a single flush, then the mare owner is required to sign an additional contract for the additional embryo and pay an additional stud fee of \$800 for each additional embryo.

- This breeding contract may not be sold, transferred, or if won as a prize, or bought off an auction to any other party besides the original winner or owner. If win or bought off an auction all vet fees, office fees, and shipping fees are not included.
- All parties acknowledge that this agreement is made and performed within the County of Umatilla. Both parties agree that should any dispute or claims arise regarding this contract, the venue will be in the State Court located in Umatilla County, Oregon and shall be construed and enforced under the laws of the State of Oregon. Both parties agree that at no time will any damages ever be awarded in any amount greater than the actual stud fee that was paid. Frontier Genetics except credit card payments with 4% fee. Make sure to call ahead to arrange your preferred type of payment. Shaunte' Robert except Checks, Venmo, Cashier Checks, Cash, and Money Orders. Make sure all balances are taken care of before shipping semen. If it is not taken care of semen will not be shipped.

Liability and conditions: Mare owner agree to hold Shaunte Robert and Diamond SR Performance horses not liable for any accident, sickness or death to the mare and or/ foal. Mare owner assumes all risks of loss or damage to the mare and or foal while in the care and custody and control of Stallion owner and will insure against any such loss at discretion.

Mare owner agrees to pay for any vet services due for breeding services or for emergency care, make arrangements to pay veterinarian directly.
