- a. Grounds Committee and Related Items
- i. Maplewood (2) The plaques are still off the boulders. No response from Heather re the Maplewood entries, and Nancy will text her.
- ii. Caley Island Aurora Reimbursement/Review Mitigation and Plant List. The reason for this project was explained to Marty. Fran said that her contact at Aurora Water has approved a budget of \$320. Board agreed that the project should be delayed for a few weeks, so there's more time to see if the replanted tree survives, and also in order have cooler conditions for planting.
- iii. Water Tap on Maplewood Rod is working with SSPRD regarding the possibility of using their tap to provide water to the two areas to be planted with bushes and perennials. The board concluded that this could be a viable solution for the long term, despite the estimated cost of \$2,200. Fran suggested that the cost could be covered by the Monument Fund, and Nancy suggested that the Board apply for a grant from the City in 2026. Curtis proposed that the Board ask Rod to proceed with the plan to use water supplied by SSPRD, and Nancy seconded.

### 7:30 New Business

- a. Movie Night Update. The signs have arrived. Fran will get help installing the 2 additional metal sign holders and put up the Movie Night signs on Sunday or Monday, Aug 3rd or 4th. The Board discussed the 2 movies proposed by Ruth and voted on "If". Dawn will notify Ruth and Stacey. There has been no response from Rod regarding asking Jim for electrical access. Dawn will follow up.
