The General Secretary, Association of A.P Assistant Executive Engineers, Hyderabad (I&P, R&B, P.R Departments), in his letter 4th read above, while furnishing the amendments to the existing Bye-laws of Association of A.P Assistant Executive Engineers, Hyderabad (I&P, R&B, P.R Departments) has stated that, for better functioning of their Association certain amendments to the Bye-Laws of Association of A.P. Assistant Executive Engineers, Hyderabad (I&P, R&B, P.R Departments) were made during their General Body meeting held on 14.03.2015, at Guntur and requested the Government for approve the same.

Further, he has also stated that, earlier Government have changed the nomenclature of Irrigation and Power Department in to Irrigation & Command Area Development Department and in G.O.Ms.No.16, G.A(AR&T-I) Department, dated 24.02.2015, have again renamed the nomenclature of Irrigation & Command Area Development Department as Water Resources Department. Accordingly, for administrative convenience he requested the Government for change of nomenclature of their Association from “Association of Andhra Pradesh Assistant Executive Engineers, Hyderabad (I&P, R&B, P.R Departments)” to “Association of Andhra Pradesh Assistant Executive Engineers, Vijayawada (Water Resources, R&B, P.R Departments)”.

3. Government, by obtaining certain justifications/clarifications in the reference 6th read above, and after careful examination of the matter, hereby approve the amendments to the Bye-laws of Association of A.P. Assistant Executive Engineers, Hyderabad (I&P, R&B, P.R Departments) and also accord permission to change the nomenclature of “Association of Andhra Pradesh Assistant Executive Engineers, Hyderabad (I&P, R&B, P.R Departments)” to “Association of Andhra Pradesh Assistant Executive Engineers, Vijayawada (Water Resources, R&B, P.R Departments)” which are annexed to this order under Rule 3(2)(g) of the A. P Civil Services (Recognition of Service Associations) Rules, 2001, issued in the G.O. 1st read above.
