It is brought to the notice of the undersigned that certain Executive Engineers of Q.C Divisions under the technical control of this office are carrying out the Quality Control Operations of both Civil and Mechanical/Electro-Mechanical items of works under their respective jurisdiction, which is highly irregular.

As per the orders issued vide ref 2nd & 3rd cited, the Mechanical/Electro-Mechanical items of works such as M.S. Pressure Pipe Lines, Motors, Gates, Hoists, EM Parts etc., (irrespective of quantum of work) are to be dealt by the General Superintendent, P.W.Workshop Division, Seethanagaram only.

Hence, all the Executive Engineers of Q.C Divisions under the technical control of this office are here by instructed to strictly adhere to the orders in vogue and draw a fine line in exercising the Q.C Operations of Civil items and Mechanical/Electro-Mechanical items of works in their respective jurisdiction and restrict themselves to carry out the Q.C Operations of Civil items only. All Mechanical/Electro-Mechanical items of works shall be invariably inspected and the Quality Control certificates (irrespective of quantum of work) for the Mechanical/Electro-Mechanical items of works are to be issued by the General Superintendent, P.W.Workshop Division, Seethanagaram only.
