It is to submit that, the 4th General Body Meeting of the APAEEA, West Godavari (erstwhile) was held on 30-10-2022 at Eluru and the discussions were held on prevailing issues in respect of Assistant Executive Engineers working in West Godavari District (erstwhile). As per the resolution taken in the meeting, it was decided to address certain issues to the State APAEEA for taking further necessary action. The detailed issues are as follows:

1. Probation Declaration issue related to 2017 Batch AEE's:

It is well known that, due to delay of Probation declaration, some of the AEEs of 2017 PSC Batch are deprived of monetary benefits and regularization of their service. Recently the State Body has informed that, the file will be moved from the Engineer-In-Chief (Admn) office, Vijayawada to the Government during the second week of November-2022.

Keeping in view the well being of these AEE's, the APAEEA WG Dt, have constituted a team to constantly pursue the issue with APAEEA, State Body and to ensure that the file is resent to the Secretariat after attending remarks from the Engineer-In-Chief (Admn) office, Vijayawada and to get the necessary amendment order from the Government.

In this regard, the State Body, APAEEA is requested to pursue the issue at Secretariat and intimate to district units so as to inform the same to the concern officer. It is once again requested to resolve the issue at the earliest keeping in view the well being of the AEE's.

2. Timely processing of ACRs, TA Bills, Surrender Leaves etc:

It is to inform that, elaborate discussions were held on Processing of ACRs, TA Bills, encashment of Surrender Leaves in 4th General Body Meeting. In this regard, it is to inform that, the Annual Confidential Reports of all Gazetted Officers are required to be initiated by the Reporting Officer concerned for the year ending 31st March and submitted before 15th April to the counter - signing officer and thereafter to the accepting authority in such a way that it reaches the Heads of Departments and the Secretaries, as the case may be, before the end of May as per the DO Letter No. 449/Ser.C/89-1, General Administration Department, Dt.04-04-1989.

But unfortunately these are being delayed at different levels due to various reasons. A detailed discussion is held on this issue with all the association members present in the 4th General Body meeting. It is opined to implement online process for submission of CRs, just like the Annual Property Returns, so that willful delay in processing the CRs at different levels can be avoided. The same was appraised to the APAEEA, State Body vide reference 1st cited.

In this regard, the APAEEA, State Body is requested to address the issue to the higher authorities of WRD for implementation of online process in submission of CRs, as these will be considered at the time of promotions.

In addition, the State Body, APAEEA is requested to appraise the long pending of DA arrears, TA bills and Surrender Leaves to the Government to resolve the issue positively.

3. Sub-Staff recruitment to assist the AEE's:

It is also well known fact that, at present, the section level officers are looking after various engineering works like Execution works, Operation & Maintenance works, Water Regulation works etc., at field level without any assistance. Enormous discussions were held on this issue in previous as well as in the present General Body meeting of APAEEA, West Godavari dt(erstwhile).

In this regard, the APAEEA State Body is requested to appraise theis issue to the higher authorities of WRD and to the Principal Secretary, WRD for taking necessary action to recruit the Sub staff for assisting the section officers.

In addition to the above, it is to inform that, during the 4th General Body meeting, the attendees have expressed their extreme disappointment on levying unnecessary financial burden on most of the AEEs in the name of indents viz., vakalth of court cases, VIP visits etc. In this regard, the APAEEA State Body is requested to address the same to the higher officials of WRD with a request to ensure that such incidents are kept in check, keeping in view the well being of all the AEEs in the Association.


Further, it is to inform that, the service matters of all the Gazetted officers has to be initiated by the concerned case works present in the offices as per their job profile/ job chart. But, unfortunately, the scenario has changed. During the General Body meeting, the attendees have raised concerns about the negligence of the case workers in the Offices, in attending to service matters of the AEEs like initiating the SGP Process, Probation Declaration Process, Language Exemption Proceedings, timely updating the AEEs Service Registers etc., Therefore, the APAEEA State Body is requested to address the ENC Admin WRD to issue specific instructions to the Unit Heads to instruct the case workers in the Circle Offices to attend to service matters on top priority inorder to avoid unnecessary delay in service matters.

Hence, the above issues are brought to the notice of APAEEA State body for information and requested to take necessary action under intimation to the respective district units.

Early action on the subject issues is highly solicited.
