It is to submit that, the 1st General Body Meeting of the newly elected body was held on 23-01-2022 in Eluru and discussions were held on the prevailing issues in respect of Assistant Executive Engineers working in West Godavari District. As per the resolution taken in the meeting, it was decided to address certain issues to the APAEEA State Body, for taking further necessary action. The issues which need the intervention of APAEEA State Body are as follows:

1. Difficulties faced by AEEs of PIPRMC in curbing unauthorized lifting of spoil:

The issue of unauthorized lifting of spoil in PIPRMC and the difficulties faced by the AEEs in curbing such activities is discussed in the meeting. It is discussed that the unauthorized lifting of spoil is carried out during mid night and it is very difficult to control such activities. Further it was also discussed that without any sub staff, the AEE's could not control such activities. AEEs are getting calls during night time from unknown persons informing unauthorized lifting of spoil. AEEs are scared to visit the site during night hours. There is no proper response from the Police department when asked for protection. Due to above reasons, it is very difficult to control unauthorized lifting of spoil.

Further the AEEs are also worried that they may attract charges in unauthorized lifting of spoil though they are performing duties without any lapse from their end. In view of the above the District Body has decided to appraise the issue to the APAEEA State Body with the following requests.

- 1. A delegation of state body is requested to meet the Hon'ble Minister, WRD Govt. of A.P and brief the entire issue to the Hon'ble Minister and request shall be made to provide necessary Watch & ward/Sub staff and also to provide support from Police and Revenue Department in curbing unauthorized lifting of spoil.
- 2. A delegation of state body is requested to meet the State Police officials and request to issue necessary instructions to the Police Department to coordinate and provide necessary support to Field Engineers in curbing unauthorized lifting of spoil.

2. Amendment to APIES Service Rules:

The Government (Combined AP & Telangana state) has issued AP Irrigation Engineering Service Rules vide reference 1st cited wherein various rules in respect of Irrigation Engineering Services such as the categories of posts, the Method of Appointment, Minimum service, Probation and Training along with Annexure is provided during 2010.

Meanwhile, after bifurcation, the Telangana state has amended these service rules vide reference 2nd cited in the year 2018. In this regard, the APAEEA, State body is requested to address the higher authority to amend the AP Irrigation Engineering Service Rules issued in 2010 accordingly.

3. Speedy action in processing the ACR's of AEE's:

The Government vide reference 3rd cited, has instructions for maintenance of Confidential reports with an objective to assess how far each officer is physically, mentally and morally suitable for his office, whether he/she is able to apply intelligently the law, rules, practices and procedure applying to the work within his charge.

Further, in the said GO, vide Instruction-7 cited, it was specified that, "the first reporting officer will forward the report by the 15th of April and the intermediate authorities will pass on the report with their remarks to the next higher authority within one week of its receipt by them. These reports should reach the Heads of Departments not later than the 15th May and the Secretariat concerned not later than the end of May every year."
