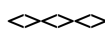

	<p>In view of this, the Engineer-In-Chief (IW), Vijayawada vide Letter No. ENC/IW/P&M/EE.1/NTPA/W1/4097/2008 Vol-4, Dt.19-09-2019 asked to furnish the requirement of Lascars based on the Govt. of Andhra Pradesh GO MS No. 29, I&CAD (Ser.V) Dept., Dt.19.03.1996 regarding responsibilities of Irrigation Lascars.</p> <p>In this regard, as per the discussions held in the General Body Meeting, the APAEEA, WG Dt has decided to obtain the Sanctioned and Working Strength, in addition to the No. of vacancies of Lascars in all the divisions under PIPRMC Unit and Irrigation Circle Unit and submit a detailed representation to the APAEEA State Body, with a request to once again address the issue to the higher authorities of WRD and the Principal Secretary, WRD for taking necessary action to recruit the Sub-staff for assisting the section officers.</p>
2.	Exemption from Covid-19 Duties
Resolution Taken:	<p>In view of the effective Containment & Control of Covid-19 in the District, many AEEs are appointed as the Nodal Officers and Assistant Nodal Officers at the Covid Hospitals & Covid Care Centers. In accordance to the orders issued under Disaster Management Act 2005, AEEs are discharging Covid -19 duties.</p> <p>But some of the AEEs appointed as Nodal Officers and Assistant Nodal Officers at the Covid Hospitals & Covid Care Centers in the district are not relieved properly from their regular duties. Due to which it is very difficult for the AEEs to attend Covid -19 duties in addition to their regular duties. As per the Covid-19 duty orders, if there is any lapse in attending to full-fledged Covid-19 duties the Nodal Officers and Assistant Nodal Officers will attract disciplinary action under the provisions of Disaster Management Act-2005& ESMA act 1971.</p> <p>In this regard, as per the discussions held in the General Body Meeting, the APAEEA, WG Dt has decided to sort out those AEE's who are facing the above said problem and to submit a representation to his/her next level officer personally/ from the association to immediately arrange proper relief from their regular duties.</p>

Resolution Taken:	As these issues are very crucial and need to be solved eminently, the APAEEA, WG Dt has decided to constitute a sub-committee with the APAEEA WG Dt. 4	Amendment to APIES Service Rules
Resolution Taken:	The Govt. of AP (Combined state of AP & Telangana) vide GO MS No. 32, Dt. 12-04-2010 has issued APIES rules in which the method of appointment, eligibility in the initial cadre of Assistant Executive Engineer and the eligibility for the promotions based on the educational qualifications were issued. The APAEEA, WG Dt has decided to look deep in to this issue and to submit a representation to the APAEEA, State body to represent the same to the higher official for amendment to the orders of the AP Engineering Service Rules issued in 2010.
5	To condemn the action taken against AEE's in PIPRMC & PIPLMC Spoil theft issues.
Resolution Taken:	The AEE's of PIPRMC as well as PIPLMC are facing lot of complications in the Spoil theft issues which are seemingly increasing day by day. The APAEEA, WG Dt has decided to represent the issue to the APAEEA State body to put forward the issue to the Hon'ble Minister and also to represent the issue to the Superintending Engineers to provide for proper watch & ward at spoil banks.
6	To ensure speedy action in processing the ACRs of AEEs by the reporting officer.
Resolution Taken:	To avoid long pending of CRs at division and sub division level, the APAEEA, WG Dt has decided to represent the issue to all the Executive Engineers under PIPRMC Unit, Irrigation Circle Unit and Quality Control Circle Unit as well as to the APAEEA State body for speedy process of CRs in order to avoid complications at the time of transfers. Resolution Taken	The APAEEA, WG Dt. has explored the ways and possibilities in setting up of Office Building in Eluru for carrying out association activities.

Further, the APAEEA, WG Dt. has invited the AEE Association representatives of Panchayat Raj (PR), Rural Water Supply (RWS), Housing, Public Health Engineering departments to participate in the JAC meeting which was held in the office of the Assistant Executive Engineer, Head Quarters sub division, Eluru in order to discuss the issue relating GO Rt No.8, Dt.14-01-2022 i.e., Delegation of powers of AEs/AEEs working in the Engineering Departments of Panchayat Raj(PR), Rural Water Supply (RWS), Housing, Public Health Engineering & Minor irrigation (O&M) to the Engineering Assistants (EAs) located in the respective Village & Ward Secretariats.

The President, Rural Water Supply (RWS) AEEs Association Er. Chintamaneni Varma has attended the meeting. During the discussion, we came to know that, in the gazette published by PR department, the Engineering Assistants were placed below the rank of "blue print operators". It is also opined that, appointing the Engineering Assistants to assist the AEs/AEE working at field level is justifiable rather than delegation the powers of AEs/AEEs to EAs which is irrational. After the detailed discussions, the APAEEA, WG Dt has decided to take immediate necessary action duly taking the Opinions/suggestions from the PR, Housing and Public Health Engineering departments.

Further, it is also decided to represent the issue to the APAEEA, State Body to address the issue to the higher authorities of WRD and the Principal Secretary, WRD and to proceed legally to put the GO in abeyance.

Summing up of all the issues, the APAEEA West Godavari has decided to initiate and take immediate necessary steps in resolving the above said issues duly constituting sub committees and assigning responsibilities for effective approach to the solution.
