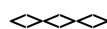

In wake of the district bifurcation, elaborate discussion was held during the 3rd General Body Meeting, regarding restructuring of APAEEA WG District body as per the new districts formed.</p> <p>Keeping in view, the well being of the association, all the aspects i.e., personnel strength, financial strength etc., were discussed and all the executive members as well as association members present in the meeting, opined to continue the existing APAEEA WG District (erstwhile) Association without any alterations. It is opined to put the issue in abeyance, until a decision is taken by the APAEEA State Body regarding 'Restructuring the APAEEA district bodies, in wake of Newly formed districts'. |
| 10. | Discussion on 'Abolishing the Contributory Pension Scheme (CPS) and reverting to the Old Pension Scheme and also to discuss in detail on Guaranteed Pension Scheme as proposed by the Govt. of A.P dated 25-04-2022 in place of Old Pension Scheme '. |
| Resolution Taken | During the 3rd General Body Meeting of the APAEEA, WG District, elaborate discussion was held on this issue. It is opined by all the executive members as well as association members present in the meeting, that 'Abolishing the Contributory Pension Scheme (CPS) and reverting to the Old Pension Scheme' is a mammoth task. As the Government of Andhra Pradesh is reluctant in restoring the Old Pension Scheme. Huge support from larger section of employees is required, to protest against the Governments decision. Therefore, the APAEEA, WG District (erstwhile) have decided to support the other associations like the NGO Associations, Teachers Associations, Government Employees Associations etc., financially to the extent possible, who are also striving for restoring the Old Pension Scheme. |

Further, APAEEA, WG District unit (erstwhile) financial accounts were kept open before the executive members as well as association members present in the meeting, for verification. Elaborate discussion on various possibilities to strengthen the financial status of the association is also explored.

Discussion on various other issues like eviction of encroachments, encroachment act 1905 etc., was discussed in the meeting. It is opined to prepare and upload a detailed 'case study' regarding the role of AEE's of Water Resources Department in dealing with eviction of encroachments, duly quoting the various judgments from the Honorable Courts, in the APAEEA, WG District (erstwhile) website <https://apaceawg.in/>. The association's members present in the meeting have also requested to upload the basic estimates of various CM & CD Works, O&M Estimates, Annual Maintenance Estimates etc in the APAEEA, WG District website, which would be very useful to all the AEEs.
