The following agenda was discussed during the meeting

1	Probation Declaration issue related to 2017 Batch AEE's
Resolution Taken:	It is well known that, due to delay of Probation declaration, some of the AEEs of 2017 PSC Batch are deprived of monetary benefits and regularization of their service. Keeping in view the well being of these AEE's, APAEEA WG Dt, have constituted a team to constantly pursue the issue with APAEEA, State Body and to ensure that the file is resent to the Secretariat after attending remarks from the Engineer-In-Chief (Admn) office, Vijayawada and to get the necessary amendment order from the Government.
	Recently the State Body has communicated that the file will be moved from the Engineer-In-Chief (Admn) office, Vijayawada to the Government during the first week of November. However, during the General Body Meeting it is resolved to once again address the issue to the State Body for speedy perusal at Secretariat. APAEEA Wes Godavari District Body have taken up the issue on top priority and i is constantly pursuing with the APAEEA, State Body to resolve the issue at the earliest keeping in view the well being of the AEE's.
2	Discussion on CPS, OPS & GPS.
Resolution Taken:	As we all known that, under CPS i.e., Contributory Pension Scheme 10% of the Basic pay and DA of Government employee will be deducted and credited to the NPS (National Pension Scheme). The Government also contributes an equal amount to the investmen account of NPS. On retirement, 60% of the accumulated fund can be received in lump sum by the employee. This amount would be tax free. However, the remaining 40% of the fund is mandatorily used to receive annuities. These annuities would be taxable. Whereas in GPS i.e., Guaranteed Pension Scheme, a fixed pension at 33% of the basic pay drawn at the time of retirement will be offered when compared to the current fluctuating CPS of 20%.
	As you are aware of the fact that, until today just a handful of A.F. State Government Employees, recruited under the CPS regime have retired from their service. Therefore a conclusive assessment on the pension received under the CPS is yet to be ascertained. As most or our association members are not aware of the retirement benefits under CPS and GPS. It is decided to upload a detailed comparison on

Returns, so that willful delay in processing the CRs at different levels can be avoided.

It is resolved to once again address the issue to the state body with a request to address the issue to the higher authorities of WRD for implementation of online process for submission of CRs, as these will be considered at the time of promotions.

Regarding the DA Arrears and TA Bills, elaborate discussions were held on this issue during the previous General Body Meetings also. It is understood that, the Government of Andhra Pradesh is not allocating sufficient budget towards the DA Arrears and TA Bills. Due to lack of sufficient funds, the DA Arrears and TA Bills of our AEE's are pending for clearance since years.

In this regard, as per the discussions held during the General Body meeting, it is resolved to once again address the issue to the APAEEA State Body with a request to appraise the same to the Government to resolve the issue positively.

5. Sub-staff recruitment to assist the AEE's

Resolution Taken At present, the section level officers are looking after various engineering works like Execution works, Operation & Maintenance works, Water Regulation works etc., at field level without any assistance. Enormous discussions were held on this issue in previous as well as in the present General Body meeting.

In this regard, as per the discussions held the APAEEA, WG Dt it is resolved to once again address the issue to the APAEEA State Body with a request to appraise the same to the higher authorities of WRD and to the Principal Secretary, WRD for taking necessary action to recruit the Sub staff for assisting the section officers.

Resolution Taken Discussion on the role of AEEs in carrying out eviction of encroachments on the Canals, Drains and Irrigation properties.

The field level officers are very often facing encroachment problems under their jurisdiction. Many Spandana Grievances and RTI Grievances received by the AEE's are pertaining to Encroachment of WRD Properties.

Due to lack of awareness on the process of eviction of encroachment of WRD Properties, notices are being served by the AEE's directly to the encroachers to evict the encroached property. As a result the AEEs are receiving the show cause notices from the Hon'ble Courts and
