Resolution Taken:	<p>It is already known that, the Government of AP have ordered to implement the Attendance by Photography (Facial Recognition Based Attendance System) to all the employees of all the categories of Government offices across the State vide GO MS No. 159 G.A (PU-B) Dept, Dt.26-12-2022.</p> <p>FRS is implemented in almost all the offices, right from the section level in our department. Elaborate discussion was held during the 5<sup>th</sup> General Body Meeting and many of the Assistant Executive Engineers opined that, in addition to the Division, Sub Division office locations, which are already tagged in the FRS Attendance system, the locations of section offices, any other locations within the Section Jurisdiction may also be tagged in the FRS Attendance system, so as to ease the difficulties faced by the Section Officers in marking the attendance in FRS Attendance system. It is also opined that, additional options like marking the Tour/On Duty attendance, Leave options etc should be added to the FRS Attendance system in due course of time.</p> <p>In this regard, as per the discussions held during the General Body meeting, it is resolved to address the issue to the respective Executive Engineers of the division, to tag the section office locations, any other locations within the Section Jurisdiction to facilitate easy accessibility to section level officers in marking their attendance. In addition, it is also resolved to once again address the difficulties faced by the field level officers to the APAEEA State Body with a request to appraise the same to the Government.</p>

3	<i>Probation Declaration issue related to 2017 Batch AEE's</i>
Resolution Taken:	<p>It is well known that, due to delay of Probation declaration, some of the AEEs of 2017 PSC Batch are deprived of the monetary benefits and regularization of their service. These effected AEEs are suffering both Financially and Psychologically. Keeping in view the well being of these AEE's, APAEEA WG Dt (erstwhile), have constituted a team to constantly pursue the issue with APAEEA, State Body and to ensure that the file is resent to the Secretariat after attending remarks from the Engineer-In-Chief (Admin) office, Vijayawada and to get the necessary amendment order from the Government.</p> <p>Recently the State Body has communicated that, the file is in GAD and will be resolved within a month. The APAEEA State Body, District Body along with the 2017 batch AEE's are constantly pursuing the subject issue to get the necessary amendment order from the Government.</p>
4	<i>Discussion on CPS</i>
Resolution Taken:	<p>As we all known that, under CPS i.e., Contributory Pension Scheme, 10% of the Basic pay and DA of Government employee will be deducted and credited to the NPS (National Pension Scheme). The Government also contributes an equal amount to the investment account of NPS. On retirement, 60% of the accumulated fund can be received in lump sum by the employee. This amount would be tax free. However, the remaining 40% of the fund is mandatorily used to receive annuities.</p> <p>As you are aware of the fact that, until today just a handful of A.P State Government Employees, recruited under the CPS regime have retired from their service. Therefore a conclusive assessment on the</p>

5	<p><i>Timey processing of ACRs, TA Bills, Surrender Leaves etc</i></p>
Resolution Taken:	<p>As we all are aware that, the Annual Confidential Reports of all Gazetted Officers are required to be initiated by the Reporting Officer concerned for the year ending 31st March and submitted before 15th April to the counter - signing officer and thereafter to the accepting authority in such a way that it reaches the Heads of Departments and the Secretaries, as the case may be, before the end of May.</p> <p>But unfortunately these are being delayed at different levels due to various reasons. A detailed discussion is held on this issue with all the association members present in the meeting. It is opined to implement online process for submission of CRs, just like the Annual Property Returns, so that willful delay in processing the CRs at different levels can be avoided.</p> <p>It is resolved to once again address the issue to the state body with a request to address the issue to the higher authorities of WRD for implementation of online process for submission of CRs, as these will be considered at the time of promotions.</p> <p>Regarding the DA Arrears and TA Bills, elaborate discussions were held on this issue during the previous General Body Meetings also. It is understood that, the Government of Andhra Pradesh is not allocating sufficient budget towards the DA Arrears and TA Bills. Meeting, it is resolved to once again address the issue to the APAEEA State Body with a request to appraise the same to the Government to resolve the issue positively.

6. *Sub-staff recruitment to assist the AEE's*

Resolution Taken  
At present, the section level officers are looking after various engineering works like Execution works, Operation & Maintenance works, Water Regulation works etc., at field level without any assistance. Enormous discussions were held on this issue in previous as well as in the present General Body meeting.

In this regard, as per the discussions held the APAEEA, WG Dt it is resolved to once again address the issue to the APAEEA State Body with a request to appraise the same to the higher authorities of WRD and to the Principal Secretary, WRD for taking necessary action to recruit the Sub staff for assisting the section officers.

In addition to the above, discussion on filing of Income Tax Returns, the various options that can be availed while filing the Income Tax Returns, in order to obtain maximum Tax Relief were discussed during the meeting. Similarly discussion on submitting the Annual Property Returns and the process to be followed for acquiring / disposing the Movable / Immovable Property were discussed during the meeting. It is also opined to place the information (i.e., covering letter, proforma for acquiring the property etc.,) which is necessary for obtaining the permission from the Engineer-In-Chief (Admin), Vijayawada in the Association website, for easy access to all its members while acquiring the Movable / Immovable Property.

Various other problems faced by the section level officers were also discussed during the General Body meeting, such as levying indents on AEEs, forcing the section level officer's to prepare the budget proposals (budget proposals have to be prepared by the staff of Division Office), Creation of agreements in CFMS etc. The President, APAEEA, West Godavari District (erstwhile) has assured that, proper action will be taken on these issues, keeping in view the well being of all the AEEs in the Association.
